- > A video course for doctors "TB diagnostics by TB LAM tests", is developed and posted on the PHC educational platform
- > Flyer guidelines for using LF-LAM tests for doctors and patients have been developed
- > A webinar was held for doctors and NGO representatives on the use of LF-LAM tests
- > 3 trainings on topical issues related to tuberculosis, patient support and use of LF-LAM tests, for infectious disease physicians, tuberculosis specialists and NGO representatives were conducted together with PHC
- > WHO recommendations "The use of lateral flow urine lipoarabinomannan assay (LF-LAM) for the diagnosis and screening of active tuberculosis in people living with HIV" were translated into Ukrainian

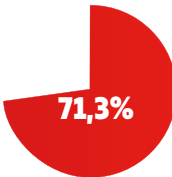

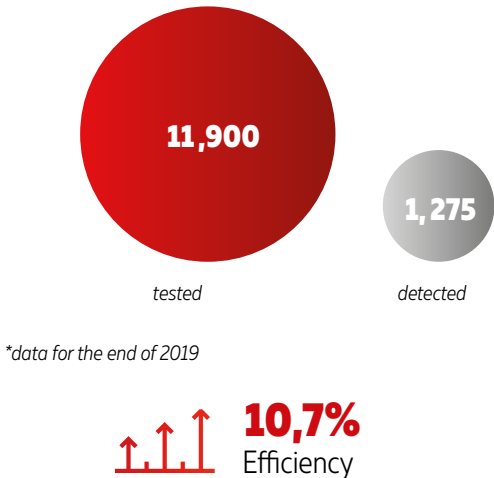
EFFICIENT TESTING MODELS



- Provider-initiated testing and counseling (PITC)
- HIV testing for PLWH partners (Index Testing)
- Engaging men who have sex with men to the HIV prevention, testing and treatment services (VCT)

The emphasis is on the testing of partners of HIV+ people

The efficiency of such testing is up to 10.7% *

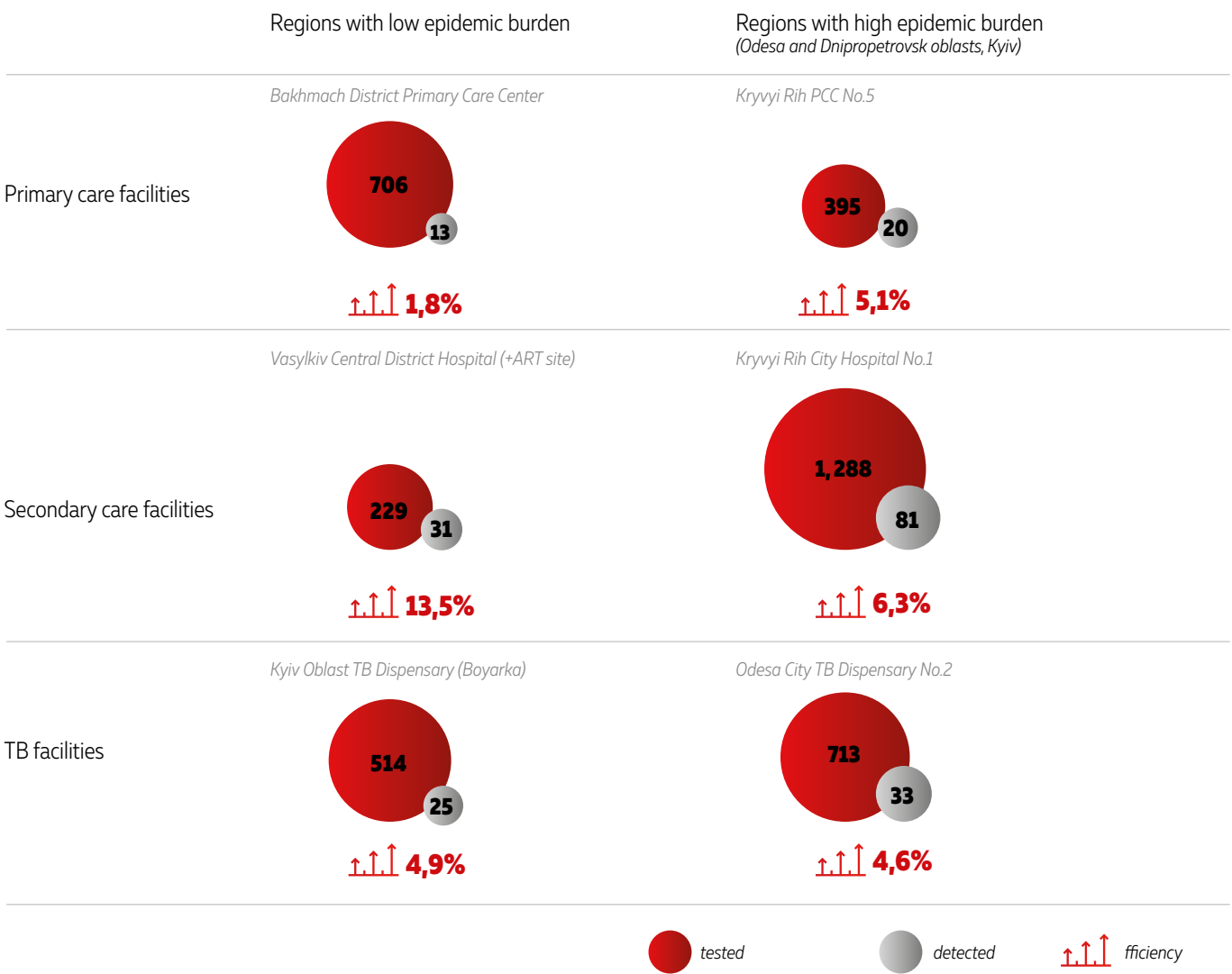


Testing is carried out at all levels of medical services provision.

ABOUT INNOVATIONS



A communication strategy has been developed to increase the demand for HIV testing services (Based on the study "Study of communication processes among representatives of key populations")



prozdorovia.in.ua - the first Ukrainian-language portal with key information on HIV, the largest map of testing points in Ukraine and a "library" of public health information materials was launched



Together with the Center for Public Health, a "Universal Physician's Handbook" has been developed, which contains 8 basic materials on public health. The manual is distributed among medical institutions of Ukraine with the support of the National Health Service of Ukraine.

BUDGET ADVOCACY

- the structure of national and local budgets, as well as the current regulatory environment in the field of public funding in Moldova, Belarus, Russia, Kazakhstan, Kyrgyzstan, Uzbekistan, Tajikistan, Georgia are analyzed,
- mechanisms of social contracting in Moldova, Belarus, Tajikistan are analyzed
- technical support to NGOs in the implementation of advocacy campaigns in Georgia
- formation or improvement of mechanisms of social contracting (or social order) in Kazakhstan
- training of NGO representatives in the field of budget advocacy in Georgia, Moldova, Russia and Tajikistan

Advocacy for price decrease for ARV medicines in the EECA region

- optimization of treatment schemes

Kazakhstan and Belarus are included in the voluntary license for dolutegravir from ViiV

- *Mentoring and technical assistance to the national partner in negotiations with the manufacturer-holder of the ViiV license and in cooperation with the MPD.*



Expanding access to generic drugs

- mentoring and technical support for Kyrgyzstan, Moldova and Ukraine for registration and purchase in 2020 of tenofovir alafenamide/emtricitabine/dolutegravir, tenofovir/lamivudine/ efavirenz (400 mg)
- *In 2020, savings of the national budget for the procurement and access to drugs with a better safety profile.*



Eurasian Community for Access to Treatment (ECAT) meeting held in Yerevan, in partnership with ITPCru

- *A platform for negotiations between national and local patient organizations with generic companies: Mylan, Hetero and Emcure*
- *Generics of tenofovir, efavirenz (400 mg), bigtagravir and tenofovir/lamivudine/ dolutegravir were discussed.*



A study has been launched on the compliance of national protocols

- with the latest WHO recommendations on HIV testing and treatment in 9 EECA countries and 5 Balkan countries in partnership with ITPCru.
- *In addition to the compliance analysis, expert recommendations will be prepared on the necessary changes to the national protocols, which will form the basis for further advocacy campaigns.*



Support of the working group on revision of national treatment protocols

optimize treatment regimens in accordance with WHO recommendations in the Republic of Kazakhstan and Kyrgyzstan. The adoption of the updated protocols is expected in the first half of 2020.



In Amsterdam, training was conducted with I+Solutions: on procurement reform:

a review of effective international ART procurement mechanisms, exchange of national best practices and opportunities to transform the procurement system for each of the project countries.

HUMAN RIGHTS

Promote the realization of fundamental human rights and remove barriers to access to HIV prevention and treatment services.



An action plan has been developed to decriminalize HIV transmission in the focus countries of the CECA region.

The foundations have been laid to establish a regional platform of the Global Partnership for Action to Eliminate All Forms of HIV Stigma and Discrimination.



Alternative reports provided and submitted to the UN: a shadow civil society report on discrimination and violence against women who use drugs, women living with HIV, sex workers and women in prisons in Kazakhstan.

Recommendations of the 74th session of the Committee on the Elimination of Discrimination against Women were received.



Regional seminars were held for activists and community representatives on human rights mechanisms and documenting violations and the quality of services provided to gays, other MSM and trans people.



The IV Eurasian Gender Academy was held in Tbilisi.



A competition for mini-grants "Gender and HIV" was held among civil society organizations and transgender communities in the CECA region.



The first face-to-face meeting of ENPUD members was held to mobilize the community of injecting drug users.

The coordinating council of the organization was elected.



A workshop was held for the staff of the National Preventive Mechanism (NPM) in Kazakhstan to develop an algorithm for monitoring the observance of the right to health in prisons.

The Ombudsman of Kazakhstan was given recommendations on improving the activities of the NPM in the context of monitoring the observance of the right to health.

Two bills were registered in the Verkhovna Rada of Ukraine of the new convocation – No. 2089 and No. 2259, which are aimed at improving the availability of medicines



Bill No. 2259 was recommended by the Committee on Economic Affairs for the vote in a first reading.

The adoption of Bill No. 2259 will help prevent the abuse of patent rights. This will lead to lower drug prices, by increasing competition among pharmaceutical companies.



For the first time in Ukraine, a study of the single-source drugs market was conducted.

The conclusion of the study – half of the drugs in Ukraine are procured from a single source, without competition, ie are monopolistic

COMMUNITY DEVELOPMENT

INVESTING IN CAPACITY BUILDING AND INSTITUTIONAL DEVELOPMENT = STRONG COMMUNITIES

During 2019, the CO "100% Life" continued to actively cooperate with religious organizations in combating the HIV epidemic and combating stigma and discrimination against people living with HIV and members of key communities.

SEX WORKERS (SWS)



For the first time, under the leadership of sex workers, the decriminalization of sex work was discussed at the state level in the Ministry of Health and with the participation of the National Police, Ministry of Social Policy, Ministry of Justice and the Office of the Verkhovna Rada Commissioner for Human Rights.

A working group on the decriminalization of sex work at the National Council for Combating Tuberculosis and HIV/AIDS has been established.

4,526 police officers have been trained to combat stigma and discrimination against sex workers.

PEOPLE WHO INJECT DRUGS (PWID)



200 PWID received legal assistance.

Independent pharmaceutical examination of Methadone-ZN and Buprenorphine-ZN has been initiated.

5 new sites of opioid substitution therapy (OST) were opened in small towns of Ukraine, as a result of advocacy activities.

The community organization of the Volna Charitable Foundation expanded the number of its associate members to **862 persons in 17 regions of Ukraine**.

MEN HAVING SEX WITH MEN (MSM)



A draft law **"On Civil Partnership"** has been developed.

The community's proposals are taken into account in the documents adopted by the Government: Strategies for Public Policy in the Field of Combating HIV / AIDS until 2030 and Strategies for Comprehensive Response to Human Rights Barriers to Access to HIV and TB Services until 2030.

Training and deployment of the **paralegal network** continued.

25 cases of violations of the rights of MSM and adolescents in the context of health care and the provision of HIV services, stigma and discrimination have been resolved.

ADOLESCENTS LIVING WITH HIV



The organization **CSO Youth Organization "Teenagers of Ukraine"** was established, with the expert support of the CO "100% Life"

Amendments to the Resolution of the Cabinet of Ministers of Ukraine # 741 of 04.10.2017 were initiated in order to rename the **Centers for HIV-infected children and youth**, as the name of the centers reveals the status of the child.

FORMER PRISONERS



The community has developed **proposals to the Law of Ukraine** "On Social Adaptation of Persons Serving or Having Served Punishment in the Form of Restriction of Liberty or Imprisonment for a Certain Term".

The First National Conference on the Implementation of Penitentiary Probation in Ukraine was held with the participation of more than 100 representatives of the community, branches of the Probation Center, and the Administration of the State Penitentiary Service of Ukraine.

Precedents have been set for attracting funds from local budgets for the implementation of penitentiary probation activities in Sumy, Poltava, Cherkasy and Lviv oblasts.

WOMEN LIVING WITH HIV



Representatives of the community **became members of the National Council** on TB and HIV/AIDS.

A study entitled **"Rights of Women Living with HIV in Ukraine"** was conducted.

Community efforts **monitored gender-based violence against women living with HIV.**

Recommendations have been developed for the National Parallel Report on Ukraine's Implementation of the Beijing Declaration and Platform for Action of the XXIII Special Session of the UN General Assembly in the Context of the 25th Anniversary of the 4th World Conference on Women.

13 regional coordinators for the development of the HIV+ women community in the regions of Ukraine were involved.

TB COMMUNITY (PEOPLE AFFECTED BY THE TB)



The **Second National Conference on Tuberculosis** was held in Kyiv, organized by TB People Ukraine, which was attended by about 100 people. In **10** project regions, self-help groups for TB patients were conducted with a total coverage of **111** patients in order to enhance their adherence to treatment.

194 primary care workers from 9 regions of Ukraine received trainings on stigma reduction and discrimination against TB patients.

In Dnipropetrovsk, Lviv, Kherson, Cherkasy, Rivne, Sumy, and Mykolayiv oblasts, representatives of the TV community became members of the **regional coordination councils for combating TB/HIV.**

About **UAH 180,000** of state funds were **allocated for social support of TB patients** in Lviv, Rivne, Kherson, Cherkasy, Chernihiv, and Dnipropetrovsk oblasts as a result of advocacy efforts.

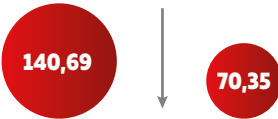

TRANSITION PLAN FROM THE DONOR TO THE STATE FUNDING

HOW IT WORKS

1. Funding for HIV services in 2019 was provided in the proportion of 50% x50%: starting from January 2019 and the next 6 months, funding was provided by the Global Fund, through the main recipients - CO "100% Life" and the ICF "Alliance for Public Health", which subgrant regional service NGOs..
2. From July 1, 2019, funding for HIV prevention, care and support services is provided by the state budget. The implementation mechanism is the procurement of services through the ProZorro e-procurement system.

This approach allowed to create a "window of opportunity" in the first half of 2019 to develop all the necessary tools for the implementation of public procurement at the national level.

3. 92 tenders were held in the field of public health in 24 regions of Ukraine and the city of Kyiv.
4. 53 non-governmental organizations won tenders and signed contracts with the PHC.
5. From December 2019, procurement of services for 2020 began, which lasted until February-March 2020.

CO "100%LIFE" RISK MINIMIZATION ACTIVITIES IN THE TRANSITION PROCESS

- Advocacy of national regulations to implement the transition to public funding.
- Together with the NGO "Light of Hope", training and mentoring of regional NGOs in the field of budget advocacy and fundraising from local sources for an expanded package of services was conducted.
- Together with the "100% Life. Lviv", a series of trainings was held for representatives of NGOs on the public funds administration on the basis of NGOs for the provision of social services.
- A two-day conference "Participation of NGOs in Public Health Services Procurement Tenders" was held in Kyiv together with the PHC and International Renaissance Foundation, which gathered more than 250 participants.
- Support for mediation sessions in regions with a high level of competition among NGOs, which allowed to adjust the organization to a constructive and critical assessment of their own capacity to comply with the contractual terms in case of winning.
- Together with the NGO "Light of Hope", a series of videos with recommendations on how to participate in the procurement process was created.

- Remote consulting of potential service providers was supported together with the Strategic Group.
- Work with the MSM community has been strengthened to improve synergies in public funding for MSM services.
- Technical support was provided to NGOs in the process of preparing tender documents for participation in the bidding.

HOW THE NATIONAL LEGISLATION WAS HARMONIZED TO ACCOMMODATE FOR THE SOCIAL CONTRACTING

1. Resolution of the Cabinet of Ministers of Ukraine to amend the procedure for using the funds provided in the state budget for the implementation of health care programs.

The changes allowed to use existing programs of the Ministry of Health (namely KPKVK 2301400) to finance services for HIV prevention and key populations and for the care and support of people living with HIV from the national budget.

2. Resolution of the Cabinet of Ministers of Ukraine "Some issues of providing services to representatives vulnerable to HIV groups and people living with HIV"

This document stipulates the implementation of these services from July 1, 2019..

3. Order of the Ministry of Health "On approval of the procedure for providing services for the care and support of people living with HIV"

Contains a clear algorithm for providing services.

4. Order of the Ministry of Health “On approval of marginal tariffs for the provision of HIV services”

The Order includes marginal tariffs for the following services:

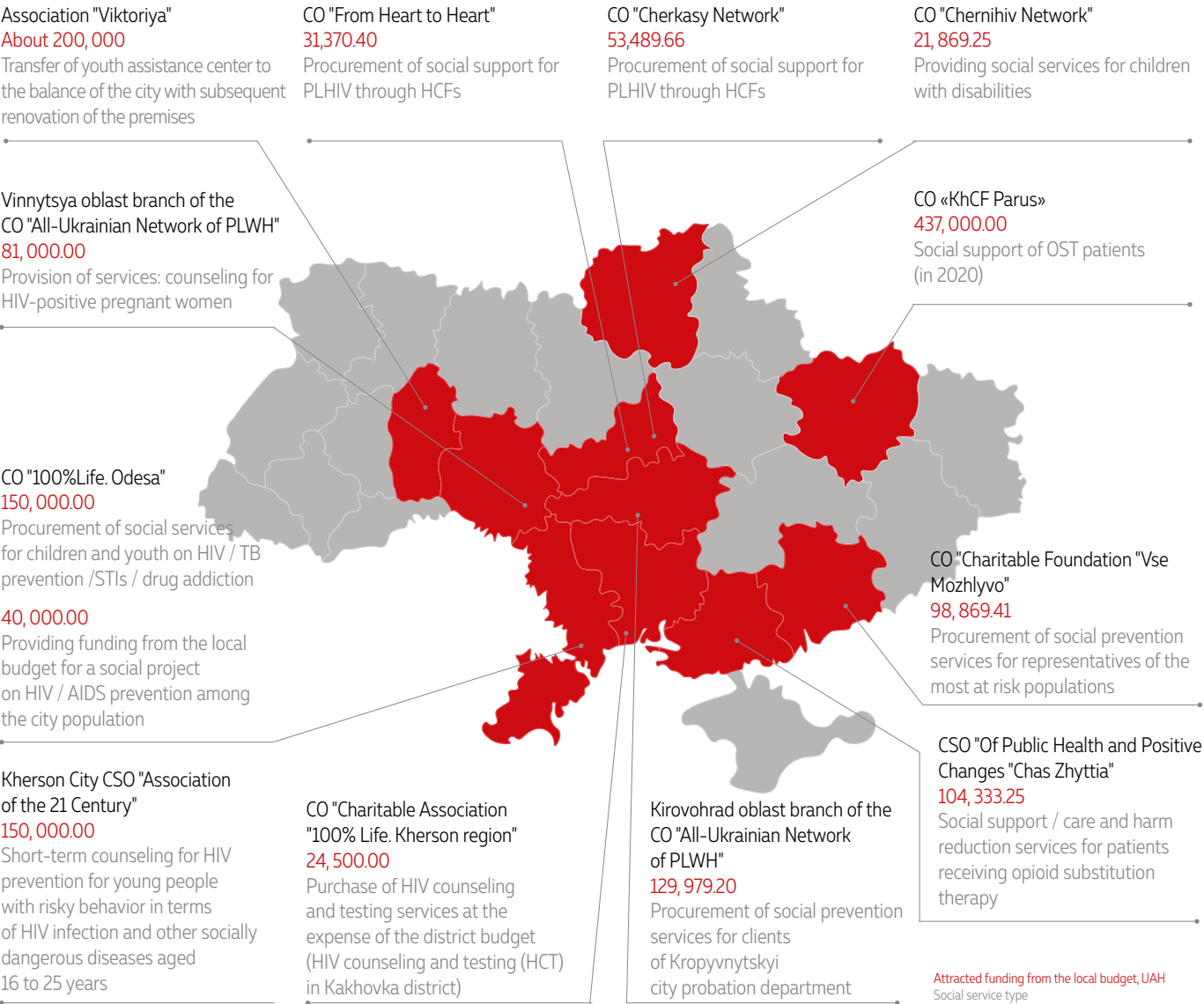

TRANSFORMATION OF THE HEALTH SYSTEM OF UKRAINE

Central 103, a national IT system that monitors the quality of emergency care (EC) and accelerates the arrival of first responders and EC crews, has been developed.

15 oblasts are connected to the Central, 5 more are in the process of connection.

CENTRAL 103 SYSTEM

Central 103 is one of the components of the eHealth ecosystem and provides digitalization of the entire EC sector. The system monitors the work of regional emergency medical centers online and receives complete information about calls and the results of their processing, as well as provides a "bridge" for the exchange of information between regional 103 call centers and other services.

CENTRAL 103 ENSURES:

- Collection of reliable analytical and operational information on the functioning of the EC system
- Transparency and accountability of the EC system at all stages of work and assistance provision
- Free inclusive access of Ukrainians to the EC service by the ability to call an ambulance by digital means
- Unification of EC service processes at all levels of medical care
- Integration of EC with other branches of health system
- Full digitalization of EC medical reports
- Effective interaction between emergency medical services and other emergency services, volunteers
- Providing open, depersonalized information about the work of the EC to the public.

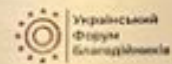

The aim is to introduce a new health care culture to reduce the level of dangerous infectious diseases in Ukraine.

#STOPTHEPAIN:

CAMPAIGN ON LEGAL REGULATION OF
MEDICAL CANNABIS

2 million people in Ukraine suffer from pain that can
be stopped with medical cannabis

Among them are **18,873 children**

On January 30, 2019, a broad campaign to support the legal regulation of medical cannabis was launched under the petition "Stop Pain - Protect Citizens' Rights".

In nearly 40 days, the petition gathered 25,000 votes necessary for it to be considered by the MPs of the Verkhovna Rada of Ukraine.

For the first time in the history of Ukraine, a bill co-authored with patients was submitted to the Verkhovna Rada for consideration.

103 MPs wanted to co-initiate the Bill.

Medical cannabis has become part of the 2019 news and political agenda.

On May 31, 2019, Kyiv hosted a conference "100% ACCESS", which aimed to discuss the current state of drug policy in Ukraine, study the best world practices, prospects for development and improvement of legislation in the country on drug policy, human rights and access to painkillers.

More than 600 participants, 20 speakers.

About 10 speeches and panel discussions with the participation of representatives of international organizations (UNODC) of the Ministry of Health of Ukraine, the Ministry of Justice, the Ministry of Internal Affairs, representatives and activists of public and patient organizations, doctors, etc.

Sharing experience with experts from Moldova, the Czech Republic and Georgia. The best international practices in the field of drug policy, mitigation of legislation, prevention of human rights violations and access to treatment, which are the key to overcoming the HIV/AIDS epidemic in Ukraine, are set to be implemented in Ukraine.

Wide coverage in the media, which provoked a great reaction in the society, interest in the topic of drug policy and, in particular, medical cannabis, and the relaxation of drug policy in general in Ukraine.

The most important consequence of the "100% ACCESS" conference was a change in the position of Ukrainian MPs on Bill 10313, almost 200 of whom expressed their support for the possible adoption of this law in the Verkhovna Rada of Ukraine.

This bill should be the first step that would shift the tradition of repressive drug policy in a country that affects not only psychoactive substance users, but also patients, and hinders access to painkillers in general.

Bill 10313 was developed and submitted to the Verkhovna Rada of Ukraine.

For Love collection – was the joint creative development by the CO "100%Life", designer Ivan Frolov and the artists of the SOVA jewelry studio.

Collection included 7 unisex jewelry pieces matching each other and expressing a unique manifesto of love.

SOCIAL MISSION

The jewelry pieces are sold in the online shops and all corners of the SOVA brand. A portion of revenue is used to combat HIV/AIDS epidemic in Ukraine – procurement of rapid testing systems which allow to timely diagnose HIV and start treatment.

The collaboration was presented during the winter UFW-2019.

To this aim, the main runway of the Fashion Week was transformed into a grand bed, to which the show guests were invited.

FROLOV X SOVA show for 100%LIFE was recognized as the best presentation by Ukrainian and international fashion journals.

HIV TESTING

CO "100%Life" arranged a confidence testing site at Ukrainian Fashion Week, where everyone willing might take a free HIV test or assess the infection risks in the HIV Test mobile app.

More than 300 guests of the event got tested.

In almost a year since the collection sales start, more than 1,000 rapid tests were procured.

Striving to continue the new tradition of the socially responsible Ukrainian fashion, the collaboration authors decided to expand the range of the collection models in 2020.

"We were inspired by thoughts of our loved ones and most importantly - love, health and life. The main goal is to draw more attention to the issues of safe love and the HIV epidemic in Ukraine", - Vanya Frolov, designer
