PROJECT REDUCING THE TB/HIV

through universal access to timely and quality diagnosis and treatment of tuberculosis and its drug-resistant forms, expanding the evidence-based prevention, diagnosis, and treatment of HIV, and creating sustainable and resilient health systems

The project is implemented with the financial support of the Global Fund to Fight AIDS, Tuberculosis, and Malaria.

Geography — all regions of Ukraine.

Care and support services for patients living with HIV to develop their adherence to treatment, which was previously provided by CO "100% Life" with support of the Global Fund within the Transition plan from donor to budget funding, was implemented at the expense of the state in 2020.

About the Transition Plan: According to an agreement between the Global Fund and the Ukrainian Government, starting in 2019, the donor-funded HIV program began declining by increasing state funding for HIV prevention, care, and support services. The 20-50-80 co-financing plan envisages 20% funding from the state budget in 2018, 50% — in 2019, and 80% — in 2020.

HIV TESTING

Geography: Vinnytsia, Volyn, Zhytomyr, Zakarpattia, Ivano-Frankivsk, Luhansk, Lviv, Rivne, Sumy, Ternopil, Kharkiv, Khmelnytskyi, and Chernivtsi oblasts.

8,173 people were tested for HIV by rapid tests
650 cases of HIV were confirmed
627 "HIV-infection" diagnoses were determined
563 patients were registered for follow-up care (this is
89.79% of those with confirmed HIV+ status).

The rest of the identified HIV+ clients were at the stage of diagnosis



CARE AND SUPPORT OF PATIENTS LIVING WITH HIV

- **461** patients* with the disease of the highest rank of complexity received treatment, care, and support services.
- **59** patients received individual consultations on the treatment of opportunistic infections.
- **89** patients received individual consultations on the treatment of HIV/TB coinfection.
- **10** patients received individual consultations on the treatment of HIV/TB and viral hepatitis.

SUPPORT FOR CHILDREN AND ADOLESCENTS

Geography: NDSL "OKHMATDIT", regional AIDS Centers.

- **283** children received medical and social support services.
- **6** [six] visits were arranged by multidisciplinary teams to Donetsk (Sloviansk), Kirovohrad, Poltava, Dnipropetrovsk, Mariupol, and Chernihiv AIDS Centers, and 69 clients received services within those trips.
- **72** healthcare specialists from the regions received remote consultations on the management of complicated cases.

Technical support

We prepared a complete package of design and estimate documentation for the restoration of a treatment block at Holoprystan colony 7 (Kherson region) in compliance with all modern requirements and standards of infection control for patients with TB and we submitted it to the Ministry of Justice of Ukraine.

Cooperation with the Ministry of Reintegration of the Temporarily Occupied Territories of Ukraine

On November 6, 2020, with the support of the Global Fund, CO "100% Life" equipped a service hub, consisting of a medical office and mothers-and-children room, which was opened at the new EECP "Schastia" (Luhansk Oblast). Primary care, including rapid HIV testing and a tuberculosis screening, is now available to people crossing the contact line.

In 2021, with assistance from the Global Fund, CO "100% Life" plans to start providing COVID-19 testing at the EECP.

"HEALTHLINK: ACCELERATING HIV/AIDS RESPONSE IN UKRAINE"

HealthLink allows getting tested for HIV quickly and safely and starting treatment.

HealthLink is implemented by CO "100% Life" in partnership with the Alliance for Public Health and with financial support from USAID (United States Agency for International Development).

About \$ 9 million has been distributed among 12 regions.

- Testing was carried out at all levels of health care.
 Each type of institution worked according to a separate path of the patient, which allowed testing and treatment enrollment in the most effective way
- More than 300 healthcare facilities
- About 3,000 healthcare workers were trained in reducing stigma and discrimination; counseling and testing for HIV and hepatitis C using rapid tests; index testing
- About 300 social workers were involved in the project

ABOUT INNOVATIONS

Launch of a communication mentoring program for 27 regional partner organizations

27 NGOs developed and are implementing 27 regional communication plans within the HealthLink project to increase the demand for HIV testing services:

- A new approach to HIV communication in the regions
- Start of cooperation with a number of enterprises and opinion leaders
- Launch of online information mini-campaigns
- New digital, video, and print content

The function of ordering a free oral HIV test at home based on the results of a screening questionnaire intended to determine the risk of HIV infection has been launched.

The site also contains the largest map of testing points.

- For 3 months, about 60,000 people watched videos created for a digital campaign that invited the MSM target audience to get tested for HIV.




COOPERATION WITH THE MINISTRY OF REINTEGRATION OF THE TEMPORARILY OCCUPIED TERRITORIES OF UKRAINE

On December 16, 2020, a service hub with a medical office and a mothers-and-children room was opened at the EECP "Novotroitske" (Donetsk Oblast); these units were equipped by CO "100% Life" with the support of the HealthLink project.

This EECP became the second one that provided healthcare services for citizens of Ukraine crossing the contact line.

Primary care, HIV and hepatitis testing, and tuberculosis screening are available to citizens at the checkpoint. It is possible to make a declaration with a family doctor directly at the EECP and receive an appointment in accordance with the healthcare guarantee program.

"100% Life" equips service hubs at EECP in the framework of the Memorandum with the Ministry of Reintegration of the Temporarily Occupied Territories of Ukraine.

- Under the auspices of EKHN, the 5th Eurasian Gender Academy was held and one of its online sessions was intended for representatives of the transgender community of Tajikistan.

Uzbekistan

- The sociological survey "PLHIV Stigma Index in Uzbekistan" according to the methodology of Stigma Index 2.0 was launched.
- An ECOM consultant documented 8 cases of human rights violations against LGBT people in Samarkand, Uzbekistan.

Georgia

 Under the auspices of EKHN, the 5th Eurasian Gender Academy was held and one of its online sessions was intended for representatives of the transgender community of Georgia.

REDUCING PRICES AND IMPROVING ACCESS TO ARVS IN THE EECA REGION:

- Critical discrepancies between national protocols in the EECA countries and South-Eastern Europe (SEE) and the WHO Guidelines were identified and directions to advocate changes were formed.
- 2. With the participation of the patient community, new HIV clinical protocols, which are harmonized with the WHO Guidelines, were adopted in Kazakhstan, Kyrgyzstan, and the Russian Federation.
- With the assistance of the CAA of PLHIV and in partnership with the WHO, a webinar on analyzing practical cases and problems with treatment optimization (transition to DTG, EFV 400, and use of TAF) was held for 8 EECA countries.
- 4. The functioning of an effective platform to advocate reducing prices and expanding access to ARVs in EECA countries was supported.
- 5. Voluntary license for dolutegravir was obtained in Belarus and Kazakhstan.
- 6. Adoption of new HIV clinical protocols in Kazakhstan, Kyrgyzstan, and Russia was advocated.

- 7. The indicator on the average cost of ART of the first-line treatment for the countries using the TDF + XTC + EFV regimen was performed.
- 8. A pool of experts was formed to monitor the effectiveness and advocate for changes in the supply of medicines for HIV treatment.
- 9. Advocacy for access to TDF/FTC in the pharmacy network in Kazakhstan.
- 10. The first regional dialogue for the SEE countries on reducing ART prices and expanding access to treatment was conducted.
- 11. Work on expanding access to generic DTG for 4 SEE countries began.
- 12. The cost of annual treatment per 1 patient in 9 EECA countries was reduced. In 2019, the cost was \$ 605.76, in 2020 \$ 535.74.
- 13. The potential savings, generated by the optimization of purchase prices in 9 EECA countries, was \$ 48,987,606.84 in 2020 compared to 2019.

Medical information system "HIV-Infection in Ukraine" (MIS HIV**) was transferred to the Public Health Center of Ukraine

- MIS HIV was designed to create a single repository of data from routine epidemiological surveillance of HIV/AIDS and medical monitoring of patients with HIV
- MIS HIV provided for the optimization of monitoring and evaluation processes, procurement planning, accounting, and control of medicines and medical devices

Mobile application for patients of "100% Life" was integrated with MIS HIV:

This allowed for relationships between patients and healthcare facilities by electronic registration (e-registration) in the face of the COVID-19 pandemic

- The MIS HIV functionality was supplemented with new modules "Substitution Maintenance Therapy" (SMT) and "Tuberculosis" (TB). The process of transferring MIS HIV to the national stakeholder continues
- A protocol was developed and information exchange between the MIS HIV and central database of the eHealth ecosystem was established
- The establishment of the Laboratory Information Management System (LIMS) started in 4 laboratories of the PHC and Clinical Diagnostic Laboratory of the Kyiv City AIDS Center at KCCH #5.

- Additional computer and network equipment needed to connect analyzers and perform bar-coding of biological material delivered to the laboratory was purchased.
- Training of users was carried out and the industrial version of the software was established in the reference laboratory for AIDS at the Public Health Center and the clinical-diagnostic laboratory at KCCH #5; laboratory analyzers were connected to the system.
- System adjustment and adaptation to the peculiarities of the pilot facilities took part in the reference laboratories of the PHC for microbiological and parasitological research on particularly dangerous pathogens.

HIV testing


- 5-year period was analyzed and proposals on the priorities of a new Plan for the next 2-3 years were made. This was the starting point for official work on amending Ukrainian human rights legislation.
- For further international advocacy activities aimed to protect the rights of PLHIV and representatives of key communities vulnerable to HIV, an application was submitted to the Committee of Ministers of the Council of Europe containing a shadow report on Ukraine's implementation of the ECHR decisions regarding cases related to failure to provide timely and quality health care to HIV-positive prisoners and detainees.

MEN WHO HAVE SEX WITH MEN (MSM)

Advocacy achievements of the community:

- The draft law "On Civil Partnership" is included in the Action Plan for the implementation of the National Human Rights Strategy for 2021–2023. The Ministry of Justice of Ukraine assumed responsibility for the implementation of this task.
- In July 2020, Ukraine received a direct recommendation from the UN to implement the institution of registered civil partnership ("Report of the Independent Expert on Protection against Violence and Discrimination Based on Sexual Orientation and Gender Identity" was presented at the 44th session of the UN Human Rights Council).
- The draft law of Ukraine "On Amendments to the Criminal Code of Ukraine (regarding the regulation of liability for crimes committed on the grounds of intolerance)" was submitted to the Verkhovna Rada for consideration.
- For the first time in the history of Ukraine, the national TV channel was deprived of its license due to homophobia (indicating this fact in official documents).
- 130 new volunteers joined the paralegal network.



SEX WORKERS (SWS)

- During the COVID-19 pandemic, the community raised additional funds to provide psychological and material assistance to sex workers.
- 320 sex workers participated in information sessions to mobilize efforts to advocate for community interests and raise awareness of health and human rights protection.
- 3872 law enforcement officers participated in informational and educational sessions on reducing the level of stigma and discrimination against sex workers and representatives of other key populations.



ADOLESCENTS LIVING WITH HIV

- Changes to "Standard Regulations on the Center for HIV-Positive Children and Youth" (to the Resolution of the Cabinet of Ministers of Ukraine "On Approval of Standard Regulations on Social Support Institutions for Families, Children, and Youth" #741 of October 4, 2017) were proposed. The proposals were considered by representatives of the Ministry of Social Policy, and they will be implemented during the improvement of the regulatory framework for the provision of social services in 2021.
- 673 adolescents were trained in reproductive and sexual health.



TB COMMUNITY (PEOPLE AFFECTED BY TB)

- The allocation of local budgets for social support of patients with tuberculosis in the total amount of almost UAH 500,000 was advocated in 7 regions.
- In Cherkasy oblast, UAH 20,400,000 from the local budget was advocated to support the TB service for the period of its reform.
- The creation of the Expert Group on Tuberculosis, including on barriers and violations of the rights of people affected by TB, was advocated.
- 4 trips to the regions were made to address complaints about the observance of the rights of patients with TB
- 560 people from 12 oblasts took part in activities aimed to increase adherence of TB patients to treatment.
- Amendments to the Law of Ukraine "On Combating Tuberculosis" were prepared.
- The working subgroup on tuberculosis was supported within the activities of the Strategic Working Group on Sustainability of Services in Response to HIV/AIDS and TB within the transition to public funding.
- For the first time in Ukraine, the National Dialogue event was conducted to join efforts of state institutions and civil society organizations affected by tuberculosis to access quality healthcare and social services with respect for human rights within the transition from donor to state funding.

- As a result of the dialogue, cooperation with the Ministry of Social Policy was established; recommendations for regulations on tuberculosis were prepared.
- Due to delays in the supply of anti-TB drugs, advocacy work was carried out and interruptions of treatment were prevented in Volyn and Ivano-Frankivsk oblasts.
- In 2020, 3 more representatives of TBpeopleUkraine joined the hospital councils in 3 regions of the project. (At the end of 2019, representatives of TBpeopleUkraine have already joined the majority of regional or city coordination TB and HIV councils).
- By World TB Day, a number of public actions, appearances on TV, and photo exhibitions were held in the regions; social advertising was placed in the Kyiv subway.

FORMER PRISONERS

- An effective response to the challenges caused by the COVID-19 pandemic: 101 former prisoners from 17 oblasts were supported during enhanced quarantine.
- An advocacy campaign was conducted to include employees of penitentiary institutions and pre-trial detention centers, as well as convicts and prisoners, in the priority groups for vaccination against COVID-19.
- Social workers from among convicts in 55 penitentiary institutions of Ukraine were trained.
- The "FREE LIFE" application was developed for convicts and released from penitentiary institutions, remand detainees, those on probation, as well as for doctors of penitentiary institutions of Ukraine, inspectors preparing for release, employees of authorized probation bodies and social patronage services, representatives of non-governmental organizations, government, and local authorities. The "FREE LIFE" application helps to apply the latest digital technologies to resocialize convicts.

The community of former prisoners developed and advocated for amendments to regulations: Instruction on working conditions and wages of convicts sentenced to restriction of liberty or deprivation of liberty; proposals were made to the draft resolution of the Cabinet of Ministers to provide substitution maintenance therapy for people with mental and behavioral disabilities as the result of opioid use.



PEOPLE WHO INJECT DRUGS (PWID)

- Due to the efforts of the PWID community, the risks of substitution maintenance therapy interruption were prevented. Crown Agents purchased Methadone tablets amounting to UAH 9 million for 8,125 patients (funds were saved on purchases).
- UAH 80,000 was raised (through budget advocacy) from the budget of Lviv to provide social services to clients of the substitution maintenance therapy program.
- The strategic community development plan for 5 years was developed.
- Funds were raised for the opening of two new SMT sites in the Lviv region: Mykolayiv and Novoyarivsk.
- Patients have been waiting for years for the opportunity to receive medicine in their cities.
- The sites were provided with modern equipment and furniture.
- Approval of the State Standard of Social Services for Social and Psychological Rehabilitation of Persons with Addiction to Narcotic Drugs or Psychotropic Substances was advocated.
- More than 120 cases on violations of the rights of the PWID community were documented.
- The community was forced to repeal a discriminatory and unconstitutional draft law #2784, which proposed the introduction of involuntary treatment and the defacto blocking of the market for painkillers or drugs for substitution maintenance therapy.



WOMEN LIVING WITH HIV

- The community raised additional funding from the local budgets of Dnipropetrovsk, Chernihiv, and Cherkasy oblasts to protect the rights and improve the quality of life for women living with HIV.
- CO "Positive Women" conducted a gender audit of the National Strategy on HIV/AIDS, Tuberculosis, and Hepatitis until 2030.
- An analytical report on monitoring cases of gender-based violence with recommendations was published.
- In November-December 2020, CO "Positive Women" conducted the campaign "There is no excuse for violence! - 2020" in 20 regions of Ukraine.
- CO "Positive Women" expanded its geographic reach into 3 more regions of Ukraine.

This will allow the implementation of modern regiments for the prevention of latent tuberculosis infection in the country. The application was approved by the expert group at the MOH and the inclusion of the drug in the state nomenclature was planned for January 2021 (the drug was included).

At the expense of the State Budget for 2020, for the first time, Ukraine purchased the combination of tenofovir/lamivudine/efavirenz 400 mg (EFV400) instead of the combination with efavirenz in a dosage of 600 mg. The WHO recommends combination with EFV400 as an alternative treatment for HIV. "100% Life" advocated for the inclusion of the drug in the nomenclature for purchasing in 2019.

The intervention of the "100% Life's" experts managed to accelerate the supply of levofloxacin for the treatment of patients with drug-resistant tuberculosis and minimized the risk of treatment interruption.

Experts of "100% Life" work in the MOH expert groups on the purchase of drugs for the treatment of TB, HIV, hepatitis B and C, as well as in the group on the purchase of substitution therapy for PWUD.

UAH 100 million from the state budget was saved Thanks to the advocacy work of "100% Life", the TB drug bedaquiline was purchased from the Global Drug Facility.

THE GLOBAL FUND SUPPORTED A STUDY ON THE IMPACT OF TRIPS+ PROVISIONS ON ACCESS TO MEDICINES.

- A unique methodology was used
- The negative impact on drug pricing was analyzed: data exclusivity, patent linkage, and the mode of patent term extensions

SINCE JULY 1, 2019, FUNDING FOR HIV PREVENTION, CARE, AND SUPPORT SERVICES HAS BEEN PROVIDED BY THE STATE BUDGET.

According to an agreement between the Global Fund and the Ukrainian government, since 2019, donor funding for the HIV program has begun declining in favor of increased public funding for HIV prevention, care, and support services. The 20-50-80 co-financing plan envisages 20% financing from the State Budget in 2018, 50% - in 2019, and 80% - in 2020.

Since July 1, 2019, funding for HIV prevention, care, and support services has been provided by the State Budget. The implementation mechanism was services procurement through the ProZorro e-procurement system.

The State procured services through tender procedures. The vast majority of service providers selected as winners were NGOs.

CTIVITIES OF "100% LIFE" TO MINIMIZE RISKS DURING THE TRANSITION PLAN IN 2020:

- A "100% Life's" sub-grantee, CO "Light of Hope", implemented final activities during the year to strengthen the role of local executive authorities in implementing measures to combat the HIV epidemic.
- Project experts and a budget advocacy consultant provided technical support for the implementation of advocacy initiatives in Khmelnytskyi, Rivne, Mykolaiv, Cherkasy, Kharkiv, Chernihiv, Kirovohrad, and Dnipropetrovsk (Kryvyi Rih) oblasts. In particular, they provided consultations with representatives of local executive authorities on the implementation of an expanded package of services in 2020 at the expense of local sources.
- Five round tables were held on the common subjects of providing the needs of people living with HIV, quality healthcare and social services, and the principles of cooperation between NGOs and local authorities. There was an exchange of best practices.

DEVELOPMENT OF THE INTEGRATED PROCESS AUTOMATION SYSTEM OF THE NATIONAL HEALTH SERVICE OF UKRAINE (THE IS NHSU) HAS STARTED

- The purpose of the IS NHSU development is to ensure the implementation of the NHSU functions related to the implementation of state policy in the sphere of state financial guarantees of public health services
- The IS NHSU will consist of modules that automate the processes of concluding and executing contracts in the framework of healthcare reform, data analysis, generation of analytical and financial reports, and exchange of information between users

The Integrated System of the National Health Service of Ukraine was developed in the framework of the project "Supporting eHealth Infrastructure Development in Ukraine" with financial support from the United States Agency for International Development

SUPPORT OF THE EHEALTH SYSTEM

In the eHealth system

- 30,900,000 patients were registered with eHealth
- 23,489 primary care physicians
- More than 6,000 healthcare facilities provided services at all levels of health care

The central database of the e-health system has been expanding

- The "Immunization" module was developed.
- Immunization information will be stored in a format convenient for both physician and patient, in compliance with international standards for the storage of such data.
- The work on the "Logistics Management Information System" (LMIS) module was started
- It will be used to track the logistics of medicines and medical supplies
- · With the support of the Global Fund and in cooperation with SE "Electronic Health", in 2020 the MOH started the development of technical documentation, including the Terms of Reference for LMIS, as well as expanding the functionality of electronic prescriptions for patients. The necessary software was purchased for SE "Electronic Health" to track activities and tasks for the development of the Terms of Reference for LMIS.

THE "CENTRAL 103" SYSTEM

Central 103 is a national IT system that controls the quality of emergency medical care (EMC) and accelerates the arrival of first responders and EMC

Central 103 is one of the components of the eHealth ecosystem and it provides digitalization of the entire EMC sector.

In 2020**

- The functionality of the Central 103 ecosystem. which interacted in both directions with the central database of the eHealth ecosystem, was updated.
- The analytical "Central 103" module was created.
- Three regional dispatching services were connected to Central 103, which allowed achieving the total number of connections - 23 regions of Ukraine.
- An ARI tool was developed to link primary responders to the Central 103 ecosystem.

The reform of primary, secondary, and tertiary health care continues.

"100% Life" Medical Centers

Four "100% Life" Medical Centers operate in Kyiv, Poltava, Chernihiv, and Rivne.

ABOUT MEDICAL CENTERS:

- The medical centers provided services to both general population patients and members of the community of people living with HIV, as well as representatives of at-risk groups.
- The centers were inclusive and open to all. The principle of our work is "100% tolerance"
- By signing an agreement with the MOH, the centers became part of the state healthcare system in 2018
- The medical centers provided the following services:
- · Family medicine
- Vaccination
- · Specialized health care
- SM⁻
- Diagnostic services, including HIV testing

- All four medical centers were provided with vaccines purchased from the state budget for vaccinations according to the National Vaccination Calendar. Additional recommended vaccines offered to customers on a commercial basis were also available.
- On April 2, 2020, a contract was signed with the NHSU to provide health care under the program of healthcare guarantees: treatment of patients living with HIV
- In 2020, the list of services provided in medical centers was expanded
- The Kyiv Medical Center additionally provided otolaryngology, orthopedics-traumatology, and ultrasound diagnostics
- The Chernihiv Medical Center additionally provided endocrinology, neuropathology, and otolaryngology





Representatives of both religious organizations and organizations of communities vulnerable to HIV, as well as healthcare professionals and psychologists were engaged in the creation of this textbook.



For the International AIDS Memorial Day, CO "100% Life" initiated an online memorial LIVE AIDS concert – a tribute concert of QUEEN performed by PIANOBOY.

N.B.: In 1992, a concert in memory of Freddie Mercury and all AIDS victims was held at Wembley Stadium in London. Dozens of artists on stage and an audience of millions around the world honored the musician. Almost 30 years have passed since then, but HIV/AIDS continues to spread.

The title LIVE AIDS reminds everybody of the Live Aid charity music festival in London in 1985, where Freddie Mercury performed.

On May 17, 2020, on the International AIDS Memorial Day, Dmytro Shurov, together with his son Lev and sister Olha, played cover songs of QUEEN.

The broadcast took place on the Facebook page of CO "100% Life".

CAMPAIGN FOR THE INTERNATIONAL HIV AND VIRAL HEPATITIS TESTING WEEK

In 2020, CO "100% Life" became a partner of Coalition PLUS, the international network of NGOs involved in the fight against HIV and viral hepatitis. It is the largest francophone coalition operating in 50 countries and uniting about 100 organizations.

From November 23 to 29, Ukraine joined the first International Testing Week launched by Coalition PLUS. CO "100% Life" became the provider of the testing week in Ukraine.

For the testing week, an animated video clip was created and a promotional campaign was launched on Youtube, Facebook, and Instagram.

The idea of the video clip was

To show the positive side of testing – "Test yourself. That is better".

Even if the test is positive, thanks to HIV therapy, you can live a full life, and hepatitis is curable in more than 90% of cases.

The video was made in light colors, close to the identity of the Testing Week.

The video clip linked the viewer to the prozdorovia. in.ua, where he or she was able to order an oral HIV test at home or find the nearest testing point in a city.

Promotion tactics

Showing a series of 30 and 6 seconds on Youtube and Facebook & Instagram. The long version showed a full story and the short one caught up with the viewer and reminded them of what they had seen.

Showing a series allowed giving information in several stages. The viewer was able to see each subsequent announcement only after viewing the previous one.

The goal was to reach the audience and provide traffic to the section "I Want to be Tested" on prozdorovia.in.ua.

SCHOOL OF POWER

A new format for involving communities in public health decision-making in Ukraine

In 2020, CO "100% Life" initiated a new format for training representatives of key communities.

- To effectively implement global health approaches in Ukraine, advocate for community interests, taking into account their opinion, "100% Life" developed a training format The School of Power.
- More than 150 activists, both offline and online, from the 9 most HIV-vulnerable communities were able to attend the School and learn about power, healthcare lobbying, as well as how to change the country and better advocate for patients' rights.
- Both current and former representatives of the highest executive and legislative bodies were invited as speakers and mentors: deputies of the Verkhovna Rada of Ukraine, members of the Cabinet of Ministers, representatives of the highest judicial, executive, and legislative branches, the best-known activists, change agents, and opinion leaders.
- The School of Power had two stages in September and November 2020.
- As a result, a cohort of activists was formed from among the communities who understand the architecture of the state system, decision-making, and levers of advocacy of patients' interests.



FIGHT FOR LOVE — FASHION THAT SAVES LIVES

725 rapid multi-tests for HIV, hepatitis, and syphilis were purchased from funds received from the For Love collection.

The collection was the result of the joint creative work of CO "100% Life", designer Ivan Frolov, and masters of the SOVA Jewelry House.

It was presented in 2019 at Ukrainian Fashion Week.

Jewelry was sold in online stores and all corners of the SOVA brand. A part of the revenue was used to combat the HIV/AIDS epidemic in Ukraine – procurement of rapid testing systems which allowed for timely diagnose of HIV and start treatment.

In 2020, the authors of the collaboration decided to expand the collection.

Since the collection sale began, CO "100% Life" purchased about **2,000** rapid HIV tests for funds received.



COMMUNICATION SUPPORT OF THE MOH, NHSU, AND PHC DURING THE COVID-19 PANDEMIC

The beginning of the pandemic in Ukraine coincided with the start of the second stage of healthcare reform, which created difficult conditions for effective communication regarding both the course of COVID-19 in Ukraine and the processes related to the transformation of the healthcare industry. CO "100% Life" with the assistance of the United States Agency for International Development (USAID) within the HealthLink project provided support to government agencies to improve the overall communication capacity of the NHSU, PHC, and MOH of Ukraine.

DIRECT ACTION EVENTS

Despite the quarantine restrictions, together with CF "Patients of Ukraine" and other partner non-governmental organizations, 4 direct actions were held to protect the patient's rights to have access to quality health care.









Protest action "Gnawed Bones for Health Workers and Patients: Cabinet of Ministers, Stop Cutting the Budget for Medicine" demanded to increase the budget for health care for 2021.



The action "Sovok Kills Healthcare Reform" defended healthcare reform and implemented transformation plans (July 23, 2020).



The action "The Ministry of Treatment with Asphalt" opposed the redistribution of budget funds from medicine to road repairing.



The action "Death Budget-2021" demanded to increase health care funding in 2021 from the State Budget to 5% of GDP.


