THE ORGANIZATION'S MANAGEMENT BODIES

On the eve of February 24, 2022

A month before the war, we developed a Safety Plan for all employees of 100% Life to be implemented in the event of an outbreak of hostilities.

- Relocation of warehouses from Kyiv and the region to Ivano-Frankivsk region. About 600 people (employees and members of the organization) were trained in three stages: tactical medicine; models of behavior in case of hostilities; strategies of behavior under occupation.
- A plan for securing financial processes was developed with the transfer of financial and logistical elements to the western part of Ukraine.

● Emergency delivery of ARV medications to Ukraine

Since the start of hostilities, approximately **130,000 people living with HIV in Ukraine have been at risk of going without ART**. CO 100% Life organized the rapid delivery of medicines to warehouses in Poland and then delivered them to all regions of Ukraine within three weeks. The PEPFAR program provided \$13 million in emergency funding to purchase 53 million doses of antiretroviral drugs.

The 100% Life team performed a logistical miracle by delivering ARV therapy to all regions of Ukraine. All HIV patients in Ukraine have been provided with treatment for the coming year. This is the largest and quietest operation to save Ukrainians during the war and an unprecedented display of solidarity, professionalism and partnership.

Urgent delivery of ARV therapy to HIV patients is a logistical miracle in wartime!



In the first months of the war,
THE 100% LIFE MEDICAL CENTER
in Kyiv was transformed into a humanitarian hub,
which received and distributed humanitarian aid:

- Sorting and delivery of medicines: **more than 30 tons and thousands of items**
- **More than 6,500 individual medical kits** were assembled and delivered to territorial defense units, the Ukrainian Armed Forces, and doctors.
- **6,000 bulletproof vests** given to ambulance drivers, doctors and social workers to protect their lives.

- **38 tons of food** were delivered to hospitals across Ukraine.
- Thanks to the crowdfunding campaign, **3 electric vehicles** were purchased for evacuating people, transporting medicine and humanitarian aid.

Volunteers of 100% Life carried out evacuation from the hot spots of Kyiv and Chernihiv regions with subsequent transportation to the western regions of Ukraine. In order to achieve this, we launched the **Chain of Life** on the basis of regional organizations of CO 100% Life. The main goal was to save Ukrainian lives by creating temporary infrastructure for the relocation of civilians within Ukraine.

We were the first to deliver medicines to occupied Chernihiv together with the Ministry of Health - the first trip was made on February 28th. The volunteers of 100% Life delivered medicines to the occupied city under shelling; these were dialysis medicines, insulin, asthma medicines, antipsychotic medicines, antibiotics and other medicines that were not available in pharmacies. To enter the occupied territory, volunteers had to use passwords and secret minefield maps.

One day a group of volunteers came under mortar fire, which resulted in a tragedy; our friends, the best and bravest, **Bohdan Stefanyshyn** and **Olexiy Antonov**, were killed.

The equipment of 4 hospitals in the areas of active hostilities in Donetsk and Luhansk regions was moved to safer areas.

THE SHELTER NETWORK

Together with its partners, CO 100% Life currently supports 13 shelters that operate on the basis of regional branches of 100% Life and partner organizations.

The shelters work with key populations as well as those who have experienced the horrors of war and need a break.

Shelters operate in Lviv, Rivne, Chernivtsi, Ivano-Frankivsk, Cherkasy, Khmelnytskyi, Bucha, Dubno, Luzhany, Khotyn.

We have combined our efforts to create the **Life Token**, a MILITARY TOKEN.

15% of the proceeds from the sale of the tokens will be used to purchase humanitarian aid and 5% will be used for the needs of the Armed Forces of Ukraine.

The personal token of Dmytro Sherembey, the head of CO 100% Life, was a lot at the Venice Biennale charity auction, where it was sold for 1,000 euros. The funds were used to meet the needs of Ukrainian patients.

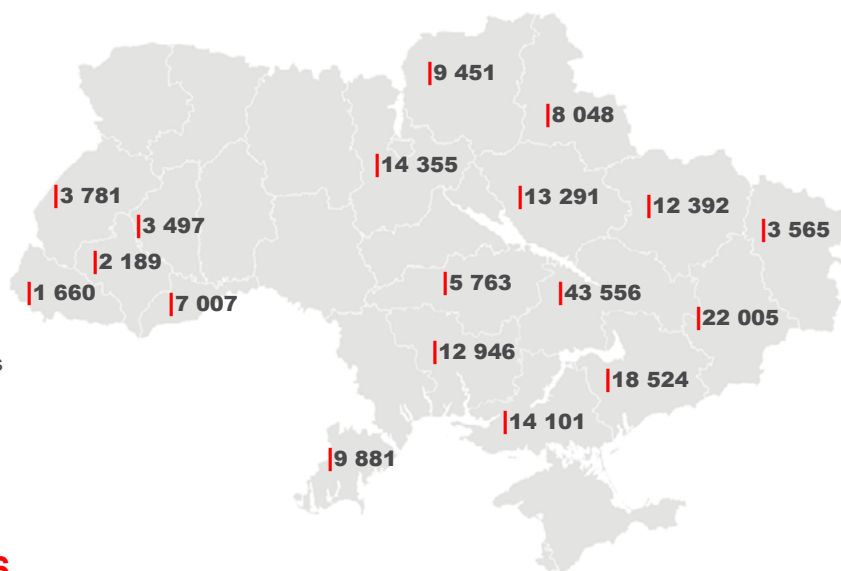

PROJECT / Creation of decent living conditions for an inclusive group of IDPs in the Rivne region as a rear region: preparation of a compact living center and repair of heating infrastructure in preparation for winter

With the support of the Humanitarian Fund for Ukraine

At the end of 2022, the preparatory stage of the project was completed, an agreement was signed, and the necessary preparatory works for the implementation of the project activities were carried out.

- The project is aimed at meeting the current needs of IDPs.
- The plan is to provide housing for 250 of the most vulnerable IDPs who arrived in Rivne region by creating a compact accommodation center on the basis of the municipal enterprise “Children’s sanatorium “Khrinniki” of Demydivska village council of Rivne region.
- In order to create decent living conditions for IDPs in compliance with sanitary and hygienic standards, it is planned to repair the heating infrastructure, carry out cosmetic repairs of the premises, purchase furniture and household items.
- The project will also provide comprehensive case management services with a focus on the inclusive group: victims of gender-based violence and other vulnerable categories.

HIV care and support

1,797 clients living in hard-to-reach settlements of 13 regions of Ukraine received services in the form of on-site multidisciplinary teams for screening for HIV, tuberculosis (TB) and viral hepatitis C (HCV)

↳ Of these, **1,790 clients were tested for HIV**

↳ 147 clients tested positive for HIV.

143 clients were diagnosed with HIV. 125 people started antiretroviral therapy (ART).

1224 clients were screened for TB

↳ 24 had suspected TB (2%), 2 clients were diagnosed with TB and referred to appropriate programs for further social support.

976 clients tested for STIs

↳ 90 tested positive. Clients with a positive result were referred to medical institutions for further treatment.

Supporting Children and Adolescents

638 HIV-positive children and children affected by the HIV/AIDS epidemic between the ages of 0 and 18 have received medical and social support.

All HIV+ children involved in the project are on ARV therapy, i.e. - 430 children, 30 of whom started ARV therapy for the first time in their lives.

The “Girls’ School” was regularly attended by 87 girls aged 10-18 years.

Other services

4,378 HIV+ clients received non-medical care services.

3,598 people received legal representation and 2,906 clients had their problems solved.

658 clients had their documents restored, 1,439 people received assistance with hospitalization and/or necessary diagnostics.

Work with HIV-positive clients who had fallen out of medical care was carried out in 13 regions of Ukraine, as a result of which 2,228 clients were covered, 2,067 people were returned to the medical monitoring system, **2,033 people are taking ART** (775 clients started/resumed ART).



Penitentiary system

HIV, TB, HCV testing, care and support services for prisoners:

- Social support services for TB patients covered all prisoners treated in specialized TB hospitals of the State Execution Service of Ukraine (SCESU):
 - Covering **583 people** with drug-resistant TB
 - Covered **354 people** with susceptible TB
- **111 prisoners with TB received services to prepare for release.** 51 people were enrolled in TB facilities in the civil sector.
- **953 HIV-positive prisoners received social support services during the preventive course of TB treatment.**



- **HIV testing support services reached 18,832 people.** Activities were conducted in 46 penitentiary institutions in 13 regions of Ukraine. **170 people received positive test results.**
- **Since the second half of 2022, ART adherence services have been provided in penitentiary institutions in all regions of Ukraine, covering 2,213 HIV-positive persons.** 35 counseling centers were equipped to provide support services in a remote format based on medical units of SCESU institutions.
- **345 HIV+ prisoners received services to prepare for release.** 276 people received post-release support. 214 people were enrolled in civil sector health facilities. In addition, 2,919 PWID received post-release social support services, of which 1,527 were referred to harm reduction programs and rehabilitation centers, and 17 clients received a prevention kit containing naloxone.
- As part of the pilot project to introduce pre-exposure prophylaxis (PrEP) in the penitentiary system of Ukraine, PrEP was started on a daily basis for 56 people.
- 328 HIV+ inmates were diagnosed by PCR for HCV (HCV RNA PCR), of which 264 people (80%) had a positive result.
- **Activities to change the risky behavior of inmates and to train social workers and/or volunteers from among inmates were carried out in 48 institutions.** For 378 prisoners, 2 cycles of training (8 classes each) for social workers were conducted. Two cycles of online courses “Basic knowledge of pre-hospital care in conditions of war” were also held (the total number of participants was 447 people). 16 courses (1,822 participants from 67 institutions) were held on participation in OST programs, harm reduction and re-socialization of PWID after release.
- On November 21, 2022, Order No. 7-OD of the State Institution “Center of Healthcare of the SCESU” was signed on the implementation of the pilot project “Implementation of a comprehensive package of services to reduce the harm caused by the use of psychoactive substances by convicts in the Medical Unit No. 14 of the Central Center of Healthcare of the SCESU in the Mykolaiv and Odesa regions”. In December 2022, preparatory work was carried out for the implementation of the pilot project in 2023.

TB prevention, care and treatment in the context of TB/HIV

- In **17 regions** of Ukraine.
- For the drug-resistant TB component, **4,383 clients were covered by social support**, of which 568 clients received services in the form of medical and social support (including TB drug supply and control services). For the susceptible TB component, 7,592 clients were covered, of which 982 clients received medical and social support.
- **135 children** under the age of 14 received services through the Social Nanny pilot project in 4 regions of Ukraine (Zaporizhzhya, Dnipropetrovsk, Zhytomyr and Cherkasy regions).
- **76 clients** from Zhytomyr, Zaporizhzhia, Kyiv (including Kyiv) and Cherkasy oblasts who are receiving palliative TB treatment received a package of psychosocial support tailored to their individual needs (including 10 people receiving adjuvant therapy to alleviate the suffering of patients in the terminal stage).
- **4,110 people** in contact with TB patients were screened. Of these, 3,759 clients were diagnosed with TB. 94 TB cases were identified. After excluding the diagnosis, 812 people were prescribed preventive TB treatment.



Monitoring of side effects of ARV drugs and TB therapy

- Activities to document adverse reactions due to ART and TB therapy were conducted in all regions of Ukraine with the exception of Kherson, Luhansk and Donetsk regions.
- There were 4,631 cases of adverse drug reactions, of which 2,400 – due to ART, 2,188 – due to anti-TB therapy, 42 – due to prophylactic anti-TB therapy, 1 – due to PrEP. All results are recorded in the Automated Pharmacovigilance Information System (AISP) by the social worker from the client's words.



Activities for the prevention and treatment of comorbidities: care and support for people with Hepatitis C

- Activities to support diagnosis and treatment of HCV among key populations living with HIV were implemented in **8 regions of Ukraine**.
- **292 clients** were covered by the services. Of these, 263 clients with a positive HCV rapid test marker were tested by HCV polymerase chain reaction (HCV RNA PCR) prior to treatment.
- **186 clients** tested positive for HCV RNA PCR, of whom 82 started treatment.

Medical and social support for HIV-infected children on the basis of OKHMATDYT and AIDS centers

- The national project of medical and social care and support for HIV-infected children and adolescents is implemented by the NGO "Childhood without AIDS" with the support of the NHL "OKHMATDYT". The services were provided to **351 children**.
- **6 visits** of the mobile technical support brigade to regional AIDS centers in Khmelnytskyi, Vinnytsia, Kirovohrad, Rivne, Chernihiv and Zakarpattia regions.
- The project team made **two visits** to the children of the family-type orphanage at the Holy Ascension Monastery and the MNE "Chernivtsi Regional AIDS Prevention and Control Center" to monitor treatment and conduct information sessions on overcoming problems of deprivation and increasing adherence to ART among HIV-positive adolescents.
- **4 information sessions** were held for 61 employees of the Service for Children and Family Affairs of the Kyiv City State Administration to improve work with parents of HIV-dissidents to protect children's rights to treatment and preserve their health.



Care and support of adult patients at the Hromashevsky clinic of the Institute of Epidemiology and Infectious Diseases

- Comprehensive services were provided to **721 HIV-positive clients** with the highest disease complexity, who are treated at the Hromashevsky Clinic of the Institute of Epidemiology and Infectious Diseases.
 - ↳ Among them, 185 are people with HIV third clinical stage and 438 people with HIV fourth clinical stage.
- **149 clients** from other regions of Ukraine received individual consultations on the diagnosis and treatment of opportunistic infections.
- **326 patients** with severe clinical course were additionally diagnosed and treated for co-infections.

All-Ukrainian HIV / AIDS and TB Hotline

- The national TB and HIV/AIDS Hotline handled 16,757 calls during the year, including
 - HIV/AIDS questions – 14,809
 - TB questions – 1,752
 - HIV/TB co-infection questions – 196.
- 21,349 counseling sessions provided.

Global Fund Response Mechanism for COVID-19

- The activities carried out under the project enabled the necessary diagnostics (including COVID-19 testing) and treatment continuity to be provided to **17,013 people** who, due to COVID-19 and war-related closures, have limited access to ARV and/or TB treatment directly in health facilities and do not have full access to diagnostics for routine HIV/TB treatment monitoring or other urgent diagnostics.
- **4,608 people received transportation services to health facilities**, 1,043 multidisciplinary team (MDT) visits were provided for HIV and TB. MDT visits resulted in 3,079 medical consultations, 5,111 consultations with a social worker/psychologist, 2,190 biomaterial samples for early diagnosis of HIV and/or TB, 2,169 tests using rapid tests for COVID-19. 23,092 ART deliveries were made to clients.
- **In the prison setting**, 557 diagnoses of opportunistic infections and 55 CT/MRI scans were performed. 4,766 T4D tests were performed. In 2022, 35 offices based on medical units and 5 counseling centers at the social-psychological service of penitentiary institutions were equipped to provide remote services.
- 3 modules were developed and 30 courses were held for 490 people, including medical and non-medical staff of SCESU institutions, on the following topics "Requirements for the use of personal protective equipment and its disposal", "Improving practical skills to ensure proper support for COVID-19 patients who need to use oxygen concentrators for treatment", "Ensuring compliance with infection control requirements related to COVID-19". Medical waste management was funded for 27 facilities.

PROJECT / “HealthLink: Accelerating Ukraine’s Efforts to End HIV”



HealthLink is the largest HIV testing project with unique scale, effectiveness, and achievements at the national and regional levels.

The project is implemented by CO 100% LIFE in partnership with ICF “Alliance for Public Health” with the support of the United States Agency for International Development (USAID).

It has been implemented since October 2017 in 12 regions of Ukraine, particularly in the Dnipropetrovsk, Donetsk, Zaporizhzhia, Kyiv, Kirovohrad, Mykolaiv, Odesa, Poltava, Kherson, Cherkasy, Chernihiv regions, and the city of Kyiv.

From October 2022, Lviv, Ivano-Frankivsk and Zakarpattia regions weren involved in the project.



As of 2022, approximately **866,000 people were tested for HIV, of whom ~21,000 learned their HIV status for the first time.**

- ~750,000 HIV tests performed by healthcare professionals
- ~600 HCFs, 27 NGOs, ~10,000 specialists
- 625 testing locations outside of HCFs
- ~75,000 oral HIV tests distributed, of which ~9,000 through www.prozdorovia.in.ua and another ~3,500 through testomats
- ~36,000 safe boxes* distributed
- ~15,000 PLHIV partners tested, of which ~3,000 learned their HIV+ status for the first time
- ~17,000 people received ART
- ~1,000 people received PrEP for the first time



* A safe box contains an oral HIV test, instructions, social worker contacts, useful brochures, a sticker pack; it may also contain condoms, etc.

In 2022:

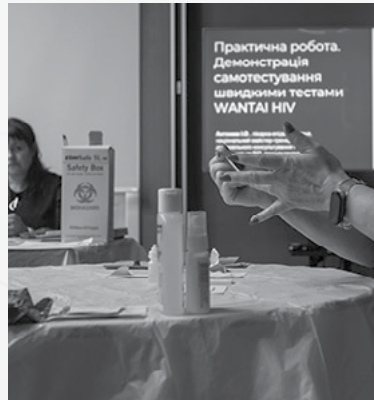
Despite difficult working conditions and a decrease in testing during wartime, the **effectiveness of detecting HIV-positive people has increased**

- ~83,000 people tested for HIV
- ~3,500 people learned their HIV+ status for the first time
- ~3,200 people received ART for the first time
- 217 HCFs provided HIV testing services
- 25 HCFs affected by hostilities
- 10% of HCFs are located in the temporarily occupied territories

Despite the difficult situation, the regions most affected by full-scale war were the most active in providing public health services.

Key challenges

- Lack of basic security to carry out full activities
- A shortage of workers and an extremely heavy workload for those who remain at work
- Complicated logistics due to damaged settlement infrastructure
- Loss of contact with many clients
- Increased need for material resources due to the increased number of IDP clients
- Uncertainty about future work and psycho-emotional exhaustion.

Mykolaiv shelling. When overcoming challenges becomes commonplace

On February 24, the provision of services to MSM was suspended in the Kherson and Donetsk regions and is still limited in the Mykolaiv region, which is in the frontline zone and subject to intense shelling. A large number of residents and medical personnel had to leave the city of Mykolaiv. Despite all this, Victoria from the NGO "LGBT ASSOCIATION "Liga" continued to conduct HIV tests at the Mykolaiv "Dovira" office. More than 40% of all tests were performed there. Nearly 87% of clients who learned their positive status started ART. At the same time, Victoria's colleague, who works as a psychologist in the organization that is part of the HealthLink project, provided continuous support to clients both online and offline.

"I met a man who is living with HIV. Now we're together"

Oksana moved from Donetsk to Pavlograd in 2014. She went through a terrible period: the occupiers came to her hometown and the ATO started. Her husband supported the so-called "DPR" and stayed in the city. Since then he hasn't been in contact with his wife.

Six months ago, the woman began to suffer from frequent colds. Then she was affected by COVID-2019 and ended up in the hospital. She had fever and lost a total of 10 kg of weight. The doctors couldn't find the cause of her condition until they finally received the results of an HIV test. In those 15 minutes of waiting, Oksana's whole life flashed before her eyes. Her status was positive.

The woman was alone in the hospital, where everyone was trying to save her. The HIV news was followed by a new diagnosis - pulmonary tuberculosis. Oksana's immune system was severely weakened by HIV in the years before she learned her status. The social support counsellor visited her regularly at the hospital and then accompanied her to the AIDS center for registration and initiation of ART. This support enabled Oksana to accept her status and make plans for her future life. "I met a man living with HIV. Now we're together."

"I am very grateful to Olga from CO "100% LIFE DNIPRO" who was there in the difficult moments of my life. She did not turn away from me, she sympathized with me, helped me and was in contact with me around the clock. I met a man who is also living with HIV and on ART. He reassures me that I am strong and great. We have become a couple," said Oksana.

PROJECT / “ACCESS Pro: Community Access to HIV Treatment through Strengthening Information Systems and Improving Access to Services”

Supported by CDC

Timeline: October 2022 - September 2023

Implementation of the Laboratory Information Management System (LIMS) software in the laboratories of the Centers for Socially Significant Diseases.

Due to the hostilities, it was decided to install the LIMS software in 6 regions:

- The purchased hardware and network equipment were delivered to the target cities and transferred to the remaining health facilities.
- LIMS software was installed and configured in HIV/AIDS research laboratories of 6 regions of Ukraine (taking into account reconstruction changes due to war): Kyiv, Poltava, Kirovohrad, Vinnytsia, Rivne, Lviv.
- It was accredited according to the national standard DSTU ISO 15189 “Medical Laboratories. Requirements for competence and quality” in five laboratories of AIDS centers and agreements with the National Accreditation Agency of Ukraine on accreditation of the following laboratories were concluded:
 1. ME “Kryvyi Rih Center for AIDS Prevention and Control” of the Dnipropetrovsk Regional Council;
 2. MNE “Cherkasy Regional Center for Public Health” of Cherkasy Regional Council;
 3. ME “Dnipropetrovsk Regional Center for Socially Significant Diseases” of the Dnipropetrovsk Regional Council;

- As of December 31, 2022, the following AIDS research laboratories are using the LIMS software: Cherkasy, Dnipropetrovsk, Kryvyi Rih, Mykolaiv, Chernihiv, Kirovohrad, Poltava, Kyiv (regional), Vinnytsia, Rivne, Lviv and PHC AIDS research laboratory.
- Technical support for LIMS software operation is provided via telephone and online applications.

The project supports the implementation in Ukraine of an established industry standard for coding data in medical documents, LOINC (Names and Codes of Logical Observation Identifiers).

Deployment of OST Module in SSDM IS (Socially Significant Disease Information System) in PEPFAR Priority Regions

- Data on 4,716 clients have been entered into the information system, 4,376 of them are active cases, clients are receiving OST drugs, 340 clients have finished their participation in the program and therefore their cards have been closed. Data on patients were entered by 62 OST centers from 12 regions of Ukraine, namely Dnipropetrovsk, Donetsk, Zaporizhzhya, Kirovohrad, Kyiv, Mykolaiv, Odesa, Poltava, Kherson, Cherkasy, Chernihiv, and Kyiv City.
- Data Quality Assessment (DQA) activities of the SSDM IS were carried out and 97 monitoring visits were conducted in 86 institutions using the relevant system module.
- A series of online trainings on data analysis on the Power BI platform (between September 14 and 27) was organized and conducted for regional DQA coordinators, specialists of SI "Center for Public Health" and CO "100% of LIFE".

Remote (online and telephone) counseling services for subscribers who contact the HIV/AIDS hotline (hereinafter referred to as the “HL”).

2,947 targeted calls to the Hotline.

The HL consultants provided 3,926 counseling sessions:

- Ⓡ 807 counseling sessions for index testing
- Ⓡ 1193 PrEP counseling sessions
- Ⓡ 1554 counseling sessions on the specifics of ART in wartime and 11 complaints received about the reduction in the duration of ART
- Ⓡ 97 legal consultations
- Ⓡ 264 were other inquiries about HL that did not require assistance.

The Organization continues its partnership with the State Institution “CPH of the Ministry of Health of Ukraine” in the form of live counseling of subscribers who need additional information on the specifics of receiving ART in times of war and abroad through a [Telegram chatbot](#).

The "100%LIFE" application.

Due to the military aggression and the displacement of many clients within Ukraine, it became necessary to quickly update the client mobile application as soon as possible.

As part of the mobile application update, the following features have been implemented:

- Ⓜ Login to the mobile application
- Ⓜ Viewing search results
- Ⓜ Search, filter research results
- Ⓜ Graphical display of BH and CD4 study results
- Ⓜ Prescription in treatment plans
- Ⓜ Setting up a calendar for taking medications, displaying the calendar in different variations
- Ⓜ Automatic medication administration
- Ⓜ Schedule a doctor's appointment
- Ⓜ Notification of new appointments and test results.

PROJECT / Strengthening the response to urgent changes in the country to further develop the organizational capacity of 100 PERCENT LIFE

Supported by GIZ

Timeline: October 2022 - March 2023

The main activity of the project is the development of a unified management and administration system for the coordination of client transportation activities and the provision of services for the Chain of Life shelter network.

- The following functionalities were developed: accounting, shelter accounting, statements for the exchange of customer needs, flight and transport accounting, dashboards and analytics, a chatbot for the driver, an experimental chatbot for the social worker.
- After the license was developed and purchased, a trial period for users began. The first shelter connected to the management and administration system was the one in the Lviv region.
- After the pilot project in Lviv region, other shelters were connected to the management system. Now the functions of accounting, shelter accounting, statements for exchange of client needs are fully operational, and the rest of the functions will be connected in the near future.

Currently, shelters are connected to the management and administration system in four regions, namely:

- Eleos Ukraine in Lysets (Ivano-Frankivsk region)
- Eleos Ukraine in Khotyn (Chernivtsi region)
- St. Olha Shelter in Varkovychi (Rivne region)
- 100% LIFE Lviv (Lviv region)



PROJECT / Public Health

With the support of the European Union Anti-Corruption Initiative (EUACI), implemented by the Danish Ministry of Foreign Affairs (DMFA)

Partners of the project
Medical Centers "100% Life"

- During the devastating hostilities as a result of Russian aggression in Ukraine, there was an urgent need to provide critical medical supplies to health care facilities assisting Ukrainian citizens.
- Thanks to the project, medical supplies were promptly purchased and delivered for the Public Health Center and subsequently distributed in medical institutions of Chernihiv, Mykolaiv and Kyiv regions.
- During active hostilities in the Kyiv region, the project purchased fuel for the cars of volunteers who evacuated civilians from the most inaccessible areas of the region.
- Electricity generators were purchased and delivered to meet the needs of civilians in small, hard-to-reach villages and settlements where hostilities took place and which have since been de-occupied.
- The purchased generators were used by civilians not only to charge phones, computers and batteries, but also to charge power tools while repairing damaged buildings.



PROJECT / CO “100% LIFE” AND THE UKRAINIAN HELSINKI HUMAN RIGHTS UNION

Legal support, information, referrals, consultations and representation of interests of people living with HIV, TB and HIV-vulnerable groups

- **3,935 qualified legal consultations** in 2022 in the main and COVID projects.
- Legal support to **34 strategic cases**, including 11 in the ECHR.
- 2 strategic cases won at the ECHR.
- Support to 152 pre-trial cases, of which 124 were resolved in favor of the client, i.e. 79% of pre-trial cases were successful.
- In 2022, the LegalBot 100% LIFE chatbot answered 1,474 questions and recorded 26,995 sessions.
- The legal content of the chatbot was developed with a new section “Martial Law”, consisting of 26 questions and their answers. The new section was launched in May 2022.
- In 2022, UHHRU lawyers successfully concluded the case of [M.K. v. Ukraine](#), in which the ECHR found a violation of Article 8 of the Convention due to the fact that the hospital did not inform the applicant of the results of her HIV testing and disclosed the applicant’s HIV-positive status to her mother and her management at work (a military unit). The European Court of Human Rights ordered the applicant, who had tried unsuccessfully for years at national level to prove that her rights had been violated, to pay 5,000 euros in compensation for damage caused by the state.
- In the future, the decision in the case of [M.K. v. Ukraine](#) will be used in law enforcement practice as a “decision on the HIV status disclosure”, because it concerns a violation of Article 8 of the Convention, that is, the right to respect for private life, since personal information about the patient belongs to their private life.

PROJECT / Mobile SRH Brigades

Supported by UNFPA

The goal is to improve access to obstetric, gynecological and therapeutic care for the rural population and communities where access to health services is difficult.

The target population includes IDPs, persons with disabilities, and other vulnerable groups.

The project also aims to identify, provide medical care and refer survivors of gender-based and sexual violence to other services.

In 2022:

- **11 Sexual and Reproductive Health Brigades (SRH)** and 1 Mobile Maternity Brigade (MMB).
- 7 SRH brigades and one maternity brigade began their active work in 7 regions of Ukraine.
- **109 medical specialists** were involved in the provision of counseling services, providing 4,160 consultations.
- **3,437 people over the age of 18 and 137 people under the age of 18 were counseled by medical specialists.**

PROJECT / “Medical assistance to regions of Ukraine facing humanitarian crisis”

Supported by Peace Winds Japan

CO 100% Life and Peace Winds Japan signed a Memorandum of Cooperation to provide medicines to Ukrainian hospitals to meet the needs of people affected by the hostilities. Peace Winds Japan, a Japanese NGO, was one of our first new partners to offer immediate assistance.

29 hospitals in the hardest-hit areas received \$1 million worth of medicines. Since the beginning of the full-scale invasion, hospitals in the Chernihiv, Sumy, Kharkiv, Luhansk, Donetsk, Zaporizhzhya and Kyiv regions and the city of Kyiv have received **1,101,898 packages of 90 types of drugs.**

Faced with the **challenges of winter and power outages**, Panasonic’s support helped us deliver 17 6.5 kW inverter generators to 17 hospitals in the Donetsk region, which continue to operate under the most difficult conditions. They ensure the smooth operation of the hospital during power outages.

The cooperation with Peace Winds Japan and the Japan Platform provides expanded support to the healthcare system in Ukraine.



PROJECT / “Support for the development of eHealth infrastructure in Ukraine”

Supported by USAID

In 2022, a 4-year project to **support the eHealth system** was completed

- **8 eHealth Modules** were developed and supported.
- In 2022, the **development of the NHSU Information System was completed** and all the necessary licenses for its full operation were acquired. This system will ensure effective operational management of all financial processes of the NHSU and will increase the resilience and institutional capacity of the Agency.
- Work is underway on the Logistics Management Information System (LMIS) module, which will be used to track the logistics of medicines and medical supplies.
- With the support of the Global Fund, in collaboration with the State Enterprise “Electronic Health” and the Ministry of Health, terms of reference were developed in 2022, including the terms of reference for the LMIS, as well as the expansion of the functionality of electronic prescriptions for prescribing medicines to patients.



PROJECT / Tactical Medicine

In collaboration with the NGO "Charitable Foundation "Headquarters UA"

- A project to train military personnel in tactical combat medical care.
- More than 400 servicemen have learned the skills of pre-hospital medical training in tactical conditions according to the TCCC protocols of the US Armed Forces.
- Currently, the units of the Armed Forces where the TCCC system is implemented (in NATO countries) have the best casualty survival rate in the entire history of observation.



PROJECT / Advocacy for access to treatment.

Supported by Unitaid and Aidsfonds

- Development and advocacy of a legislative proposal for the restriction of intellectual property rights (the so-called **"IP waiver"**) in accordance with Art. 73 "Security Exceptions" of the Agreement on Trade-Related Aspects of Intellectual Property Rights to reduce barriers to access to critically needed medicines for the period of war and its aftermath.
- In April 2022, the text of the draft law was submitted to the Profile Committee of the Verkhovna Rada.

IP waiver, the waiver of intellectual property rights, compulsory licensing and the use of inventions in the public interest were discussed at two high-level roundtables organized by CO 100% Life in collaboration with its partners:

- Biosafety in times of war.
- Access to affordable medicines during war in Ukraine, organized together with the Max Planck Institute, brought together international experts in the field, as well as representatives of the Ministry of Health, the Ministry of Economy, local pharmaceutical companies and scientists.
- Advocacy for the elimination of the provision on the automatic and unconditional extension of the term of intellectual property rights for the duration of martial law led to the revision of the law of Ukraine "On protection of the interests of persons in the field of intellectual property during martial law imposed in connection with the armed aggression of the Russian Federation against Ukraine", adopted in April 2022.

In January 2023, we received the first draft from UKRNOIVI for comments and suggestions. Currently under review in UKRNOIVI.

- **Patent opposition prepared on bedaquiline patents** and the decision to extend the patent term.
- The tocilizumab patent opposition litigation is ongoing. The first court hearing was held in November 2022.



**BUDGET
ADVOCACY
AND HUMANITARIAN
AID ADVOCACY**

In 2022, the following results were achieved:

- 109 deliveries of humanitarian aid were made, including: for the needs of clients with HIV, TB and other HIV-vulnerable groups, internally displaced persons, under martial law, the needs of medical infrastructure facilities, with the total value of UAH 136 million;
- 108 trips for safe evacuation of people: women and children were evacuated from the combat zones/zones close to the hostilities to safe places (1,564 people were evacuated);
- Access to services for IDPs, including: clients with HIV, TB and other HIV vulnerable groups, in 8 shelters run by NGOs and 9 other equipped premises/dormitories of educational institutions, etc;
- Access to services of the extended package in shelters/equipped premises was provided to 3,586 people, which is 89,980 person/days of stay or services received.

Our representatives participated in the work of the Profile Working Group on the draft **law of Ukraine "On Amendments to Certain Legislative Acts to Simplify the Procedure for Import, Accounting and Distribution of Humanitarian Aid"** to improve the circulation of humanitarian aid, including medicines, in Ukraine. The draft law has been finalized and is being prepared for the first reading by the Verkhovna Rada of Ukraine.

● Shelters, evacuation, clothing

In 2022,

1. Together with the social sewing enterprise "Oversize", 100 sets of uniforms were sewn for Ukraine's defenders. **In addition, 100 bulletproof vests were sewn to protect doctors working in the ambulance service.**
2. Due to the military aggression of the Russian Federation, Ukraine needed and still needs a network of shelters and rapid response services for people directly affected by the war, refugees and IDPs. Namely, the need for rapid movement of people from combat zones to a safe space, that is, the shelters. Together with ELEOS-Ukraine, a map of shelters in Ukraine was created. As part of the project and with the support of the International Renaissance Foundation, a 7-seater passenger car was purchased for the rapid transportation of injured people from the areas of active hostilities and the provision of first aid (shelter, food, clothing, medicines).
3. As part of the Chain of Life project, with the financial support of GIZ, a CRM was created to facilitate the input of information by the shelter staff about the people who settle in the shelter, in particular, the registration of new IDPs, their transportation to safe places and shelters, the registration of services needed by IDPs (food, clothing, medical, legal assistance, etc.). Currently, 5 shelters are connected to the CRM: Lviv city, Ivano-Frankivsk region, Chernivtsi region and Rivne region (2 shelters).



● **Advocacy work in partnership with the CF “Patients of Ukraine” and the Ukrainian Foundation for Legal Aid**

1. As part of collaboration of CO 100%Life with the Ukrainian Foundation for Legal Aid of UFPD in 2022:

- legal information/advice was provided to 517 clients on their appeal through the [Telegram channel](#) and for 33 clients on their appeal through DataCheck;
- 12 consultations on current legal problems of clients were held and published on the [Telegram channel](#);
- a training program was prepared for a distance course for lawyers providing free legal aid on how to respond to cases of discrimination against clients and prejudice on the part of authorities, law enforcement agencies; available at <https://edu.ua2j.school/enrol/index.php?id=13>;
- 23 paralegals from key communities were trained to provide initial legal advice and referrals for clients on using the chatbot and DataCheck

2. As part of collaboration of CO “100%Life” with CF “Patients of Ukraine” in 2022:

- the Humanitarian Center was launched:
 - Nearly **57 million UAH** were raised, which was used to purchase more than **48,000 packages of medicines, 1,328 units of equipment, 1,427 units of consumables for equipment and more than 120,000 units of medical goods and products, which were delivered to more than 70 hospitals and communities in 20 regions;**
 - Donations of more than **150,000 packs of medicines, 500 units of equipment consumables, 205 units of medical equipment, and more than 2,000 units of medical supplies and goods were received and delivered to hospitals in 10 regions;**
- Legal advice was provided to 33 patients on treatment in Ukraine and abroad during the war;
- Active participation in the work of the Commission of the Ministry of Health of Ukraine on the termination of marketing authorizations, which prevented the cancellation of more than 300 marketing authorizations for drugs of two European drug manufacturers.

3. Proposals have been developed and submitted to the draft specifications and terms of purchase under the Program of Medical Guarantees in 2023 in the area of “Diagnosis, treatment and support of persons with human immunodeficiency virus”.

PROJECT / “Fighting for Life”

Supported by Expertise France

Support of the network of Medical Centers “100% Life” in wartime



Four “100% Life” medical centers operate in Kyiv, Poltava, Chernihiv, and Rivne.

The implementation of the project is closely connected with the active phase of the Russian invasion of Ukraine. **Currently, all four regional medical centers of the 100% Life LLC network continue to operate and help people in need: PLHIV, TB patients, representatives of the most vulnerable communities, pregnant women, IDPs and the general population.**

● Medical Center in Chernihiv

- Since the beginning of the full-scale war, 27 bridges and overpasses have been destroyed in the Chernihiv region. In the Chernihiv region, the Russian military has damaged or destroyed about 3,500 buildings. In the Chernihiv region the Russian military destroyed 27 (out of 34) schools and 37 (out of 52) kindergartens, 3 (out of 4) hospitals.
- The 100% Life Chernihiv Medical Center resumed operations on June 1, 2022. The medical center continued to support PLHIV, socially vulnerable groups and the population of Chernihiv as a whole – it was one of the few operating clinics in the region.

- **Medical Center in Kyiv**

- The Kyiv branch also resumed operations on June 1, 2022.
- In the first months of the full-scale invasion, the medical center in Kyiv worked as a humanitarian hub.
- The medical center in Kyiv helps those who came to Kyiv from the eastern regions, as well as clients from the destroyed cities and villages of the Kyiv region. New patients displaced by the hostilities require medical care and tend to experience financial hardship as they try to meet their basic needs with limited resources.

- **Medical Center in Poltava**

- Since the beginning of the war, people from the neighboring cities of Russia began to move to Poltava. Poltava became a buffer city. The Medical Center “100% Life” continued to provide medical services to IDPs, PLHIV and vulnerable groups, clients of opioid substitution therapy programs and the general population.
- The number of patients began to increase and the staff of the medical center expanded. The number of patients receiving ART and OST also increased.



● **Medical Center in Rivne**

- As a result of the Russian invasion of Ukraine, Rivne also became a buffer city for people traveling to western Ukraine and abroad. In the medical center “100% Life” in Rivne the number of patients increased and there was a need for additional specialists.
- The medical center moved to another building and expanded its functions with additional services such as ultrasound, gynecologist, dermatologist, pediatrician.
- The proposed response strategy, based on hiring additional health care providers, expanding the number of services, and supporting existing units, enabled more HIV and TB clients to access skilled health care.

Unique services provided to patients of 100% Life medical centers:

100% Life LLC is the **only private institution in Ukraine that has signed an agreement with NHSU to provide services to PLHIV. The service is fully free of charge and is provided in clinics in Kyiv, Rivne, Chernihiv and Poltava.**

A free package of services for people living with HIV (*provided whenever possible, taking into account wartime circumstances*).

The patient who is registered in the medical center “100% Life” additionally receives the following free of charge:

- Ultrasound (abdominal organs, kidneys and bladder, thyroid gland, small pelvis, mammary glands, etc.);
- Counseling by doctors - specialists of a narrow profile (can be obtained at the medical center);
- Free supply of antiretroviral drugs by Nova Poshta.



**COMMUNITY
DEVELOPMENT**

● Investing in capacity building and institutional development = strong communities.

● Legislative work of the Struggle for Health Platform

The Platform brings together national human rights defenders, community leaders and experts in the fields of HIV/TB/human rights.

The Commissioner for Human Rights of the Verkhovna Rada of Ukraine awarded CO “100% Life” with the Award for regular work on human rights protection, advocacy for the principle of universal coverage of HIV testing and treatment, and legislative activities carried out by the Struggle for Health Platform.

Activities of the Platform:

- Amendments have been made to the HIV bill regarding universal coverage of HIV testing and treatment.
- 5 packages of bills have been prepared to decriminalize the provision of sexual services, to remove the stigmatization of persons for health reasons, to decriminalize persons who use drugs and to expand the practice of using rehabilitation rather than punitive methods to influence this problem, etc.
- The concept of registered civil partnerships for same-sex couples was presented to the Ministry of Justice and the Office of the Ombudsman, and negotiations were held with parliamentarians to support the bill.
- Inclusion of the Platform’s developments in Ukraine’s Economic Recovery Plan for 2022-2032 and in the draft strategy for reform of the penitentiary system until 2026 (in terms of prison medicine and protection of prisoners’ medical rights).
- Advocacy for ratification by the Verkhovna Rada of the Council of Europe Convention on preventing and combating violence against women and domestic violence (ratified)
- Experts from the Platform participated in the working group of the Verkhovna Rada on the development of a new Criminal Code of Ukraine and advocacy for the decriminalization of HIV.

• Paralegal care for people at risk of HIV and TB

150 paralegals from all communities provide prompt free legal assistance on a peer-to-peer basis.

25 lawyers of Free Legal Aid Centers, lawyers of the Ukrainian Helsinki Human Rights Union and trusted community lawyers provide free professional legal assistance to communities.

In the system of operational legal aid, DataCheck appeals and complaints modules: **8,150 appeals from community representatives were registered, 3,551 appeals required and received paralegal assistance.**

● Humanitarian work of communities

• People who inject drugs (PWID)



CF "VOLNA"

- The PWID community organized the evacuation of 573 representatives of key populations from areas of active hostilities.
- Delivery of ART drugs to Donetsk oblast for key populations.

• Sex workers (SP)



CO "Legalife-Ukraine"

- The community of sex workers has been informed and coordinated on how to obtain the necessary social, medical, legal services and humanitarian assistance.
- Evacuation to safe places of stay and residence is provided: crisis centers, shelters.
- A variety of assistance was provided to more than 500 sex workers in Ukraine and to their children.
- There is a hotline for sex workers.

- **Adolescents living with HIV**



NGO "Adolescents of Ukraine"

- With the support of the 100% Life Central Office, adolescents living with HIV were evacuated to Germany.
- Adolescents living with HIV were coordinated to receive ART in Ukraine and abroad.
- Psychological counseling on treatment and adherence.

- **Women living with HIV**



CO "Positive Women"

- The community of women living with HIV in the regions of Ukraine and in Kyiv City and Kyiv region created safe spaces for women vulnerable to violence and HIV, and women affected by gender-based and domestic violence.
- Hundreds of women used the services of psychologists and safe space social workers and received assistance in the form of hygiene kits and food vouchers.
- Links were established with all crisis centers in the regions, allowing community members to be sent to them for shelter.

- **Men who have sex with men (MSM)**



NGO "ALLIANCE.GLOBAL"

- 699 MSM/LGBTI community representatives received assistance in the form of humanitarian kits, shelter or other services.
- Four shelters for LGBTIQ+ communities and their families continued their activities in Chernivtsi, Dnipro, Kyiv and Lviv.
- NGO "LGBT Association" Liga" held a training session on professional and emotional burnout for volunteers and staff of MSM/LGBT organizations.

- **Ex-prisoners**

- Shelter and social support are provided for people who have been released from prison.

- Representatives of the TB community provided humanitarian assistance to TB facilities in 21 oblasts.
- The community raised more than UAH 1.5 million to provide humanitarian assistance to community representatives during the war.

CO "FREE ZONE"

- The Community of Former Prisoners has developed proposals for amendments to the Regulations on Employment of Convicts, and a corresponding appeal to the Ministry of Justice and the Cabinet of Ministers of Ukraine has been prepared.
- A full package of documents was prepared and draft amendments to the CEC of Ukraine, the Law of Ukraine "On Pretrial Detention", as well as to the Fundamentals of Health Legislation were submitted to the Verkhovna Rada.
- Consultations were held with inter-parliamentary associations.
- **Together with FreeZone**, 9 advocacy campaigns were conducted to collect material, humanitarian and other aid to meet the needs of representatives of the community of convicts and released prisoners in 9 regions of Ukraine in the total amount of almost 12,360,000 UAH.
- Despite the military aggression of the Russian Federation and difficulties in accessing penitentiary institutions, it was possible to carry out 30 monitoring visits to penitentiary institutions.
- Amendments to the "Regulations on Supervisory Commissions" were advocated. On November 25 the government approved the amendments.
- Information was provided on the features of the Free Life application. During the war, the application became an indispensable source of up-to-date information and communication with the community of convicts and released prisoners.
- 5 temporary accommodation facilities for the community of convicts and released persons were supported; household appliances, equipment and goods necessary to ensure the living conditions of the released persons were purchased.
- Effective coordination of stakeholders in the processes of collecting and meeting the humanitarian needs of convicts and released prisoners under wartime conditions was ensured.

CO "Positive Women"

- On June 22, 2022, amendments to key documents in the field of prevention of mother-to-child transmission of HIV in Ukraine, approved by Order No.692 of the Ministry of Health of Ukraine, came into force.
- 285 mutual support group meetings were held.
- 4 webinars for clients on the following topics "The Right to Protection from Psychological and Physical Violence", "Problems of Legal Regulation in Combating Violence against Women in the Family and Domestic Sphere", "Activities of Law Enforcement Authorities in Combating this Offense", "Improvement and Enhancement of the System of Protection of Women's Rights from Domestic Violence".

- Thanks to community advocacy, the submission of an order to the Ministry of Justice to increase the minimum dosage of narcotics for personal use was suspended.
- As a result of the advocacy activities of community leaders, the Department of Health's Regulation "On the Provision of Palliative Care and Supportive Substitution Therapy to Patients under Martial Law" was drafted and approved.
- The community developed an OST queue monitoring tool that allows real-time monitoring of the implementation status of the OST program.
- A manual on gender-sensitive services was developed for HIV service NGOs.
- Advocacy for amendments to the Criminal Code of Ukraine and work on decriminalization of PWID in Ukraine were carried out.
- 7 budget advocacy cases were completed.

- **Men who have sex with men (MSM)**



NGO "ALLIANCE.GLOBAL"

- A representative of the Community has been included among the experts for cooperation with the Government on the European integration track.
- Interaction with the Council of Europe Department, Human Rights and Gender Coordination of the Department of International Organizations of the Ministry of Foreign Affairs was established (on November 24, 2022, the Ministry of Foreign Affairs reported that Ukraine had joined the statement of the Coalition for Equal Rights criticizing the new Russian law on "Prohibition of LGBT Propaganda").
- A desk review of the situation in ensuring the sustainability of the basic/expanded package of services for MSM at the regional level in war and internal displacement was conducted, as well as an analysis of the provision of public health services for MSM in war and internal displacement.
- The National LGBTI Consultation 2022 "Ukrainian LGBTI: War and Life" was held. Based on the results, a roadmap was developed to ensure the freedoms and human rights of LGBTI people in Ukraine in 2023.
- Additional financial and humanitarian resources have been mobilized for MSM/LGBT needs.

- **Sex workers (SW)**



CO "Legalife-Ukraine"

- 579 information sessions for sex workers, the All-Ukrainian Forum of Sex Workers were held and the main priorities of the community's activities under war conditions were assessed and identified.
- Additional funds were raised for humanitarian assistance to the SW community.

- **People at risk of TB (TB community)**



CO "TB people of Ukraine"

- Monitoring the availability of medicines in the regions of Ukraine. Proposals were made at the meetings of the working group for the development of draft specifications and conditions for the procurement of medical services under the Medical Guarantees Program - 2023.
- **Together with TB People Ukraine, a training course** "Formation of tolerant attitudes of health workers towards TB patients and representatives of high-risk groups" was developed and placed on the **training platform of the NHSU Academy**.
- Advocacy was conducted in the regions to encourage health facilities to adopt anti-stigma and anti-discrimination policies. Currently, **86 healthcare institutions in 5 regions have adopted the policy**.
- As part of **the implementation of the Plan** for the Transition to State Financing of Support Services for People with TB, the "Procedure for Procurement of Medical and Psychosocial Support Services for People with Sensitive and Resistant TB" and the Regulation "On Approval of Marginal Tariffs for the Provision of TB Services" have been developed and are in the process of final approval by the central executive authorities.
- Active implementation of **the Onelmpact app** continued. In 2022, 2,117 new users were registered. The total number of calls is 1,861, of which 1,503 have been verified. Consultant trainers provided individual and group consultations on the possibilities of the mobile application for people with TB and submitted their requests on barriers. **In 2022, 3,435 people from 19 regions of Ukraine were covered by information counseling sessions**.
- Continued support for the activities of the National Expert Group on Barriers: the group considered 15 cases of violation of the rules of people with TB. Humanitarian assistance was provided such as food, disinfectants, heaters, and electricity generators to 7 regional phthisiopulmonology centers. To collect the needs of TB hospitals, patients and specialized NGOs, an online form was created and shared to indicate the urgent treatment needs of patients.

- National counseling sessions for HIV+ adolescents were held.
- Proposals for the "Strategic Plan for a Comprehensive Response to Human Rights Barriers Associated with the Spread of HIV and Tuberculosis in Ukraine for 2023-2026" have been submitted.

Organization ELEOS - UKRAINE



- Held 200 regional meetings with 146 representatives of churches and religious organizations from 11 regions of Ukraine.
- 2 thematic meetings of the Commission on Social Service of the All-Ukrainian Council of Churches and Religious Organizations.
- The All-Ukrainian Conference "Faith for Life 2022" was organized and held.
- 40 students of theological educational institutions received optional training in the course "HIV: Faith, Tolerance, Hope".

● YOUR FAMILY DOCTOR

The **Your Family Doctor** brand is a long-term social campaign supporting medical reform and the institution of family doctors, which can establish communication of reform between doctors, patients and the state.

The goal is to introduce a new culture of health care in order to reduce the level of dangerous infectious diseases in Ukraine.

CO 100% Life became **a permanent member of Coalition PLUS**, the largest francophone NGO coalition, which operates in 50 countries and unites about 100 organizations. This gives us more opportunities to advocate globally for Ukraine's needs and attract additional resources.



The voice of patients was heard at the March **EU Conference (the EU Conference on the Future of Europe)**, where Dmytro Sherembey participated remotely and shared his experience of the first weeks of the Russian military aggression in Ukraine, how our reality changed and the efforts the organization made to help Ukrainian people.

In the summer, during the **AIDS2022 #IAS22** International Conference in Montreal, Canada, the Ukrainian delegation spoke on all its platforms, uniting the global donor, scientific communities and civil society. **THE IMPOSSIBLE**, a film we made specifically for AIDS2022 about the strength and courage of Ukrainian civil society, **was launched at a special meeting of donors supporting Ukraine. To date, the film has been nominated for a number of international festivals.**

In September, Valeria Rachynska, one of the film's characters, spoke at the meeting of the Global Fund to Fight HIV, Tuberculosis and Malaria (the **7th Replenishment Meeting, Global Fund**) in New York, USA; it was followed by a meeting of activists with the US Presidential Administration, where Valeria presented the needs of Ukrainian patients during the war.

During the **Fast-Track Cities 2022** conference in Seville, Spain, the CO 100% Life's delegation was recognized for its wartime humanitarian and healthcare efforts and awarded with the 2022 Community Leadership Award.

Immediately after the full-scale invasion began, we launched an additional project: <https://network.org.ua/donate-ua/> to raise funds around the world. These additional funds are used to help victims of occupation, hostilities, affected groups, doctors, hospitals, the Armed Forces of Ukraine, and others.

« In the difficult conditions of the beginning of the war, when shells flew overhead, and Russians were on the streets of Kyiv, our organization did not stop its activities for a moment, and taking into account the new challenges and needs of the war, on March 9, 2022, it concluded an agreement on the provision of financial services for the transfer of funds with ProfitGid LLC. Thanks to this cooperation and through the website of our organization <https://network.org.ua/>, it became possible to make an immediate charitable donation in USD, EUR, GBP, UAH," recalls Tetiana Niesternko, Chief Accountant of 100% Life. – "The charitable contribution sent by any philanthropist is transferred in the Platon electronic payment system, after which the contribution is credited to our hryvnia current account, which was opened specifically for this type of collection of charitable funds under martial law and the funds from which are used exclusively for needs related to the consequences of Russian aggression. »

On February 25, 2023, a meeting was held with 8 employees of the organization on the continuation of work in the time of war.

Many IDPs moved to Zakarpattia oblast, including HIV-positive people. The NGO provided assistance to almost 600 HIV-positive IDPs, in particular in obtaining medical services, finding accommodation and obtaining certificates for military conscription.

During the first two weeks of the war, Nova Poshta's ART shipments were suspended due to the closure of post offices. The NGO found a way out and transferred ART by interdistrict transport.

NGO employees were also actively engaged in volunteer activities, in particular, they helped the Armed Forces of Ukraine, the Territorial Defense Forces, people in the epicenter of hostilities, and IDPs in search of housing.

Since February 28, the NGO has been conducting registration/questionnaires of all HIV-positive IDPs temporarily registered with the MNE "ZOCPP" ZOR. Together with partners, the NGO continued to solve the problem of ART shortage, which was later completely solved thanks to the efforts of the NGO "100% Life".

Transcarpathian region is the safest region in Ukraine, which allows NGOs to continue to provide services and help anyone in need.

CHERKASY

With the beginning of the full-scale war, CO "100% Life of Cherkasy" did not stop its work for a day and quickly adapted to the requirements of martial law.

The main changes that have occurred in the activities of the CO:

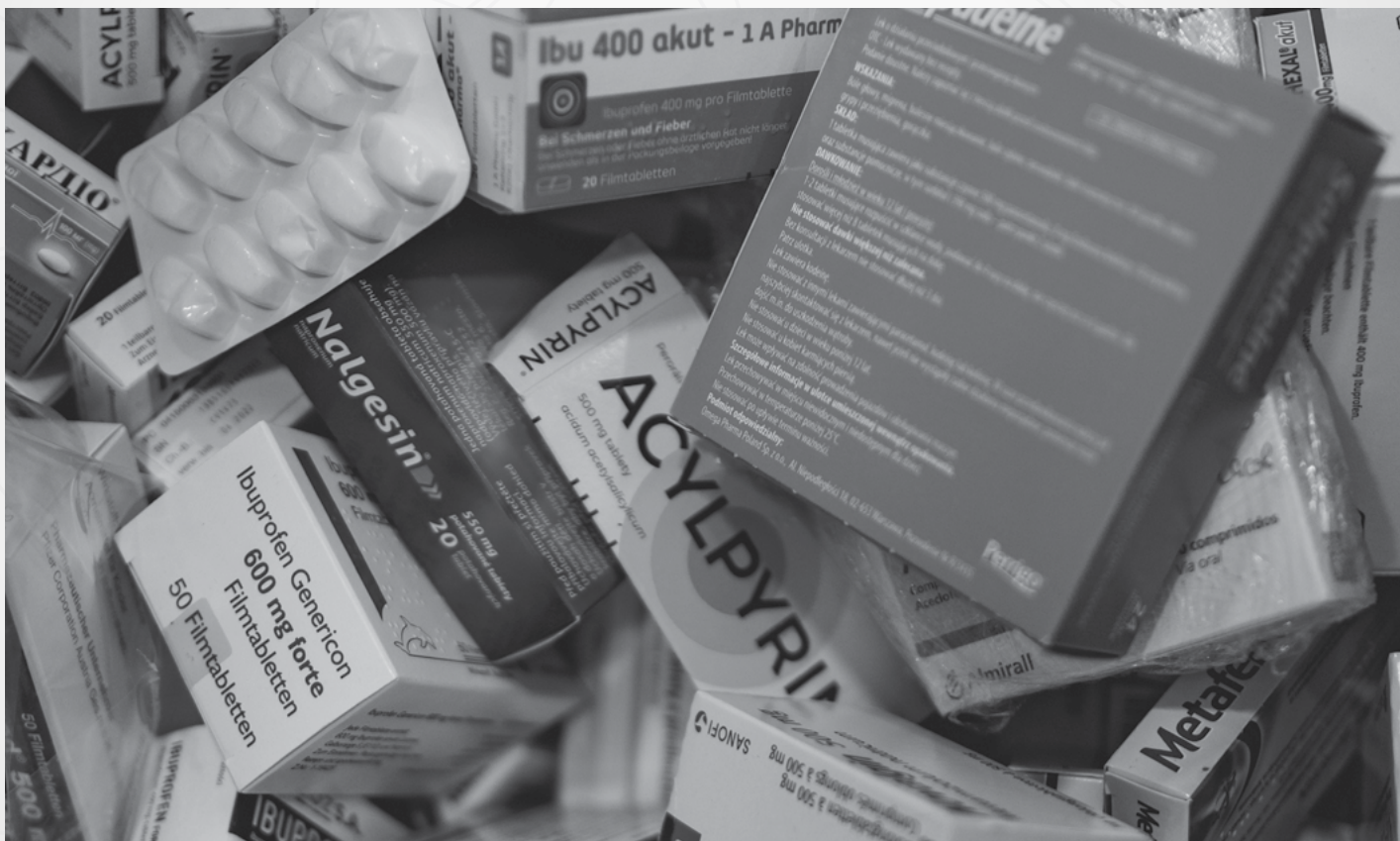
- Adapting crisis centers to the needs of IDPs. In the early days of the war, CO opened its crisis centers for temporary or transit IDPs.
- Strengthening communication with partners. CO successfully established and maintained effective links with its partners, which allowed it to increase humanitarian assistance and expand the geographical scope of its activities.
- Autonomy and resilience under duress. CO has developed a security and evacuation plan that has allowed it to become more adaptable to external risks and ensure smooth operations under martial law.
- Expanding the range of services. CO provides a wide range of services, including targeted assistance, social support, and material support to affected populations.
- Increased humanitarian assistance. CO delivered more than 100 tons of humanitarian aid to medical facilities and state penitentiary institutions in the Cherkasy region.
- Support for IDPs. More than 6,000 IDPs received targeted financial assistance and more than 9,000 received non-financial assistance, including social support, assistance in finding housing and restoring documents.
- Expanded outreach. CO transformed military centers into transit centers, allowing it to provide more effective assistance to military personnel and their families.
- Psychological assistance. CO provides psychological support to those affected by the war.

One of the stories of 2022:

At the beginning of the war in the Cherkassy region, there was an acute problem in supplying people with OST medicines. The balance was at a critical level, and supplies could only be replenished by deliveries from the Kyiv region.

The Vyshhorod district, where the warehouse was located, suffered from shelling. However, the employees of "100% Life of Cherkasy" were willing to take the risk of going there to get the medicines. As a result, patients of the OST program in Cherkasy region were provided with medicines for 3 months.

The successful drug delivery was made possible thanks to the coordinated work of the partners: Cherkasy Oblast Narcological Dispensary, Alliance for Public Health, 100% Life - Network of PLWH, and NGO Volna.

The full-scale Russian invasion of Ukraine has made changes in the activity of many organizations, including CO "100% Life of Ternopil".

From the very beginning of the war, the organization's employees decided not to leave the country and to continue their work to help people in need.

One of the most important challenges for the organization was to ensure the continuous treatment of HIV-positive people. To this end, "100% Life Ternopil", together with the staff of the AIDS Center and the Tuberculosis Clinic, traveled throughout the region and delivered medicines to patients using their own vehicles. In addition, the organization provided food kits to HIV-positive people who left the area of hostilities or were in transit abroad.

As a result of the united and coordinated actions of the employees of "100% Life of Ternopil", it was possible to provide continuous treatment of HIV-positive people during the war.

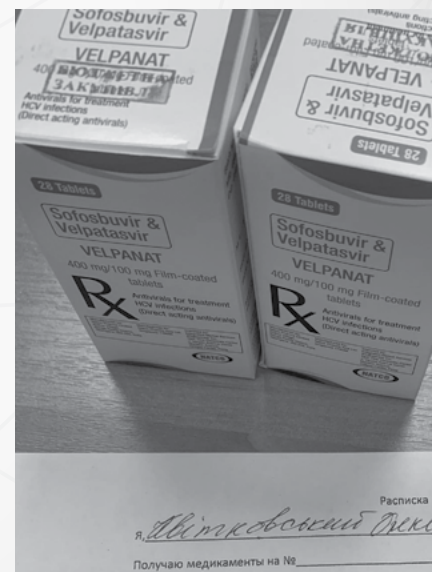
Despite the war, CO "LUGOT" NETWORK continued to provide assistance to the victims in the Luhansk region.

The organization provided humanitarian aid to the population remaining in the region, including food, hygiene products, medicines and other necessary items. It also provided medical care, including first aid and evacuation of the wounded.

One of the stories that became a symbol of the organization's commitment to its vocation occurred in March 2022. Despite the constant shelling and evacuation of medical facilities, CO "LUGOT" NETWORK managed to organize the distribution of OST drugs for patients receiving treatment in Rubizhne. This allowed them to receive the necessary medicines for the long term and to take advantage of the evacuation to receive further medical care.

● CO “One Hundred Percent of Life in Lviv”

From the first days of the war, a team of social workers helped infectious disease physicians treat people with HIV who had moved from the affected areas. During the first year of the war, more than 1,000 people received the necessary treatment.

The organization also set up a shelter for people fleeing the war zone. The premises were provided with the help of the Lviv Regional Military Administration, and beds, bedding, dishes and household appliances were also provided. Subsequently, a second shelter was opened with an area of 700 square meters, which accommodated more than 2,000 people.

In September 2022, the organization established the production at the Oversize garment manufacturing, employing more than 15 women from vulnerable groups, including IDPs.

It is important to note that in 2022-2023 the regional health programs in the Lviv region were not stopped. The amount of budget funds raised by the NGO “One Hundred Percent of Life in Lviv” to help representatives of key groups in 2023 is more than 4 million UAH.

One of the stories of 2022:

Charitable organization "One Hundred Percent of Life in Lviv" helped a family from Mariupol affected by the war.

A woman came to Lviv with two children in a very serious condition. The children were exhausted, sick and losing weight. They hid from the shelling in the Mariupol Drama Theater.

One day, during breakfast, the mother moved the breakfast plate closer to her son, which caused his strong reaction. The child was afraid that his food would be taken away from him, cried and kept asking if he would be able to eat again...

The mother said that her younger daughter miraculously survived when a wall pressed against her after shelling. The child was saved by folded blankets and bedspreads falling on her under the falling structure.

Charity workers helped the family adjust to their new life. They worked with a psychologist, and the father of the family came to them from Poland.

After a long stay in the shelter, the whole family moved to a separate house in the Cherkasy region, which was provided to them free of charge.

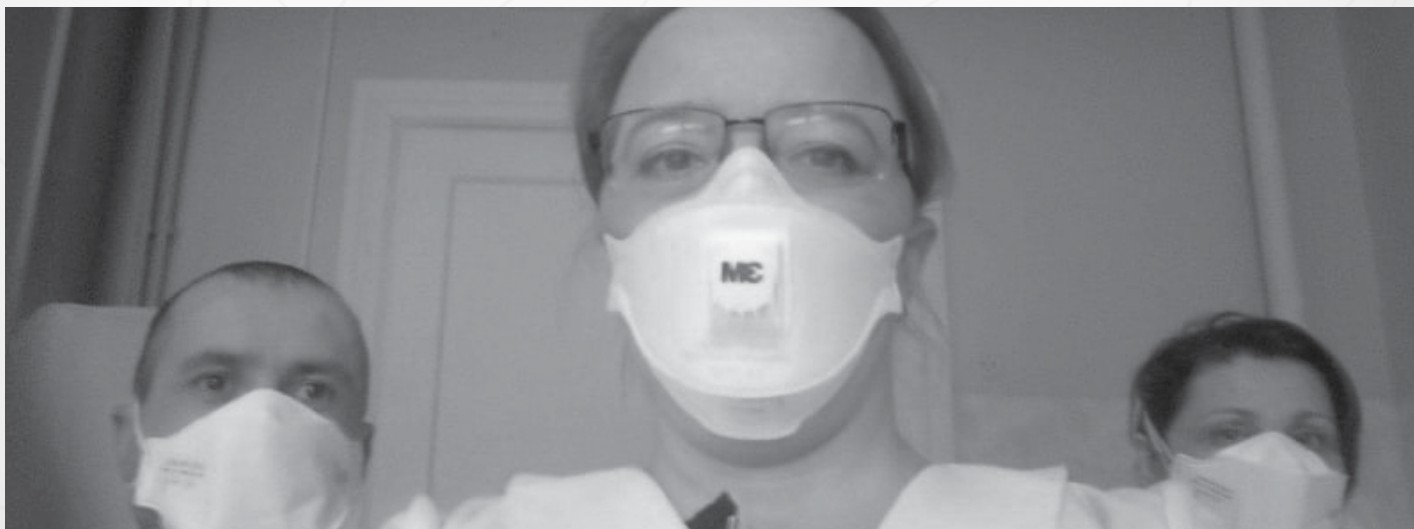

- During the war, the CO "100 percent life. Kropyvnytskyi" provided support to the fighters of the territorial unit, delivered food, drinking water to checkpoints, as well as medicines, personal protective equipment, clothing and basic necessities.
- In the first days of the full-scale invasion, the organization participated in the production of camouflage nets, cleaning of crusts and other assistance.
- The organization helps internally displaced persons, especially those with tuberculosis.
- Members of the organization also took part in visits to Kherson and Kharkiv regions.
- Charitable organization "100% LIFE. Kropyvnytskyi" continues to work in its main areas, in particular on the distribution of food kits to vulnerable groups, including IDPs.
- The organization has achieved good results in testing and identification of people with HIV. From February 2022 to September 2023, the project tested 3,935 people, detected HIV in 118 people, and started treatment in 112 people.



One of the stories of 2022:

The Stepanenko family (name changed) from the Kherson region did not want to evacuate until the last moment. They believed in the liberation of Kherson. However, on November 23, 2022, the shelling intensified and the family hardly waited for the morning. They left with all their neighbors, 9 of them in all.

In the Kirovohrad region, where their friends had already left, the village council assigned them a house. When they found a place to live, they took care of their health. TB was confirmed in her husband and her youngest daughter. "With my daughter, we saved as much as we could. She was still tiny. The maternity hospitals in the Kherson region had no vaccine, so she was not vaccinated. We waited, but there was no vaccine. Here, in the Kirovohrad region, we got a birth certificate for her. And got all the necessary tests," says Lida Stepanenko. The doctors prescribed treatment for tuberculosis.

The Stepanenko family asked the nonprofit organization "100 Percent Life. Kropyvnytskyi" for help, and they received social support.

Social worker Svitlana Demyanenko supported the family when they gave up. She repeated that tuberculosis is curable, the main thing is to continue treatment.

Charities also provided the family with food, clothes and educational toys.

Since the beginning of the full-scale invasion, many employees have changed, several specialists have been transferred to remote work, and requests for material assistance from customers have increased.

One of the stories of 2022:

In November 2022, the organization received humanitarian aid from the UN World Food Programme as part of the Food for Life project. However, due to the power outage, employees were unable to contact the driver, loaders, and logisticians to inform them of the cargo's arrival time.

When the truck with the humanitarian cargo finally arrived, it was already dark and it began to rain. The organization's workers were forced to unload the cargo in the dark. In addition, the humanitarian kits arrived in disassembled form, so they had to be packed.

The unloading took until 7:30 pm. The workers were tired and wet, but they did not give up. They understood that help is needed for people who need it.

The next day, when there was still no light, the workers continued their work. In all, they packed 1,700 humanitarian kits.

Since the first days of the war, the charitable organization “Network of 100% Life. Zaporizhzhya” did not stop its activities, on the contrary, it expanded them to help the victims of the hostilities in Ukraine.

Employees of the organization worked as volunteers in IDP reception centers, which received more than 213,000 people from different regions of Ukraine. They provided them with humanitarian aid, employment assistance and social protection.

The charitable organization “Network of 100% LIFE. Zaporizhzhya” also ensured the delivery of life-saving medicines for HIV and tuberculosis to the temporarily occupied territories as long as it was possible.

Charitable organization “Network of 100% LIFE. Zaporizhzhya” worked in the frontline areas, including the establishment of invincibility centers and shelters. It supported the health care system, which was under considerable strain as a result of the war.

In 2022 alone, the organization provided more than 3,000 tons of food to people in need.

One of the stories of 2022:

On the first day of Russia's full-scale invasion of Ukraine, Roman, an employee of the charitable organization “Network of 100 Percent Life Zaporizhzhya”, joined the Armed Forces of Ukraine. He decided that he could not stand aside and had to defend his country from the enemy.

A few days later, the organization was approached by a desperate man. He had only a few days of HIV medication left, and his village was on the front line and under constant fire.

When Roman heard about this, he could not remain indifferent. He contacted the organization's staff and agreed to help.

The staff of the organization received the necessary antiviral therapy at the AIDS Prevention and Control Department. They gave the medicine to the volunteer who delivered it to Roman.

The soldier sent the medicine to another volunteer, who delivered it to the village of Stepanohirsk in the Zaporizhzhya region and gave it to the man.

- **Sumy Oblast**

- **SOGO “Club “Chance”**

Sumy region was one of the first oblasts of Ukraine to face a full-scale Russian invasion in February 2022.

In these difficult conditions, the NGO “Club “Chance” continued to provide social and medical assistance to people living with tuberculosis and HIV.

Social workers of “Club “Chance” stayed in Sumy and continued to provide assistance to their clients undergoing TB treatment. They counseled them, distributed pills, and delivered food kits.

One of the organization’s clients, who was frightened and under acute stress, had a consultation with a psychologist.

As a result of the social workers’ efforts, none of the Club “Chance” clients who were being treated for tuberculosis dropped out of treatment.

Doctors and social workers working with HIV-infected people did not stop their work either. In difficult conditions they organized the continuous provision of antiretroviral therapy to clients and patients from Sumy and Sumy region.

This helped HIV-positive people to stay on treatment and maintain their health.

In April 2022, the Sumy region was de-occupied. However, people faced new challenges. Some businesses left, were destroyed or looted, food was not properly delivered, and residents were in a difficult financial situation.

In June 2022, Club “Chance” began to distribute humanitarian food aid from the UN World Food Program under the project “Food for Life” with the support of CO “100% of LIFE”.

In total, the organization delivered **64,620 food kits** to people from the most vulnerable groups.

At the same time, the Social Disease Prevention Program continued its work in the region. Initially, social workers distributed handouts from their homes and then began to go to stationary centers.

The mobile outpatient clinic of the “Club Chance” circulated in Symy, serving drug users in meeting places on the streets of the regional center.

In addition, the organization’s social workers continued to provide support to maintenance substitution treatment patients, informing them of new schedules for receiving drugs, referring them to OST sites in other regions, and giving them advice.



● Poltava Oblast

● “Light of Hope” Charity



Since the first day of Russia’s full-scale invasion of Ukraine, Light of Hope charitable organization has reformatted its work to provide assistance to internally displaced persons who came to Poltava region.

The organization immediately began to help evacuate the affected population. The social workers of “Light of Hope” redesigned the organization’s shelters and moved people from the frontline areas to them. Evacuation trips to the Polish border took place several times a week.

At the same time, Light of Hope operated five shelters for displaced persons. Together with partners, the organization also provided food and hygiene kits. It provided psychological, social and legal counseling.

People who are forced to leave their homes face many challenges, including integration in a new place. For this reason, Light of Hope, together with its partners, carried out a series of activities aimed not only at first aid, but also at the social integration of IDPs, in particular the development of self-employment.

One of the stories of 2022:

Together with its partners, Light of Hope organized evacuation trips from the Poltava region to the Polish border. During this time, almost 2,000 people were transported to safe places free of charge.

The passengers were people who were forced to leave their homes because of the war. They all have sad stories. Some had to evacuate twice, some could not persuade their relatives to evacuate and had to go alone, some spent a long time under occupation and only then were able to use this trip. Mothers were leaving with their infants, and families were leaving with their pets. All passengers understood the situation they were in and did not complain.

The passengers were grandmothers and grandchildren whose parents died during the shelling; neighbors who came from occupied Mariupol; spouses from Bakhmut who returned to their hometown and could not stand the shelling; residents of Kharkiv region who lived under occupation for six months.

All these people faced the war and had to leave their homes. They lost everything they had and started a new life from scratch.

Since the beginning of the full-scale war in Ukraine, the charity organization “100% Life Dnipro” has reformatted its work. The employees of the organization reassessed their values and realized that the most important thing is life and health. In times of war, HIV does not take a break, so it is important to continue testing even under the most difficult conditions.

The organization actively promoted HIV testing. They reminded society that testing should be done regularly, even during war.

In addition, the organization has found ways to operate during power outages, using backup power and communications to stay in touch with clients and provide support.

As a result of 100% Life Dnipro’s efforts, people living with HIV have been able to receive the medical care they need, even during the most difficult times.

One of the stories of 2022:

A prisoner with tuberculosis was injured as a result of a rocket attack in the Kharkiv colony. The man had a fracture of the surgical neck of the right hip.

The prisoner was taken to Dnipro penitentiary colony No. 89, where he was given an immobilizing cast and a recommendation to see a traumatologist and have the trauma treated.

In Dnipro, however, the prisoner received better medical care. Thanks to the joint work of the charity organization “100% Life of Dnipro”, the Department of Health of the Dnipropetrovsk Regional State Administration, the Department of Public Health of the Dnipro City Council and the MNE “MCLNo4” of the DMP, the convict underwent a complex operation, i.e. a total hip joint replacement.

After the operation the prisoner was able to take his first steps. He was the first prisoner to undergo such an operation.

- **CF "Let your heart beat"**

Immediately after the invasion, the organization opened a humanitarian headquarters that provided assistance to the Ukrainian Armed Forces, people affected by the occupation and hostilities, health care facilities and hospitals, dormitories and communities hosting IDPs. The organization also assisted in repairing and furnishing premises for IDPs.

The organization paid special attention to patients with HIV and tuberculosis. Despite constant air raids, the organization's social workers continued to deliver essential medicines to the districts of Ovruch, Korosten and Malyn, which at that time were the most affected by the war in the region. Medicines were also sent by mail, including abroad.



One of the stories of 2022:

Yuri is a middle-aged man living in the Zhytomyr region. He suffers from AIDS, tuberculosis and trophic ulcers. In peacetime, he hardly moved in his apartment, and under the conditions of the war, his condition deteriorated even more. He was condemned to weakness and loneliness.

But Rustam, a social worker from the Let Your Heart Beat Charitable Foundation, appeared in Yuri's life. Rustam was not afraid of difficulties and visited Yuri regularly, despite constant air raids and poor transportation.

Rustam told Yuri about the benefits of treatment, helped him with household chores, bought food and hygiene products. He became a true friend to Yuri.

Thanks to Rustam, Yuri's outlook on life changed. Yuri not only started taking ART, but also started TB therapy, which literally helped him get back on his feet. Now he can walk and even ride a bicycle, and his viral load has completely disappeared.

"Sometimes I wanted to stop everything without torturing myself or my mother... I did not see the point of continuing this life. I thought I was useless and I did not believe that some pills could help me, but Rustam was very persistent. For the first time in many years, I saw that someone cared about me. I felt not only support and care, but a real friendly shoulder. Rustam went this way with me, the way from the bed to the bike! This is incredible! I am very happy to have met him," says Yurii.
