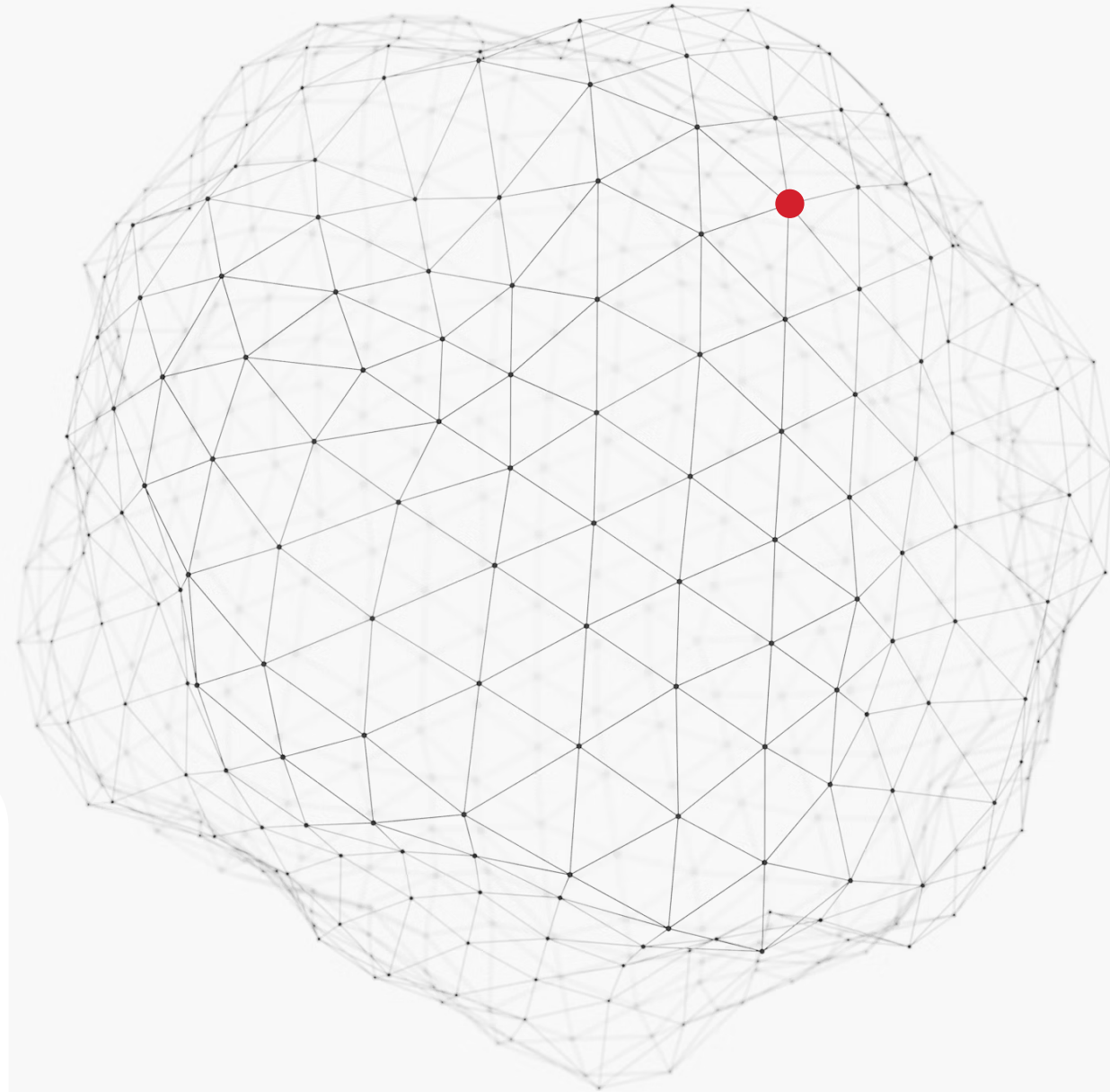

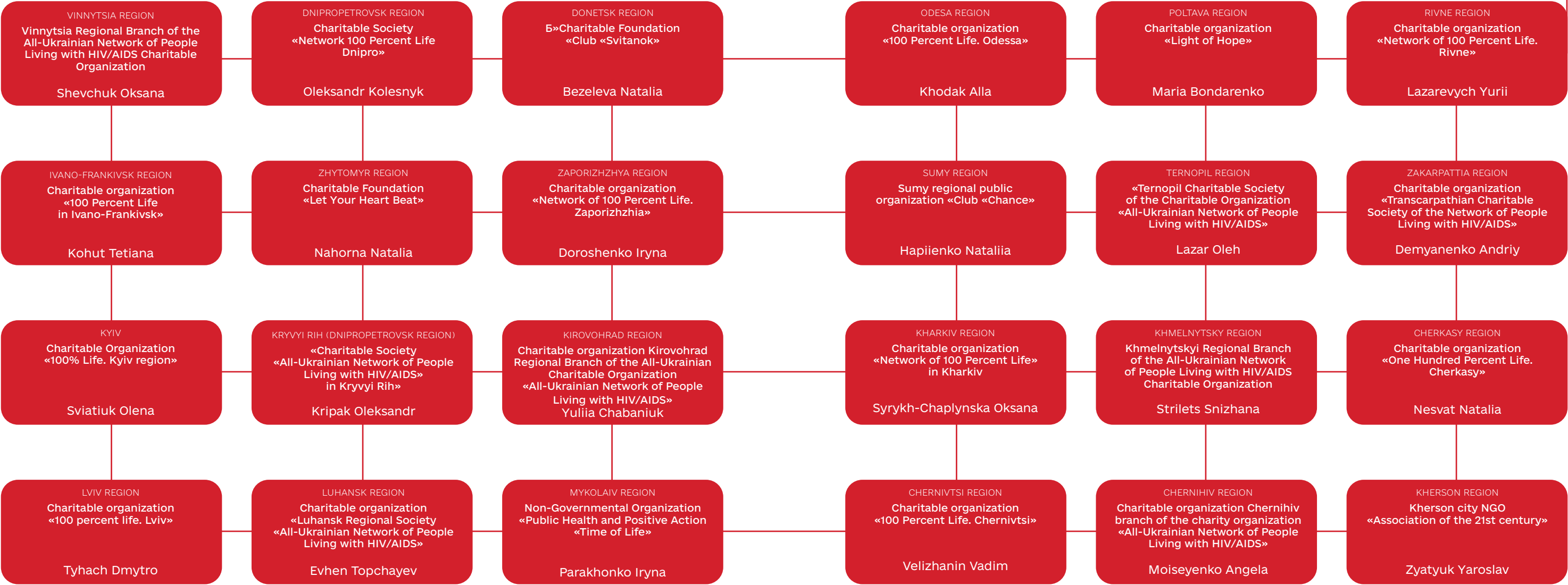

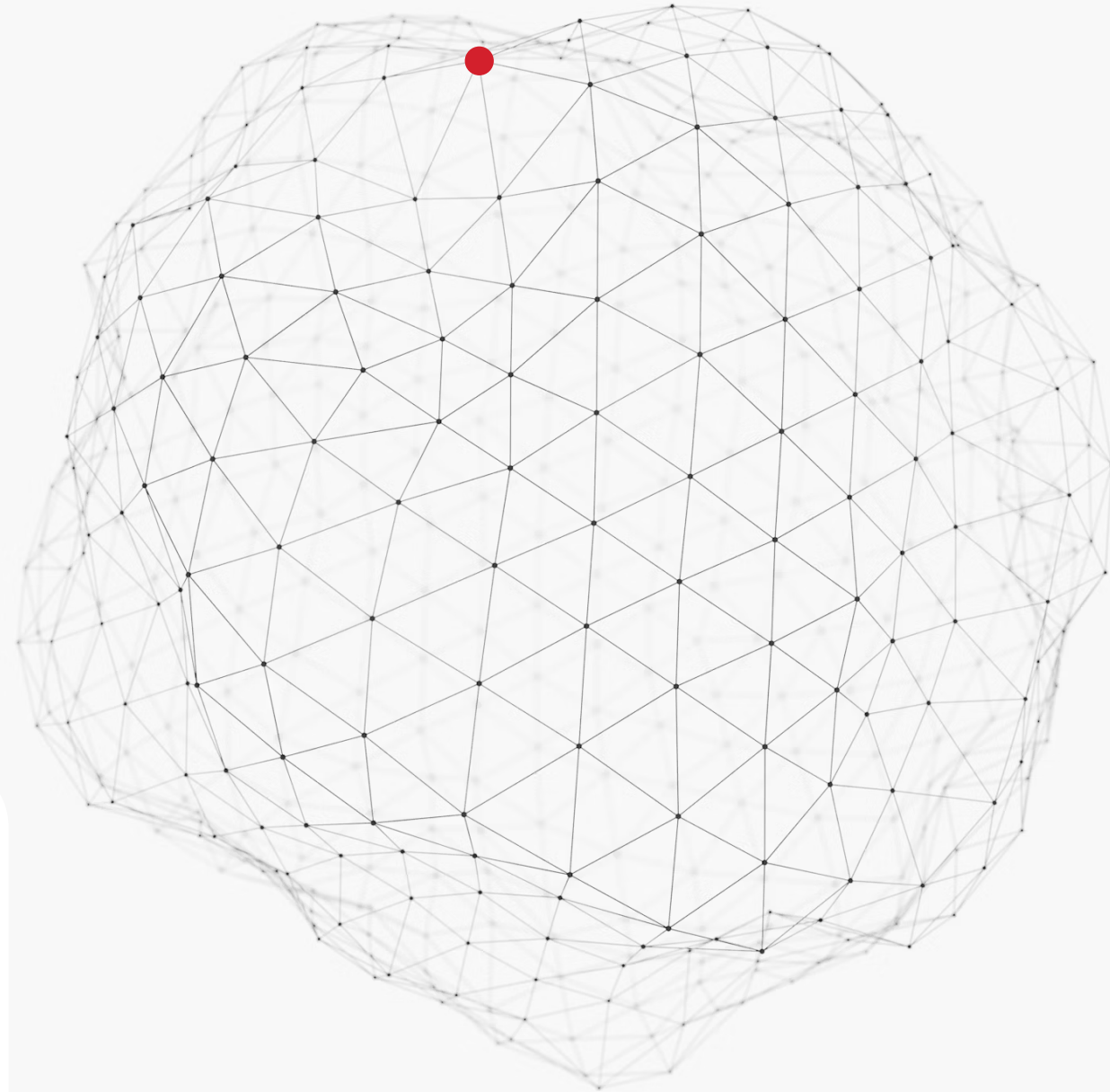

PROCUREMENT AND HUMANITARIAN AID

CO «100% Life» is one of the key partners of USAID and the Global Fund to Fight HIV/AIDS, Tuberculosis and Malaria in the procurement of goods and services

In 2024, «100% Life» supplied more than **USD 15,500,000** (approximately **UAH 621,800,000**) worth of medical supplies.



- More than 400 health care facilities and non-governmental organizations throughout Ukraine.
- Penitentiary institutions: medical supplies worth UAH 18,500,000, including X-ray machines with a tomography unit.
- The Armed Forces of Ukraine were provided with UAH 1,400,000 worth of medical supplies.

PROCUREMENT TRANSPARENCY AND CONTROL

- All procurement is carried out in accordance with donor agreed procedures and is subject to annual audits.
- Tenders are openly advertised on commercial websites, in particular through the Prozorro system, which ensures maximum competition and transparency of the process.

QUALITY CONTROL AND LOGISTICS

- Quality control is applied at all stages:
  - Selection of suppliers.
  - Delivery of medicines and medical devices.
  - Visual inspection of each package.
- Compliance with international quality standards (national, European, USA).
- Medicines and medical devices are stored in compliance with all necessary temperature and other conditions, and their movement can be tracked at each stage of delivery

NON-MEDICAL PRODUCTS:

UAH 86,500,000 is the total amount of procurement and supplies within the projects supported by USAID, GIZ, UNFPA, US CDC, Deloitte, OCHA, 5% by Expertise France.

- Furniture, children’s areas for hospitals, hardware, educational materials, household appliances to ensure the work of institutions.

UAH 417,600,000 is the total amount of food packages distributed under the UN World Food Programme.

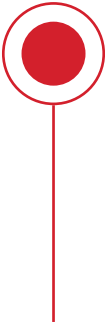

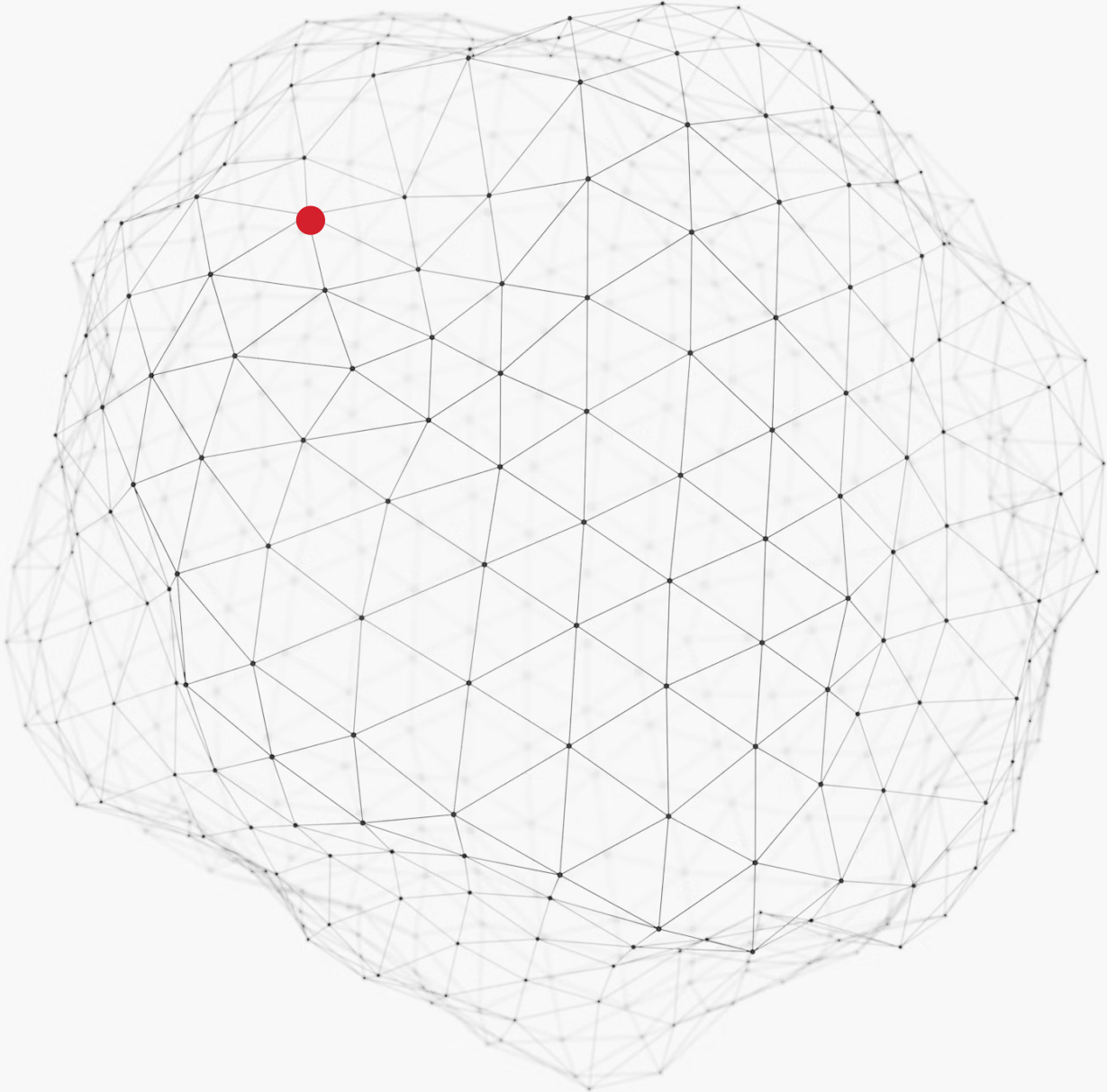

ADVOCACY

ADVOCACY IN THE PENITENTIARY SECTOR

- **Advocacy for new social services**
  - The procedure for testing algorithms for the implementation of social services of inpatient care for convicted persons who cannot take care of themselves.
  - Regulation «On the introduction and implementation of the pilot project».
  - Support of the initiative by the Ministry of Social Policy and approval of the «peer-to-peer» testing.
- **Assessment of stigma and discrimination**
  - Evidence base on discrimination against incarcerated and released people with TB, people living with HIV, and people from high-risk groups.
  - Action plan to reduce stigma and discrimination against vulnerable groups.
- **Monitoring of places of detention**
  - Checklists for assessing conditions in places of detention, which received a positive response from the Commissioner for Human Rights.
  - 40 monitoring visits to the Dnipropetrovsk, Cherkasy, Khmelnytskyi, Kharkiv, Zhytomyr, Chernihiv and Chernivtsi regions with the participation of the Monitoring Committees and the National Preventive Mechanism.
  - Information and analytical materials on the results of public oversight.

IMPROVEMENT OF THE SYSTEM OF FREE LEGAL AID (FLA)

- **Monitoring and improvement of the FLA system**
  - A draft concept for monitoring potential gaps in the FLA system in order to improve the provision of legal aid to key populations.
  - Conclusions and recommendations on the practical application and improvement of the Quality Standards for the provision of legal assistance in criminal, civil and administrative cases of clients belonging to HIV-vulnerable groups.
- **Requests for legal aid**
  - 3,007 requests from people of HIV-vulnerable groups through the FLA chatbot ([https://t.me/vulnerableua\\_bot](https://t.me/vulnerableua_bot)).
- 224 persons applied for further free secondary legal aid.
- **Training and professional development**
  - Training courses for lawyers, advocates, and paralegals are available on the FLA Distance Learning Platform.
  - 166 people were trained in 2024.
  - The mechanism for involving lawyers of the FLA system to work in the «DataCheck Ukraine» human rights module, which includes the procedure for involvement, organization of work, monitoring, evaluation and funding.

INTELLECTUAL PROPERTY

Within the framework of the Aidsfonds project «Brilliant (IP) Project» and Unitaid (ITPC) «Solidarity Project»

- **Key achievements:**
  - National Strategy for the Development of Intellectual Property until 2030
  - The Department of Intellectual Property and Pharmacy was created with the expert support of staff and consultants.
  - The Strategy has the most patient-friendly character in the history of strategies in the field of intellectual property of Ukraine.
- **Rilpivirine Patent Oppositions**
  - Opposition 1: HIV treatment or prevention with rilpivirine or its pharmaceutically acceptable salt in combination with hyaluronidase.
  - Opposition 2: Rylpivirine in pediatric form.
- **Suggestions on the draft Rules for the Examination of Applications for Inventions and Utility Models**
  - Developed by staff and consultants.
  - Included in the Rules approved by the Order of the Ministry of Economy dated 09 Sep 2024 No. 23301.
  - Requires significant changes in the therapeutic effect to be taken into account when patenting new forms of already known drugs.
  - Aimed at improving the quality of patent examination and combating the practice of #stopevergreeningpatents.



ADVOCACY AT THE LOCAL LEVEL

➤ **Funding of adaptive milk formulas for children born to HIV-positive mothers**

- Chernihiv region: 665 packages worth of UAH 198,702 from the regional budget.
- Lviv region: planned funding of UAH 1,000,000 for 2025.

➤ **Financial support for social services**

- Chernivtsi region: UAH 142,500 for social services for HIV-exposed children in need of correction of deviant behavior.

➤ **Continued use of municipal property**

- Integrated Center in Chernivtsi region: prolongation of preferential use of the premises of 125.6 m<sup>2</sup> for 5 years.
- The cost of rent is 1% of the estimated value of the premises (UAH 1,019,200).

➤ **Funding of social services in the Lviv region for 2025**

- Total of UAH 4,100,000 for PLHIV and IDPs from vulnerable groups, in particular:
- UAH 700,000 for social services for OST patients.
- UAH 550,000 for social services for HIV-positive people.
- UAH 800,000 for social services for people with tuberculosis.
- UAH 100,000 for medical and social support for vulnerable groups (TB patients at risk of treatment interruption) through a mobile outpatient clinic.
- UAH 1,000,000 to ensure the functioning of a shelter for IDPs from vulnerable groups.

- Result: Proposals submitted to the Ministry of Health.

➤ **Cooperation with government agencies**

- Participation in meetings of the competition commission for the implementation of a vitality pilot project.
- Participation in the meetings of the working group of the Public Health Center to ensure the sustainability of HIV services.
- Result: Proposals prepared for the group's work plan for the second half of 2024.

➤ **Regulatory amendments**

- Preparation of amendments to the Procedure for the use of budget funds for public health programs.
- Updating the criteria for providing care and support services to people living with HIV.
- Updating the requirements for service providers who may participate in tenders.
  - Result: The proposal to include a mandatory requirement for 2 years of experience in the field of treatment and care was supported by the Ministry of Health. Other changes are being developed with the CPH.

➤ **Initiatives in healthcare**

- Advocacy for the adoption in the first reading of the Law «On Self-Government in the Field of Health Care».
- Establishment of 20 Supervisory Boards at health care institutions in five regions of Ukraine.
  - Result: Representatives of the patient community have an influence on the decision-making of institutions.
- Establishment of the National Council on Sexual and Reproductive Health under the Ministry of Health.
  - Result: Increased attention to SRH issues, especially for women living with HIV.

➤ **Monitoring treatment provision**

- Monitoring the availability of medicines and diagnostic tools for HIV, viral hepatitis and tuberculosis.
- Advocacy to address the shortage of medicines for viral hepatitis.
  - Result: Accelerated deliveries through international procurement under the control of the Ministry of Health.
- Making changes to the National Vaccination Calendar.
  - Result: HPV vaccination for HIV-positive girls aged 9 years and older is funded from the national budget.

➤ **Inclusion of NAMS institutions into the system of medical guarantees**

- Advocacy for the inclusion of NAMS institutions in the funding through the NHSU.
- Approval of the relevant Resolution of the Cabinet of Ministers of Ukraine No. 1295 dated 12 Nov 2024.
  - Result: As of 2025, NAMS institutions will operate under the Medical Guarantees Program.

ADVOCY FOR ACCESS TO TREATMENT AT THE NATIONAL LEVEL

➤ **Legal analysis and advocacy**

- Analysis of the draft resolution of the Cabinet of Ministers of Ukraine on changes in the licensing conditions for the activities of pharmaceutical companies.
- Preparation of an advocacy appeal to the Verkhovna Rada Committee on National Health and the Ministry of Health.
  - Result: Patients' interests were taken into account when the draft resolution was finalized.
- Participation in the public discussion of the amendments to the procedure for the use of budget funds of the «Public Health and Epidemic Control Measures» program.

IMPROVING SUPPLY CHAINS IN WARTIME

➤ **Advocacy & Regulatory Change**

- Development of procedures for transferring humanitarian aid to other recipients in agreement with the recipient.
- Establishment of the mechanism for returning humanitarian aid to the donor if it cannot be used for its intended purpose.
- Implementation of amendments to the Law of Ukraine «On Humanitarian Aid».
  - Result: Clear procedures for the management of humanitarian aid are ensured, which contributes to its effective distribution in times of war.

ADVOCACY IN EECA: DECRIMINALIZATION OF PLHIV

CO «100% Life» conducted advocacy activities to reduce the criminalization of PLHIV in Kazakhstan, Georgia, Uzbekistan and Kyrgyzstan.

The activities were carried out as part of the SoS 2.0 project. «Sustainability of services for key populations in the EECA region» with the support from the Global Fund and in partnership with the ICF «Alliance for Public Health».

UZBEKISTAN

What was done:

- An advocacy campaign to amend Article 113 of the Criminal Code was conducted (May–September 2024).
- Consultations were held with government bodies, NGOs and international experts, including UNAIDS.
- A working group consisting of representatives of State bodies, public organizations, lawyers and experts was established.
- Draft amendments to Article 113 of the Criminal Code were prepared, taking into account international experience and the recommendations of WHO and UNAIDS.
- Agreements have been reached with the authorities on the consideration of the project.

Achievements:

- The project was officially submitted to the Oliy Majilis in September 2024.
- The Oliy Majilis approved the draft for consideration at the level of the Legislative Chamber.

KYRGYZSTAN

What was done:

- Amendments to the Resolution of the Government of the Kyrgyz Republic No. 583 on the confidentiality of information about PLHIV were initiated.
- On June 26, 2024, a new draft resolution was submitted for public discussion.
- On October 3, 2024, the final draft of the resolution was received by the Ministry of Health of the Kyrgyz Republic.
- In October 2024, the Ministry of Health of the Kyrgyz Republic submitted the draft resolution to the Cabinet of Ministers of the Kyrgyz Republic for approval.

Achievements:

- On November 1, 2024, the Cabinet of Ministers of the Kyrgyz Republic approved a new «Procedure for Monitoring, Accounting and Reporting of Infectious Diseases,» which came into effect 10 days after its official publication.
- The amendments ensure the confidentiality of PLHIV and reduce discrimination and the risk of criminalization.

These advocacy initiatives contribute to the decriminalization of PLHIV and the protection of their rights in the EECA region.

OPTIMIZATION OF NATIONAL HIV TREATMENT AND TESTING STRATEGIES

Based on national HIV testing strategies and updated WHO recommendations on ART, regulatory documents were developed and advocated in four EECA countries: Armenia, Kazakhstan, Moldova and Kyrgyzstan.

ARMENIA

Achievements:

- The Ministry of Health adopted Order No. 6241-L (13 Nov 2024) on the implementation of the clinical protocol «Pre-exposure prophylaxis of HIV infection».
- A study was conducted on the causes of ARV drug interruptions among HIV-infected persons, and recommendations were made to the Ministry of Health and the National Center for Infectious Diseases.
- A review of the clinical guidelines for HIV testing, counselling and laboratory diagnosis was initiated and is expected to be completed in early 2025.
- The implementation of decentralized services for the provision of ARV drugs in the Lori and Ararat regions continued, with the introduction of remote treatment expected in 2025.

KAZAKHSTAN

Achievements:

- The Ministry of Health adopted Order No. 774 (08 Nov 2024), which updates the roadmap for HIV prevention for 2025–2026, including:
  - Changes in the standard of medical and social care (implementation of OMT in hospitals in the 3rd quarter of 2026).
  - Update of clinical protocols on HIV in adults, children and HIV/TB infection (Q4 2025).
- Advocacy for amendments to the HIV Code of the Republic of Kazakhstan, including new testing methods and the replacement of stigmatizing terms.
- The Ministry of Health adopted Order No. 29 (24 Jun 2024), which updates the rules for investigating HIV cases.
- The Ministry of Health adopted Order No. 55 (11 Jul 2024), which expands the list of key populations (including transgender people and people from prisons) and increases the distribution of condoms and syringes by 20%.

KYRGYZSTAN

- **Achievements:**
- A government decree was adopted that regulates:
    - Free HIV and viral hepatitis screening.
    - Mandatory medical examination for HIV and viral hepatitis for certain professional professions.
    - The procedure for testing and examination of foreigners and stateless persons.
    - Social support for PLHIV and their families.
  - Technical assistance was provided for the development of regulations, in particular the approval of the list of socially significant diseases.
  - Technical assistance was provided to the government to develop regulations on HIV and drug trafficking, which strengthened the implementation of the national strategy.

MOLDOVA

- **Achievements:**
- The National Clinical Protocol «Treatment of Viral Hepatitis C in Adults» was developed and approved.
  - The development and discussion of the National Clinical Protocol «Pre-exposure prophylaxis of HIV infection (PrEP)» was completed, and its approval is expected in early 2025.
  - Recommendations were prepared to improve the draft document «Management of cardiovascular risk in people living with HIV».
  - Recommendations were made to update National Clinical Protocol No. 316 «Prevention of HIV Transmission from Mother to Fetus».

Optimizing national strategies in these countries is helping to increase access to treatment, improve diagnosis and increase the effectiveness of HIV prevention.

IMPROVEMENT OF SUPPLY CHAIN SYSTEMS

- Technical assistance was provided to the countries of the EECA region to improve drug supply mechanisms:
  - Armenia – Established a mechanism to reimburse the population for the cost of medicines.
  - Georgia – Improving the mechanism for importing unregistered medicines.
  - Kazakhstan – Improving the mechanism for implementing long-term contracts for the purchase of medicines and involving NGOs in the procurement process.

OTHER AREAS

- **TB stigma assessment in Ukraine**
- The second study was conducted with the participation of 866 people, including people with TB, their relatives, community representatives and health workers.
  - Conclusions and recommendations were developed.
  - The research report was transferred to partner organizations, posted on Internet resources and social media and presented to international partners.
- **Revision of services for people with TB**
- The revision of the cost of services and the terms of agreements with NGOs (new tariffs are under consideration) has been updated.
  - The agreements for 2025 include the possibility of prepayment to non-government organizations for the quality service delivery.
  - The process of reviewing the cost and scope of services has begun and is expected to be completed in 2025.

These initiatives will help improve access to medicines and improving support mechanisms for TB patients in the EECA region.







ADVOCACY AND HUMAN RIGHTS ACTIVITIES

# Human rights activities: the «100% LIFE» project and the Ukrainian Helsinki Human Rights Union

The project provides free legal aid in the form of consultations, pre-trial support and strategic cases before national courts and the ECHR.

## RESULTS OF 2024

- 1,243 legal consultations – the achievement of the indicator was at 124%.
- 57 pre-trial cases, of which 45 were resolved in favor of clients – the success indicator was at 180%.
- 424 informational messages through the legal chatbot «Legalbot 100% LIFE».
- 37 strategic cases:
  - 24 in national courts.
  - 13 in the ECHR proceedings (instead of the planned 10 cases).
  - 3 strategic cases won in national courts.



## WINNING STRATEGIC CASES

- **The right to use cannabinoids for medical purposes**
  - The client was fined UAH 17,000 for using cannabis for medical purposes on the territory of a military unit.
  - Thanks to the lawyer's defense, the Court of Appeal cancelled the fine and closed the proceedings.
- **Tuberculosis due to military service**
  - The attorney proved the connection between the client's TB disease and the defense of the Motherland.
  - The resulting decision of the medical commission allows the client to regularize the disability and receive proper cash payments.
- **Return of the child to the HIV-positive mother**
  - The child was seized without due cause while the case for deprivation of parental rights was pending in Mariupol.
  - The lawyer obtained a court decision to return the child to the mother, despite the loss of court materials due to the occupation.
  - The court decision ensured the mother's reunification with her daughter, who had traveled to Switzerland with an orphanage after the outbreak of hostilities.

The «100% LIFE» project and UHHRU continue to protect the rights of the most vulnerable groups, and provide them with access to justice.

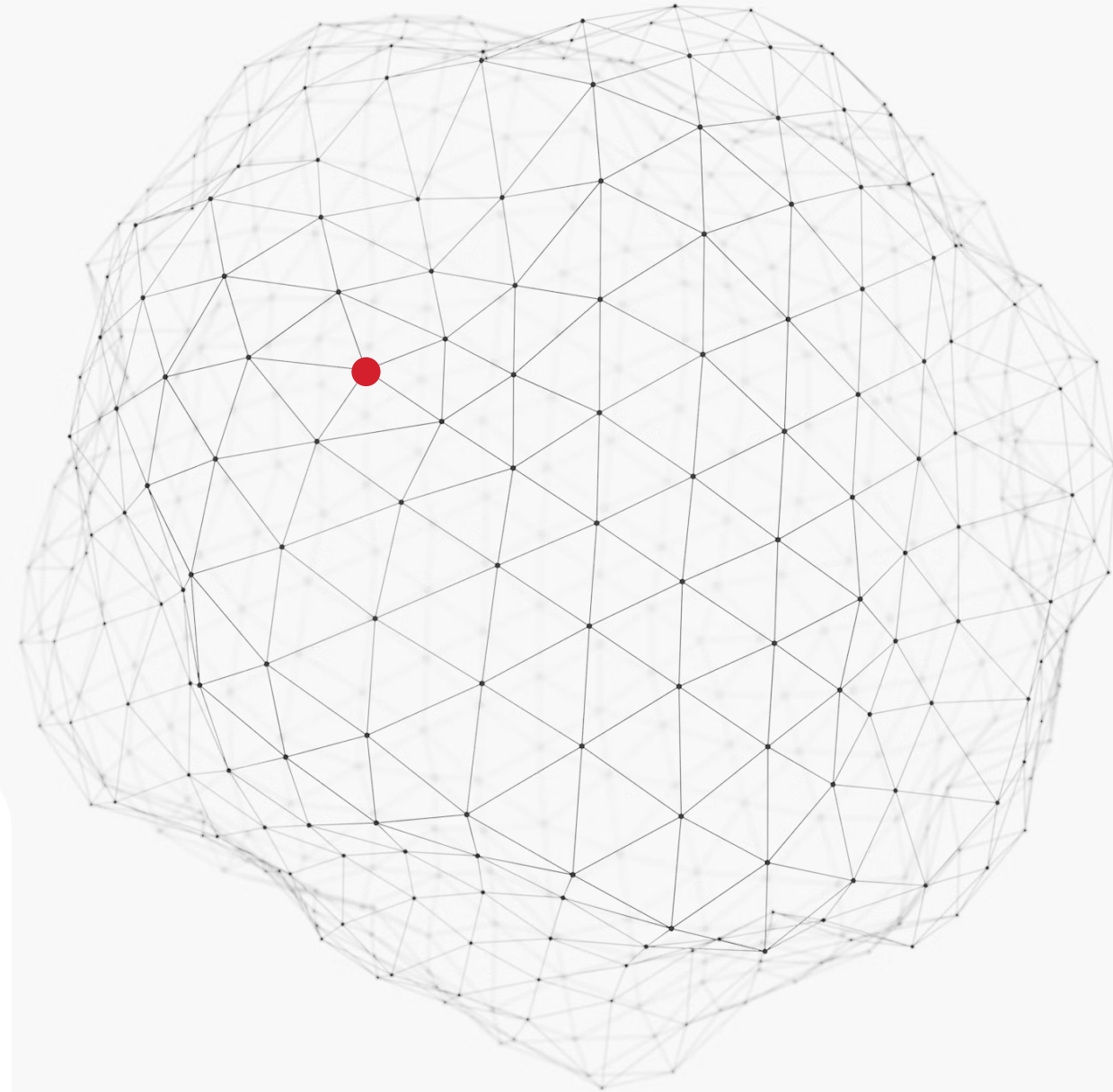

# Legislation and protection of rights

The results of the legislative and advocacy activities of the expert platform «Struggle for Health» in 2024

## WHAT HAS BEEN DONE:

- **Support for the decriminalization of HIV**
  - Advocacy of the Draft Law No.9398 on the abolition of criminal liability for unintentional HIV infection.
  - Result: The Verkhovna Rada supported the draft law and recommended it for adoption.
- **Simplification of the importation and accounting of humanitarian aid**
  - Proposals to the Law of Ukraine on humanitarian assistance were developed and submitted.
  - Result: The law came into force on 23 Jan 2024, the issue of import and accounting of humanitarian aid was settled.
- **Combating Torture**
  - Draft law No.12319 on strengthening responsibility for torture was prepared.
  - Result: The document was submitted to the Verkhovna Rada for further consideration.
- **Expanding access to cannabis-based medicines**
  - Draft regulations were prepared to ensure access to treatment for people living with HIV and TB patients.
  - Result: The Law on State Regulation of Hemp Sales entered into force on 16 Feb 2024.
- **Preventing abuse during pregnancy and childbirth**
  - The maternity protection regulation was developed and agreed with obstetrician-gynecologists.
  - A National Dialogue on the implementation of bioethical standards in the field of health care was held.
  - Result: Advocacy for the document among key stakeholders.

- **Protecting key groups from discrimination**
  - Legislation on the liability of OnlyFans models was consulted and proposals were developed to eliminate the risk of criminal prosecution.
  - Result: Advocacy with MPs and the BRDO office on amendments to the legislation.
- **Regulation of civil partnership**
  - A Draft Law on Registered Civil Partnership has been prepared.
  - Result: The document was submitted to the National LGBTI Consortium for consideration.
- **Protection of the rights of HIV-positive conscripts**
  - Amendments to the Order of the Ministry of Defense of Ukraine No.402 and the law «On conscription training and conscription» were prepared.
  - An official request was sent to the Ministry of Defense regarding unlawful actions of conscription centers.
  - Meetings were held with deputies of the Verkhovna Rada and the Deputy Minister of Defense.
  - Result:
    - It is planned to establish permanent communication with the Ministry of Defense, for
      - accompanying and monitoring the distribution of PLHIV in non-combat units.
    - Ensuring uninterrupted access to ART.
    - Informing military units about services for PLHIV.
    - Protection of the rights of illegally conscripted people of key populations.

## ASSESSMENT OF BARRIERS TO THE PROTECTION OF THE RIGHTS OF KEY POPULATIONS

- 484 representatives of PLHIV, PLHIV, MSM, ex-prisoners, transgender people were involved in the assessment of barriers to the protection of their rights during mobilization.
  - National community organizations are actively involved in the assessment.
- RESULTS:**
- 44.1% of respondents faced violations of their rights due to belonging to key groups.
  - 31.2% of ART/OST recipients avoided visiting the centers for fear of being detained by conscription center representatives.
  - 39.3% of participants in prevention programs refused to participate due to fear of being detained.
  - 60.9% of conscripts did not have control over their health during their service.
  - 45.7% of conscripts faced stigmatization and discrimination due to belonging to key groups.



**PARALEGAL SUPPORT TO KEY POPULATIONS AND PATIENT COMMUNITIES**

- 346 paralegals were registered in the DataCheck human rights module.
  - 119 paralegals provided support during 2024.
  - 6,135 complaints of rights violations were registered, of which 5,536 required the assistance of paralegals.
  - Paralegals successfully resolved 5,138 complaints.
  - Advice was provided to paralegals through the Paralegal Hub to improve the efficiency of recording violations and improve the quality of data.
  - An analysis of complaints about violations of the rights of key communities in 2024 was prepared and published.
- Result: The capacity of paralegals to respond to rights violations was strengthened and the quality of documentation of such cases was improved.

**PARTICIPATION IN GLOBAL INITIATIVES**

- A report on the results of monitoring the implementation of Ukraine’s commitments under the Global Partnership to Overcome All Forms of HIV-Related Stigma and Discrimination was prepared.
  - A Roadmap for the implementation of the Global Partnership was developed.
  - The work of the national group on the Global Partnership was resumed.
- Result: Ukraine resumed active participation in the Global Partnership and received tools to continue overcoming stigma and discrimination.
- These initiatives are strengthening legal protection for vulnerable populations and improving health care legislation.

# Community capacity building

## MEN WHO HAVE SEX WITH MEN (MSM)

NGO «ALLIANCE.GLOBAL»

- **Advocacy for the expansion of prevention services and guarantees of non-discrimination:**
  - The Code of Judicial Ethics included a direct requirement to prevent discrimination on the basis of SOGI.
  - The procedure for the provision of services military personnel prohibits discrimination on the basis of gender identity, sexual orientation and HIV status.
  - The Ministry of Health's procedures for HIV prevention among key populations and for care and support of PLHIV included the principle of non-discrimination on the basis of SOGI.
- **Conducting the XVII National LGBTI Conference:**
  - Approximately 150 participants attended.
  - Result: A roadmap for ensuring LGBTIQ+ rights and freedoms by 2025 was developed.
- **Work at the local level:**
  - 934 communication and mobilization events were held in 8 regions.
  - 3 webinars were held for 70 participants (mental health, countering gender-based violence, cybersecurity).



## SEX WORKERS (SW)

CO «Legalife-Ukraine»

- **Activities of initiative groups:**
  - There are 16 active initiative groups.
  - 867 communication and consultation meetings were held.
- **Participation in national activities:**
  - The VII Conference of Sex Workers was held with a focus on the decriminalization of sex work.
  - A round table was held to discuss the concept of the reform to decriminalize sex work.
- **Human rights monitoring:**
  - A study was conducted on the impact of Martial Law on the rights of sex workers.
- **Operation of the National Hotline for Sex Workers:**
  - 3,632 consultations, including:
    - 424 psychological
    - 344 legal
    - 1,478 peer-to-peer
  - 1,386 referrals to other organizations and specialists were made.

## ADOLESCENTS LIVING WITH HIV

NGO «Adolescents of Ukraine»

- **Hub work:**
  - There were 3 inclusive hubs (Kyiv, Dnipro, Odesa) and 4 representative offices.
- **A forum for adolescents living with HIV was held.**
- **Communication campaigns:**
  - For World AIDS Remembrance Day, 2 videos «My Love+» and «My Life+» were developed to reduce stigma and discrimination against children and adolescents living with HIV.
  - An online game was held for the World AIDS Day (536 participants).





PEOPLE WHO USE DRUGS (PWD)

CO «VOLNA»

- **Work in the regions:**
  - Representatives of CO «VOLNA» worked in 24 regions.
  - Supported the activities of 5 regional centers.
  - Result: According to the results of the performance evaluation, all centers received scores above 4.
- **The efficiency analysis included an assessment of:**
  - Advocacy by the centers and regional representatives.
  - Implementation of community-led monitoring (CLM).
  - Recording violations of the rights of IDUs in the DataCheck system.
  - Obtaining additional funding for the needs of IDUs.
- Coordination and involvement of regional representatives in the work of the centers.
  - Representation in the information space and participation in events.
- **Involvement in treatment:**
  - 400 new clients are involved in OST treatment programs.
- **Extension of services:**
  - Additional funding was involved and technical assistance was provided in the organization of OST and other services.
  - 4 new OST rooms and additional services were organized: in Kyiv, Kozelets and Vorzel
- **Result: New services were introduced and partnerships expanded to increase access to OST.**

COMMUNITY OF PRISONERS AND EX-PRISONERS

CO «FREE ZONE»

- **Participation in coordination mechanisms:**
  - 13 community representatives are involved in 13 regions: Lviv, Chernivtsi, Rivne, Zhytomyr, Cherkasy, Kirovohrad, Mykolaiv, Sumy, Poltava, Chernihiv, Vinnytsia regions and Kyiv.
  - Letters of engagement were submitted in 3 more regions: Dnipropetrovsk, Kharkiv and Odesa regions.
- **Funding:**
  - UAH 14,007,687 was collected for medical and social needs of community representatives (UAH 13,865,187 from donors, UAH 142,500 from the budget).
- **Modeling:**
  - A model of activity of municipal penitentiary institutions was developed.
- **Participation in national processes:**
  - Community representatives participated in meetings of the National Council on TB/HIV and in the working group on services in prisons.
- **Evaluation of services:**
  - A supported survey was conducted in 13 regions through the FREE LIFE application.

WOMEN LIVING WITH HIV

CO «Positive Women»

- **Working with needs:**
  - Mutual support groups are active in all regions.
  - Women's needs related to gender-based violence and barriers to HIV/TB services are continually assessed.
- **Advocacy for participation:**
  - 3 community representatives joined regional groups to eliminate mother-to-child transmission of HIV.
- **Updating plans:**
  - Updated human rights and gender equality roadmaps in 20 regions.
- **Financing of infant formula:**
  - In 2024, funding was allocated from local budgets in 10 regions: Mykolaiv, Poltava, Kramatorsk, Lviv, Ivano-Frankivsk, Khmelnytskyi, Kharkiv, Kherson, Chernihiv, and Vinnytsia.
- The total amount is UAH 2,721,857.
  - Humanitarian aid was provided in the amount of UAH 976,590.
  - In 2025, funding is provided for the purchase of infant formula in the following regions:
    - Vinnytsia – UAH 567,000
    - Lutsk – UAH 345,620
    - Poltava – UAH 49,377
    - Kherson – UAH 7,200
    - Ivano-Frankivsk – UAH 125,460
    - Kharkiv – UAH 198,000
    - Mykolaiv – UAH 765,200
    - Chernihiv – UAH 520,000
    - Khmelnytskyi – UAH 144,000 (through the territorial community).

RELIGIOUS COMMUNITY

Organization ELEOS - UKRAINE

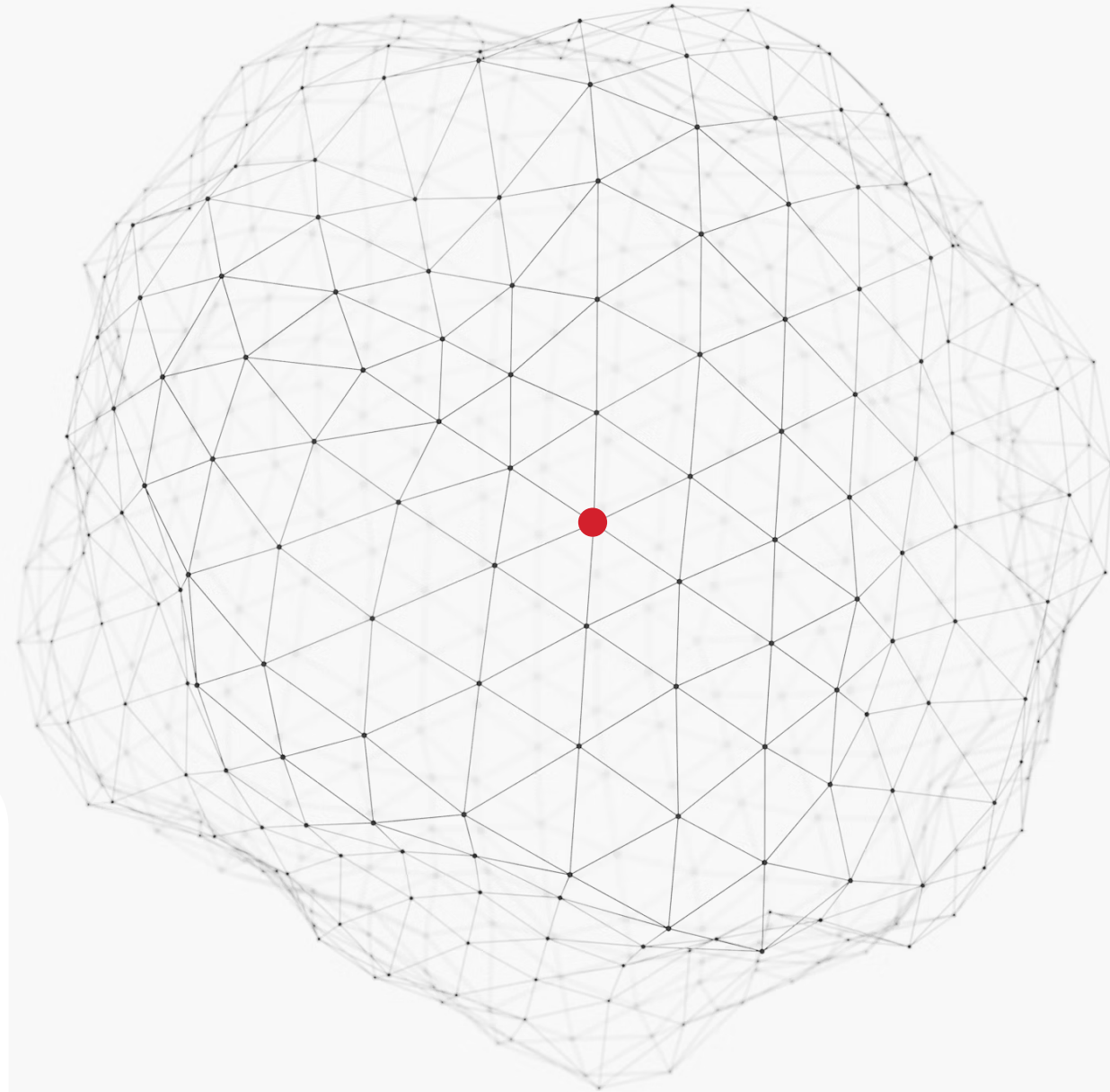
- **Communication meetings:**
  - 1,082 representatives of churches, religious organizations, chaplains, key groups, IDPs, volunteers and social workers participated in training sessions.
- **Student training:**
  - 40 students from theological educational institutions received training on HIV, tuberculosis, hepatitis and overcoming stigma.
- **Consultations:**
  - 5 consultations for 21 representatives of churches and religious organizations from regional coordinating councils.
- **Common Position:**
  - A common position of churches and religious organizations of Ukraine on overcoming stigma and discrimination of vulnerable KGs and PLHIV was developed and published.
- **Preparation of chaplains:**
  - 50 military chaplains were trained and supervised.
- **Result: Increased attention to PLHIV issues by the Medical Service of the Armed Forces of Ukraine, increased access to testing and prevention for the military.**

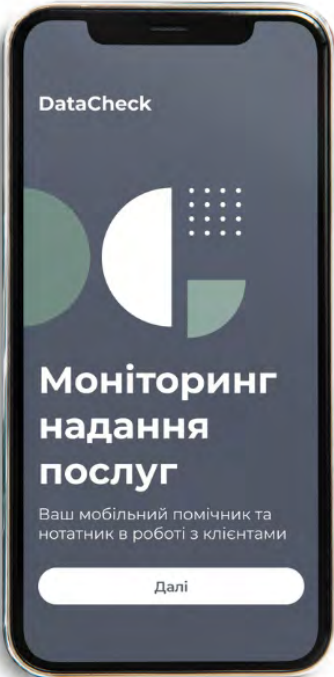

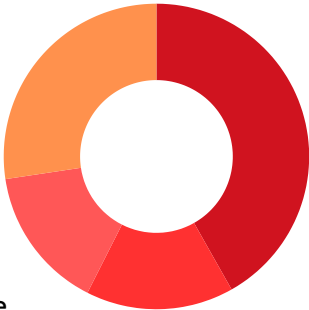
CONNECTION AND TRAINING OF ORGANIZATIONS

- 52 organizations are connected and trained.
- 36 organizations have been working with the system on an ongoing basis since January 1, 2024.
- 5,146 consultants have gained access to the service component, about 955 specialists work monthly.
- The appeals and complaints module is working in 7 organizations, 133 paralegals are registered in the system.

PROVISION AND VERIFICATION OF SERVICES

- **2,405,000** services were provided to 177,090 clients through program projects.

- **27.37%** of services were not verified



- **41.81%** of services were verified through phone calls

- **15.17%** of services were confirmed by documenters

- **15.65%** of services were verified through SMS

TRAINING AND SKILLS DEVELOPMENT

- 27 training sessions for 410 service providers on how to work with the upgraded mobile application.
- Separate training for documenters and project managers.

TECHNICAL IMPROVEMENTS OF THE PLATFORM

- The updated mobile application was launched on October 1, 2024 for all advisors:
- The Questionnaire service in the mobile application for service providers.
- The «Validation of Services Provided» service works for program curators and organizations.
- The Representative Verification functionality has added new ways to confirm services provided.
- The bookmark on the client's participation in the OST and related reporting is integrated into the client's file.
- Quarterly report indicators have been updated according to meet the new specifications.
- The report «Partners» is developed and added to the system.
- Verifier's information and phone number are now visible on the client's file.
- All reports are finalized, tested and implemented according to project requirements.
- Asynchronous reporting has been introduced to reduce the load on the web interface.
- Sorting of reports in the «My Reports» menu is configured by creation date so that the most recent requests are displayed first.
- The modality calculation for the ServicesExtended and IndexTesting streaming tables has been updated.
- The program infrastructure has been migrated to a new technology stack.

DATA AUDIT AND INFORMATION QUALITY

- **The audit of the program covered:**
  - Removal of inactive consultants.
  - Deletion of users without roles.
  - Editing the data of consultants with incorrect full names.
  - Merging duplicate consultants.
  - Deletion of erroneously created clients.
- Updating of data for organizations with the roles of «Medical System Institutions», «SCESU Institutions» and «SCESU Medical Institutions».
- The analysis of the «Agreements» subsystem made it possible to identify existing problems and formulate an approach to solving them.

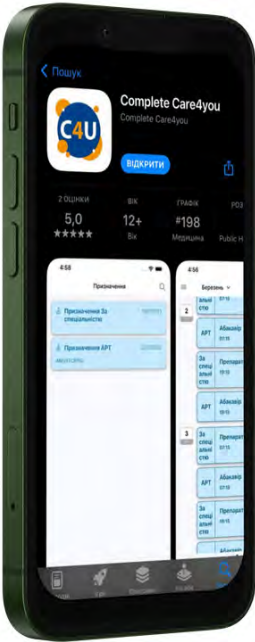
«ACCESS Pro: Access of communities to HIV care and treatment services through modern information systems and better communication with services»

2018-2024 | Supported by CDC

In 2024, a 6-year project aimed at improving the quality and sustainability of medical care for people living with HIV through modern information systems and effective communication with medical and social services in Ukraine was completed.

The project expanded and improved the information system for monitoring socially significant diseases and created a client application for health monitoring and communication with services.

As a result, healthcare providers and patients have convenient access to medical data and social services.



INFORMATION SYSTEM AND MOBILE APPLICATION

- SSDM IS Protocol (Socially Significant Disease Information System)
  - a system protocol for data collection, storage and processing has been developed and implemented.
  - 189,064 PLHIV registered in the system
  - 128,290 people living with HIV are on ART

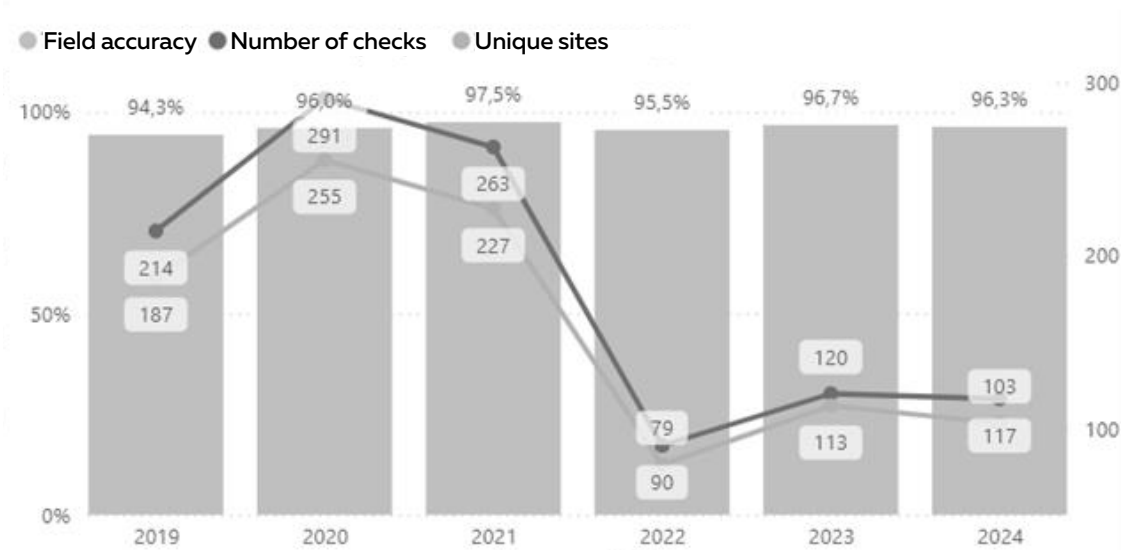

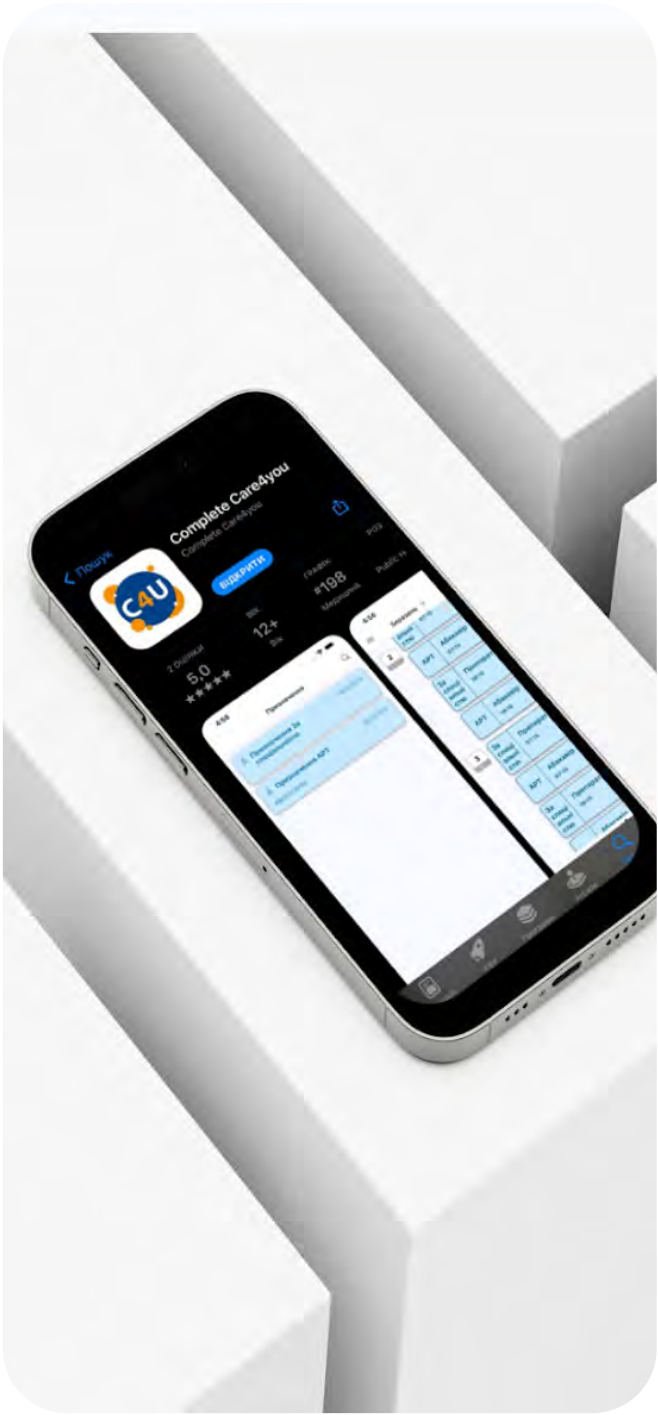

PATIENT SUPPORT

- Remote (online and telephone) counselling services for subscribers who call the HIV/AIDS Hotline
- more than 15,000 consultations on HIV, OST, PrEP, legal and psychosocial issues.
- Collaboration with government agencies
- Integration of SSDM IS with e-Health to control socially significant diseases.
- Implementation of the LOINC standard for medical laboratory tests.
- LOINC – names and codes of identifiers of logical observations.
- A study was conducted on the experience of implementing LOINC in different countries, by different laboratories.
- The concept of a national reference catalog with mapping to LOINC codes that correspond to the existing equipment (techniques) of the focus group of laboratories has been developed.
- A methodology for mapping new LOINC codes and recommendations for accompanying the national reference catalog of laboratory tests have been developed.
- LOINC translation into Ukrainian and published more than 3,000 codes on the <https://loinc.org/> website.
- The ACCESS Pro project has significantly improved access to treatment and the digitization of health services. The integration of information systems contributes to the sustainability of programs to combat HIV, TB, hepatitis, and other diseases.







KEY PROJECTS AND INITIATIVES

«Providing digital tools to address learning delays, socio-emotional development and mental health assessment for the most vulnerable 35,000 children in rural areas»

August 2023 — December 2024      With support from the Humanitarian Fund for Ukraine

This project has become a lifeline for the most vulnerable schoolchildren from rural communities of Kharkiv, Donetsk, Zaporizhzhia, Kherson, Mykolaiv and the southern part of Dnipropetrovsk regions, giving them an opportunity to catch up on their education and continue their studies even under the most difficult conditions.

The project also focuses on supporting children’s mental health, providing psychosocial support, and conducting early screening for students in grades 1-4, especially those living in areas of active hostilities or recently liberated territories.

RESULTS THAT INSPIRE

- 97 mobile classrooms: temporary educational centers, already operating in schools in all regions of project activity, have provided children with a safe space for learning and development.
- 35,000 students and 11,000 educators and psychologists were supported through this project, which included access to educational materials and digital tools on Ukrainian literacy and social-emotional learning (SEL).
- 5,000 of the most vulnerable primary school students received early mental health screening and psychosocial support (MHPSS) directly in their classrooms.

INNOVATIONS IN EDUCATION:

- Thanks to the introduction of digital technologies, the project allows not only the timely distribution of educational materials, but also their centralized coordination through regional administrations and local education departments.
- Th The SEL program, developed at the request of the Ministry of Education and Science of Ukraine, is integrated into the daily educational process to help children and teachers overcome the effects of the crisis and move forward.

RESEARCH AND PROFESSIONAL DEVELOPMENT:

- As part of the project, an in-depth study was conducted to analyze how different approaches to learning affect the recovery of educational losses and contribute to the emotional recovery of children.
- The results of the study became the basis for the development of a methodology based on digital tools that allows teachers to improve their professional skills.

# «Food for Life 2024»

2022-2024 | together with the World Food Program (WFP)

The national project, implemented since 2022, provides food to people in regions with difficult access to food, as well as to people from vulnerable categories of the population, in order to prevent or overcome a humanitarian crisis.

Since 2024, the Institutional Nutrition Program has provided monthly food packages to food units of institutions that provide various types of medical, social and psychological support to patients, visitors or guests.

## PROVISION OF FOOD IN THREE AREAS:

- Food kits;
- Institutional nutrition;
- Bread.

## DURING 2024

- 1,024,581** food parcels:

**900+** institutions that include in their activities the provision of food to beneficiaries;

**364** deliveries to specialized institutions: boarding schools, social service centers, hospices, shelters for victims of gender-based violence, etc.;

➤ **Among them:**

  - 363,190 individual beneficiaries received aid;
  - 105,696 people living with HIV, TB and their families.
- 1,519,855** beneficiaries received food in the institutions that received the aid;

**2,093,022** loaves of bread were distributed in 9 communities in different regions;

**523,072** beneficiaries received bread.

# «Mobile Sexual/Reproductive Health Brigades»

from 2023 with the financial support from the United Nations Population Fund in Ukraine (UNFPA)

The goal is to improve access to obstetric, gynecological and therapeutic care for the rural population and communities where access to health services is difficult. The target population includes IDPs, persons with disabilities and other vulnerable groups. The project also aims to identify survivors of gender-based and sexual violence, provide medical care and refer them to other services. It will also provide counseling on family planning, contraception and women’s health.

IN 2024:

- It was implemented in 12 regions of Ukraine: Dnipropetrovsk, Donetsk, Zaporizhzhia, Kyiv, Kirovohrad, Mykolaiv, Odesa, Poltava, Sumy, Kharkiv, Cherkasy, Chernihiv.
- 14 mobile teams (13 gynecological and 1 pediatric) and 1 mobile maternity hospital, which involving 187 medical specialists from regional health care institutions.

ACHIEVEMENTS:

- 3,214 visits of mobile teams and maternity hospitals in 54 out of 68 districts (79% of the territory is covered by services) in 12 regions of Ukraine. Some areas were not covered due to the occupation.
- 51,682 people, including 2,737 children under the age of 18, received the services from mobile brigades.
- 178,363 consultations with medical specialists.
- 44,500 hygiene kits for three age groups were distributed to project clients who sought medical advice.

CARE AND SUPPORT FOR HIV-POSITIVE PEOPLE

PREVENTION OF VERTICAL TRANSMISSION

- 837 HIV-positive pregnant women and women in labor received social support.
- 626 children were born to HIV-positive mothers, 100% are bottle fed.

MEDICAL AND SOCIAL SUPPORT FOR CHILDREN

- 1,518 HIV-positive children and children affected by the HIV/AIDS epidemic received support services.
- 660 HIV-positive children receive art (100% coverage among those involved in the project).
- 517 children are involved in the status disclosure process.
- 391 children have their parents' status disclosed.

EDUCATIONAL PROGRAMS FOR GIRLS

- 313 girls from families affected by HIV/AIDS (ages 10-18) participated in the «School for Girls» groups.

DELIVERY OF ARV THERAPY

- 19,208 clients with restrictions on visiting medical facilities received a drug delivery service.
- 29,828 ART deliveries were made.

RETURN OF PATIENTS UNDER MEDICAL SUPERVISION

- 8,710 HIV-positive people who had fallen out of medical supervision are covered by social services.
- 8,630 clients returned to medical supervision.
- An in-depth retention proces has been introduced to help ensure stable adherence to ART.

CARE AND SUPPORT IN THE PENITENTIARY SYSTEM

OVERALL RESULT

Access to medical, social and preventive services for prisoners and convicts has been expanded. The initiatives implemented contribute to improving HIV/TB control, reducing the spread of infectious diseases and improving the quality of medical care in the penitentiary system.

SOCIAL SUPPORT OF TUBERCULOSIS (TB) TREATMENT

- Medical care based on 4 specialized tuberculosis clinics was provided to:
  - 377 prisoners with drug-resistant TB.
  - 283 prisoners with susceptible TB.
- Informational materials:
  - 2 types of materials on TB detection, treatment and prevention were developed for prisoners, medical staff and penitentiary system staff.
  - 10,000 copies were printed and handed over to the regional branches of the SE «CHC SCESU».

PRE-EXPOSURE PROPHYLAXIS (PREP)

- There were 528 prisoners and inmates in the PrEP program.
- 316 new participants joined the program in 2024.

SUPPORT FOR HIV-POSITIVE INDIVIDUALS

- Psycho-social support
  - 1,928 HIV-positive prisoners and convicts received ART adherence services.
- Paid tests for HIV-positive prisoners:
  - Immunological (CD4) – 3,992 people.
  - Tests for markers of opportunistic infections – 304 people.
  - CT/MRI – 66 people.
  - Cytology – 72 people.
- HIV testing:
  - 29,382 inmates were tested for HIV.
  - 283 new cases of HIV infection were detected.

OPIOID SUBSTITUTION THERAPY (OST)

- Social support for OST patients:
  - Activities were conducted in 16 penitentiary institutions.
  - 508 clients of the OST program were covered.

SYRINGE EXCHANGE PROGRAM

- The program was implemented in 2 penitentiary institutions.
- 996 inmates were served.
- 53,300 syringes were distributed.
- Preparations were made to open 2 more syringe exchange sites.

EDUCATIONAL AND PREVENTIVE MEASURES

- Social worker training:
  - 537 inmates from 55 institutions received peer-to-peer training to provide prevention services.
- Life skills training:
  - 1,183 people preparing for release participated in training programs.
- Webinars on the prevention of socially dangerous diseases:
  - 1,030 prisoners from 55 institutions and 195 professionals from 49 penitentiary institutions were trained.

ACCOMPANYING PRISONERS BEFORE AND AFTER RELEASE

- The list of categories of prisoners receiving pre-release and post-release support services was expanded. In addition to HIV-positive prisoners, prisoners with TB and prisoners with PWID, support was also provided to those in the PrEP and OST programs.
- Coverage through the Pre-Release Support program:
  - 2,721 prisoners were prepared for release.
- Post-release support (registration, continuation of treatment, referral to prevention programs):
  - 2,319 released persons received support services, including:
    - 318 people living with HIV.
    - 55 people with TB.
    - 31 patients from the OST program.
    - 1,953 persons from among people who use drugs.

SERVICES FOR TESTING, DIAGNOSIS AND TREATMENT OF HIV, TUBERCULOSIS, HEPATITIS C BASED ON MOBILE FORMAT

GEOGRAPHY & COVERAGE

- 9 regions of Ukraine are introducing a mobile format for the provision of medical services.
- 1,063 mobile team outreaches in 2024.
- 10,682 clients received testing, diagnosis and treatment services.

ENSURING ACCESS TO TREATMENT

- 2,132 patients with previously established HIV status received continued access to treatment.
- 570 patients with a confirmed diagnosis of tuberculosis remained on treatment.

HIV TESTING

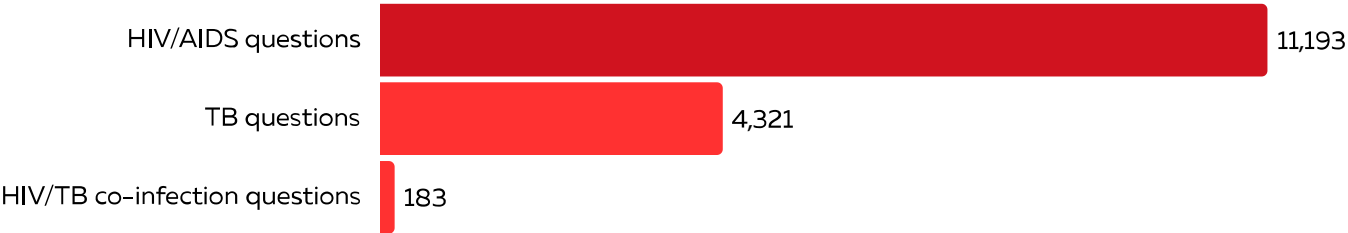
- 7,232 clients were tested with rapid tests.
- 140 clients (1.9%) tested positive for HIV.
- 84% of those identified have already been formally diagnosed, registered at the clinic and started the ART.

REFERRALS TO HEALTHCARE FACILITIES

- 100% of clients testing positive for hepatitis B and C and syphilis are referred to healthcare facilities for treatment.
- 32 clients found to have tuberculosis were referred to health care facilities for further treatment.

NATIONAL TUBERCULOSIS AND HIV/AIDS HOTLINE

15,697 calls were received during the year, including:



24,246 consultations were provided based on the results of the calls..

TUBERCULOSIS/HIV PREVENTION, CARE AND TREATMENT

RESULTS 2024

3,918 clients with drug-resistant tuberculosis received social support (including 168 people under the age of 18).

5,605 clients with susceptible TB are involved in the program (including 252 children).

1,570 index partners (community or professional) with suspected TB have undergone additional screening.

28 TB cases confirmed after screening.

PROGRAM SCOPE

- 16 regions of Ukraine are implementing social support programs for patients with drug-resistant and drug-susceptible tuberculosis.
- 17 non-governmental organizations (NGOs) are implementing patient support activities.

COMPREHENSIVE PATIENT CARE

The program has two main components:

- Medical and social support
  - Daily supply and monitoring of TB drugs.
- Psychosocial support
  - Individualized support model defined by multidisciplinary teams.
  - Motivational support: food kits or supermarket vouchers for continued treatment.
  - Consultations with a lawyer and a psychologist.
- Reimbursement of travel expenses or provision of transportation to medical facilities.
- Additional services for children (educational and entertainment activities, motivational family support, consultations with a social worker-teacher).
- Work with contacts (community or professional contacts) belonging to groups at increased risk of tuberculosis.

ENSURING THE OPERATION OF SHELTERS

FUNCTIONING OF SHELTERS

The activities of 3 shelters providing shelter to victims of domestic and gender-based violence, representatives of vulnerable groups (VG) and IDPs were ensured.

- Locations
  - Rivne region ( Varkovichi)
  - Ivano-Frankivsk region (Lysets)
  - Lviv
- 71 beds is the total capacity of the shelters.
- 848 clients received services during the reporting period.
- Up to 2 months is the average length of stay at the shelter.

EXPANDING ACCESS TO SERVICES

- A single database of shelters in Ukraine has been created in the form of an online map: [map.eleos.com.ua/](http://map.eleos.com.ua/)
- The map is updated regularly and is available to potential clients.

COMPREHENSIVE CLIENT SUPPORT

- Temporary safe stay
- Provision of basic needs: food, hygiene products
- Socio-psychological support
- Legal assistance:
- Humanitarian aid

FINANCIAL SUSTAINABILITY

- Advocacy for the allocation of funds from local budgets to support shelters is underway.
- Shelters near the villages of Varkovychi and Lysets have been transitioning to alternative funding since July 2024.
- Subgrantees are working with local authorities and donors to ensure the sustainability of the shelters in the future.

MOBILE SUPPORT PILOT PROJECT

In June 2024, a pilot project was launched in the Dnipropetrovsk and Ivano-Frankivsk regions. 74 clients received smartphones for the treatment period with cellular coverage for the duration of the treatment.

PROJECT GOALS:

- Providing continuous treatment through video DOT support.
- Improving access to health services.
- Social integration and support for patients during the treatment period.

NATIONAL PROJECTS

IMPROVING THE PROCESS FOR HELPING HIV-POSITIVE CHILDREN

- 282 children received treatment, care and support services.
- Training of Healthcare Professionals
  - 7 face-to-face trainings were conducted for doctors of the National Clinical Hospital «OKHMATDYT» and primary care of regional healthcare facilities.
  - Participants received 15 points and certificates in the BPD system.
- Mobile assistance
  - 7 mobile team visits (healthcare worker + social worker) to regional HCFs for effective management of complex cases.
- Training of children’s services employees
  - 6 trainings for 145 employees (district state administrations, village, settlement, city councils of Kyiv region).
- Social adjustment of children
  - 56 HIV-positive students from the Children’s Home at the Holy Ascension Monastery received support in adapting and overcoming problems of deprivation.

- Research
  - Study «Characteristics of the course of puberty in HIV-positive girls».
  - 100 girls were examined in 2024 (another 100 are planned in 2025).
  - Control group: 30 girls without HIV (15 in 2024, 15 in 2025).

SUPPORT OF ADULT PATIENTS WITH SEVERE HIV

- 1,041 clients received comprehensive medical services in the clinic of the Hromashevsky Institute of Epidemiology and Infectious Diseases.
- 181 patients underwent additional laboratory and instrumental diagnostics of bone tissue (densitometry).

«HealthLink: Accelerating Ukraine’s Efforts to End HIV»

In 2024, one of the largest and most effective public health projects in Ukraine – the 7-year HealthLink project «Accelerating efforts to combat HIV/AIDS in Ukraine» - completed its activities.

1,038,631 people in Ukraine were tested for HIV and now know their HIV status thanks to the HealthLink project;

- An unprecedented impact on the achievement of national HIV targets (i.e. the first «90») has been achieved: **one in three new HIV infections** in Ukraine has been tested through the HealthLink project.
- **For the first time**, the following number of health care facilities and non-governmental organizations (NGOs) was covered: more than 600 healthcare facilities, 29 NGOs, more than 10,000 medical professionals (10,222), 639 testing sites outside healthcare facilities.

- The U.S. Government’s investment in the project exceeded **USD 37 million**.

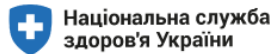
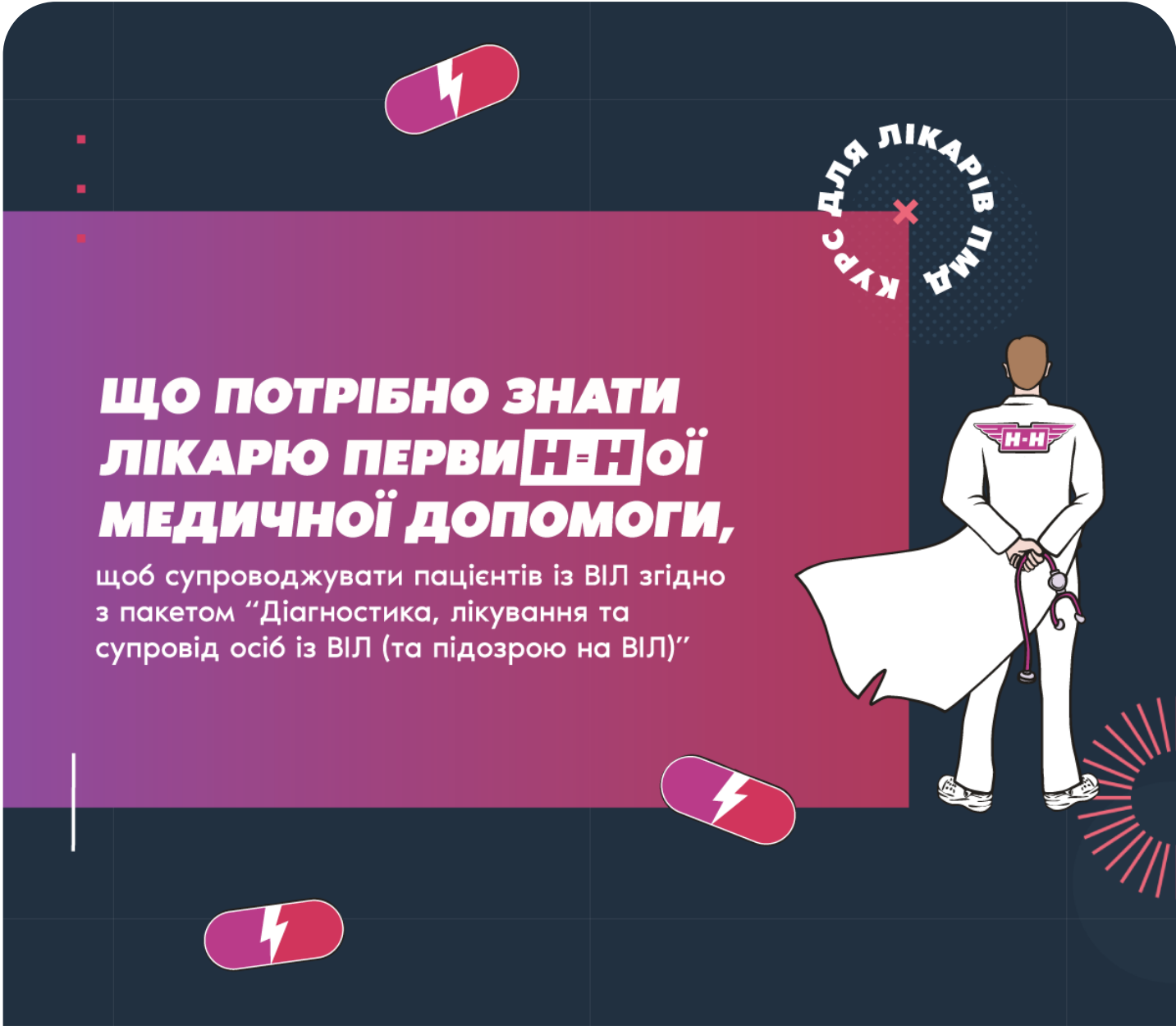

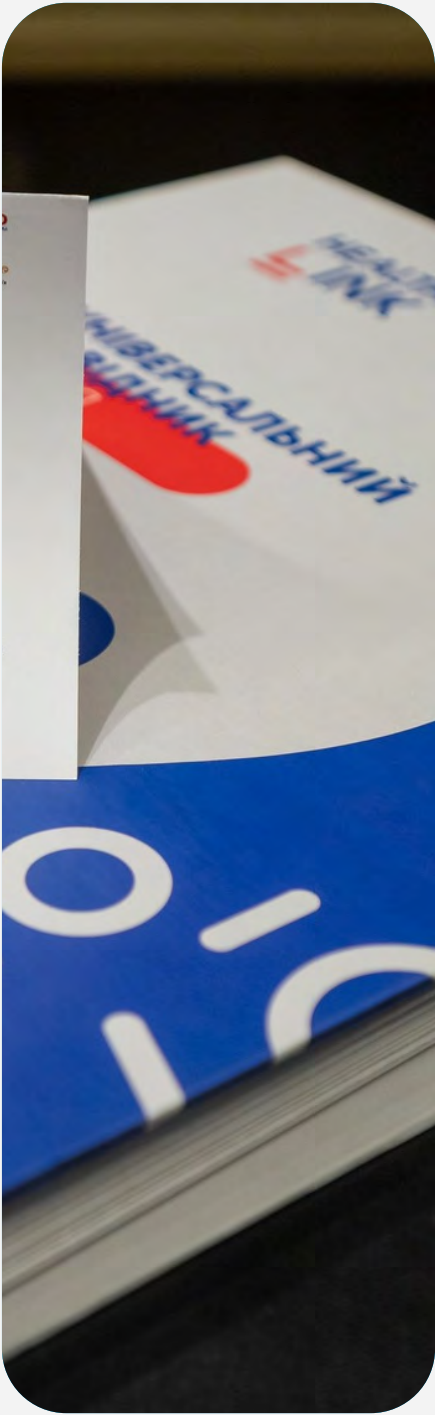

- a course for healthcare teams «Communication with people who suffered trauma as a result of the war», which will soon be available on the platform of the NHSU Academy;
- 2 information campaigns – on the prevention of cardiovascular diseases and on the re-completion of declarations in the current place of residence;

# Grant program «Restoring public access to medical care» in the Dnipropetrovsk region

2024 | Is part of the large-scale USAID project «Support to Healthcare Reform».

To support and ensure the sustainable development of the medical system in the Dnipropetrovsk region, the Grant Program «Restoring Public Access to Health Care» has been implemented since the beginning of 2024 , which is part of the large-scale USAID project «Support to Healthcare Reform». CO «100% Life» is a partner of the project and provides cooperation between medical institutions, communities on the population of Dnipropetrovsk region.

Healthcare professionals, social workers, psychologists and others have replenished their professional baggage with the latest international approaches to service delivery.

## KEY PROJECT RESULTS

- 458** pieces of equipment.
- 2** digital communication campaigns on how and why to find a family doctor near a new place of residence, and the importance of timely cardiovascular screening.
- > 3,200,000** people is the number the campaign reached.

- 39** healthcare institutions were provided with 1,330 communication campaign posters.

### ➤ **Expanding diagnostic capabilities:**

providing advanced medical equipment that will significantly expand the ability of health care facilities to provide services.

### ➤ **Comprehensive patient care:**

Multidisciplinary teams have begun to work, combining the efforts of doctors, psychologists and social workers to ensure the best outcome for patients. The peer group format for sharing experience has been introduced.

### ➤ **Healthcare worker professional development:**

- PHC workers received a series of trainings and webinars that will give their communities access to expanded diagnostic capabilities, better palliative care, skilled management of HIV, tuberculosis and cancer prevention.
- > 1,000 people participated in offline and online training sessions, and webinar recordings were viewed nearly 4,000 times.

### ➤ **Nursing empowerment:**

Healthcare institutions have participated in the development of autonomous nursing, which includes counseling and management of patients with non-communicable diseases (hypertension, diabetes, heart failure, bronchial asthma), support for critically ill patients at home, etc.

### ➤ **Caring for the health of the community's residents:**

- two digital communication campaigns that together reached more than 3,200,000 people.

- As part of the campaigns, a website <https://declaration-vpo.simeynilylikar.com.ua/> was created, which explains how and why to find a family doctor near the new place of residence and provides a list of the nearest outpatient clinics in the communities of the Dnipropetrovsk region, and the website <https://zdorove-sertse-sudyny.simeynilylikar.com.ua/>, which emphasizes the importance of timely examination of the cardiovascular system.
- **Supporting communication between health workers and community residents:**
  - Outdoor advertising is presented in three communities of the Dnipropetrovsk region.
  - Printed posters were provided for 39 health care facilities of these communities.
  - 5,350 educational materials for communities using a multidisciplinary approach.
  - 16 informational materials were developed for healthcare professionals (on the diagnosis of various diseases and conditions, the importance of detecting and preventing cardiovascular disease, and many others), which will be presented in a universal directory for doctors. KEY PROJECT RESULTS

More than **300,000** Ukrainians gained better access to health services.

Residents of **eight territorial communities** received an effective and convenient method for the communication with their medical institutions, which simplified access to healthcare services and improved the organizational capacity of the institutions.

**8 call centers** were opened for residents of Bashtanska, Domanivska, Rozdilnyanska, Nizhynska, Bakhmatska, Solonyanska, Petrykivska and Shostka communities in five regions of Ukraine.

This is a comprehensive and fundamentally new level of patient care where the patients will use convenient communication channels, as a result of systemic changes implemented as part of the medical reform.

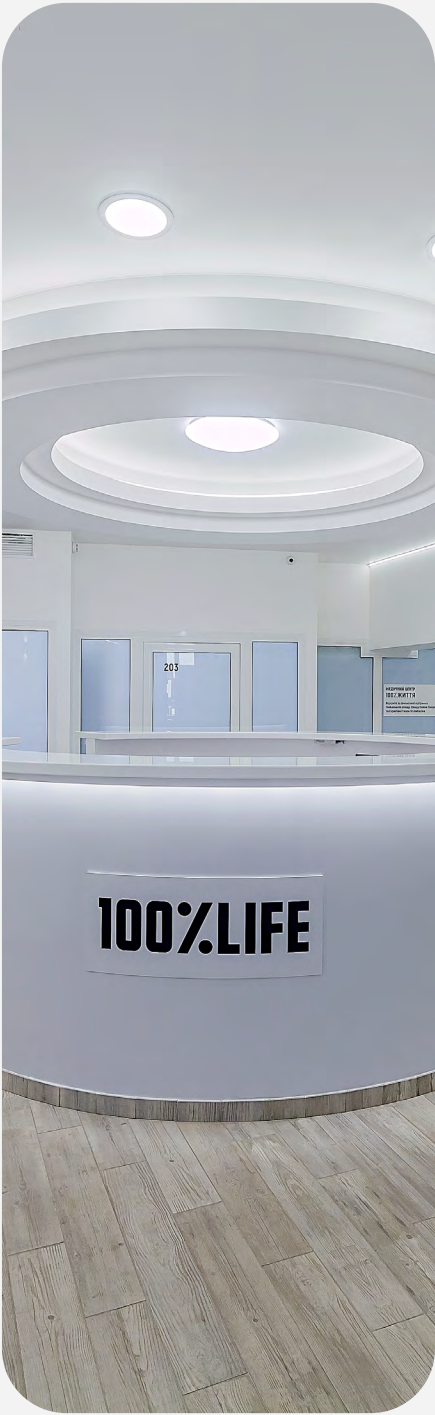

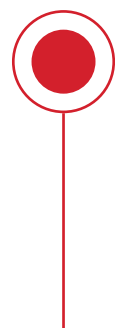

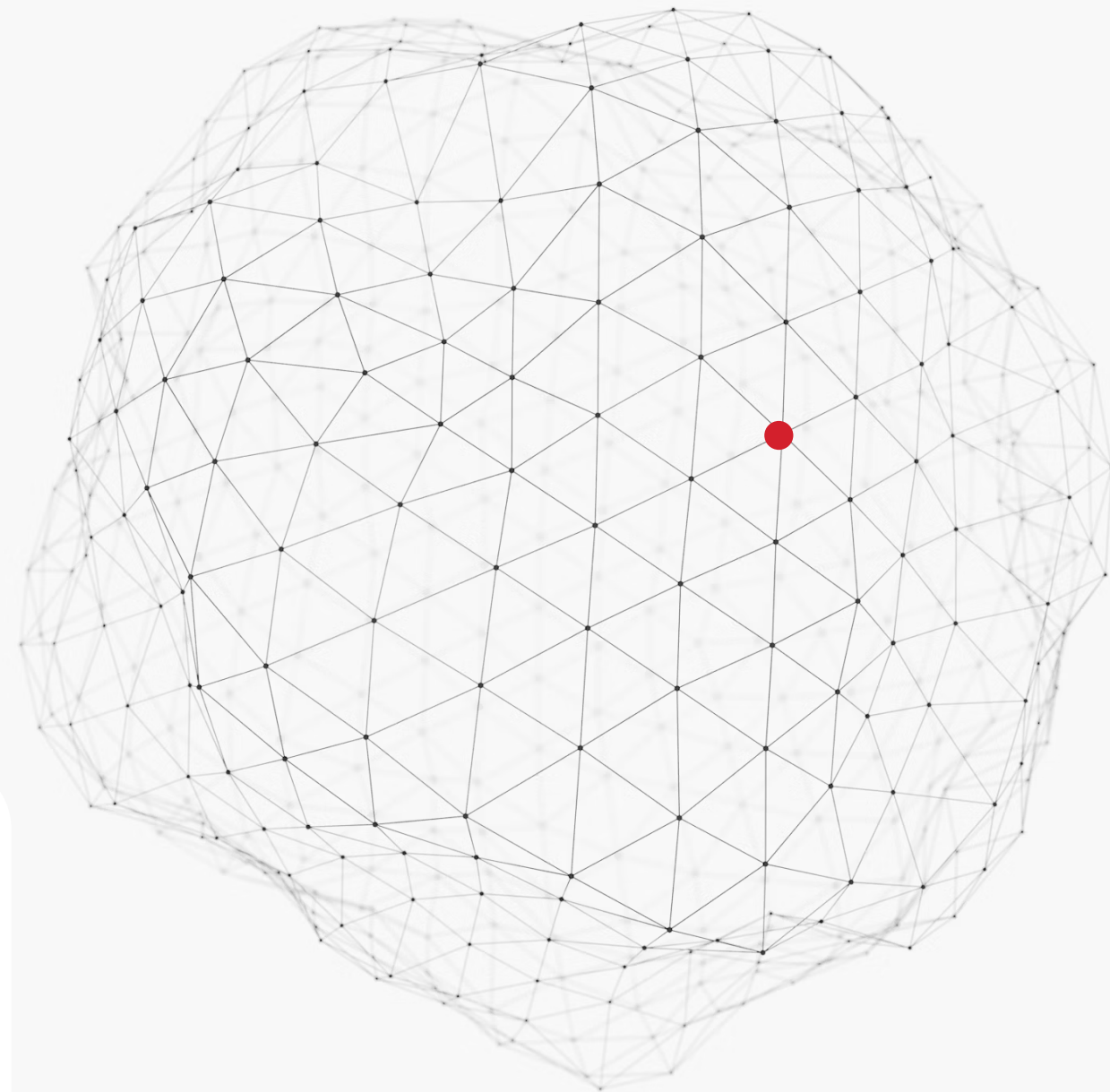

  - Partner organizations were invited;
  - An active discussion was organized.
- 662 people were tested by family doctors during the International HIV and Hepatitis Testing Week 2024:
  - 0 HIV positive, 3 hepatitis C positive;
- 20 photo shoots were conducted, including in the most remote villages of Ukraine;
- 10,612 doctors received an email newsletter about ITW 2024;
- Merchandise and information materials were sent;
- Recommendations were developed for doctors to cover the Testing Week on social media: participating doctors became active bloggers, posting quality photos and texts;
- More than 50 media partners spread the word about Test Week across the country.

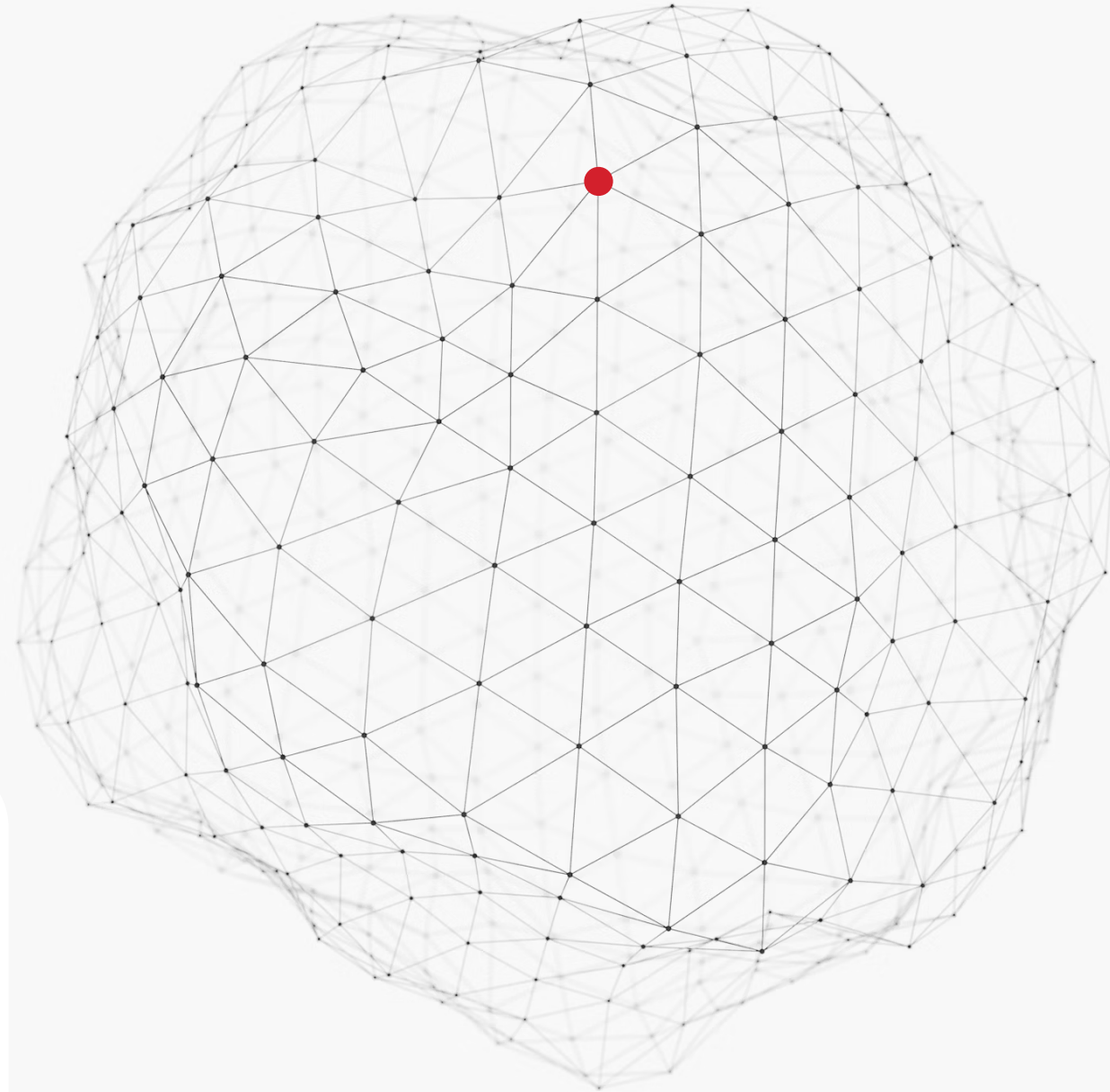

# Institutional development of the organization in 2024

## MANAGEMENT AND STRATEGIC DEVELOPMENT

- The General Assembly was held – annual report of the governing bodies to the participants.

- Updating of the Service Manual (17 Dec 2024) – contains instructions, rules and procedures for employees.

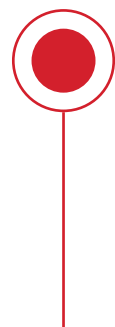
## TRANSITION TO A NEW ELECTRONIC DOCUMENT MANAGEMENT SYSTEM

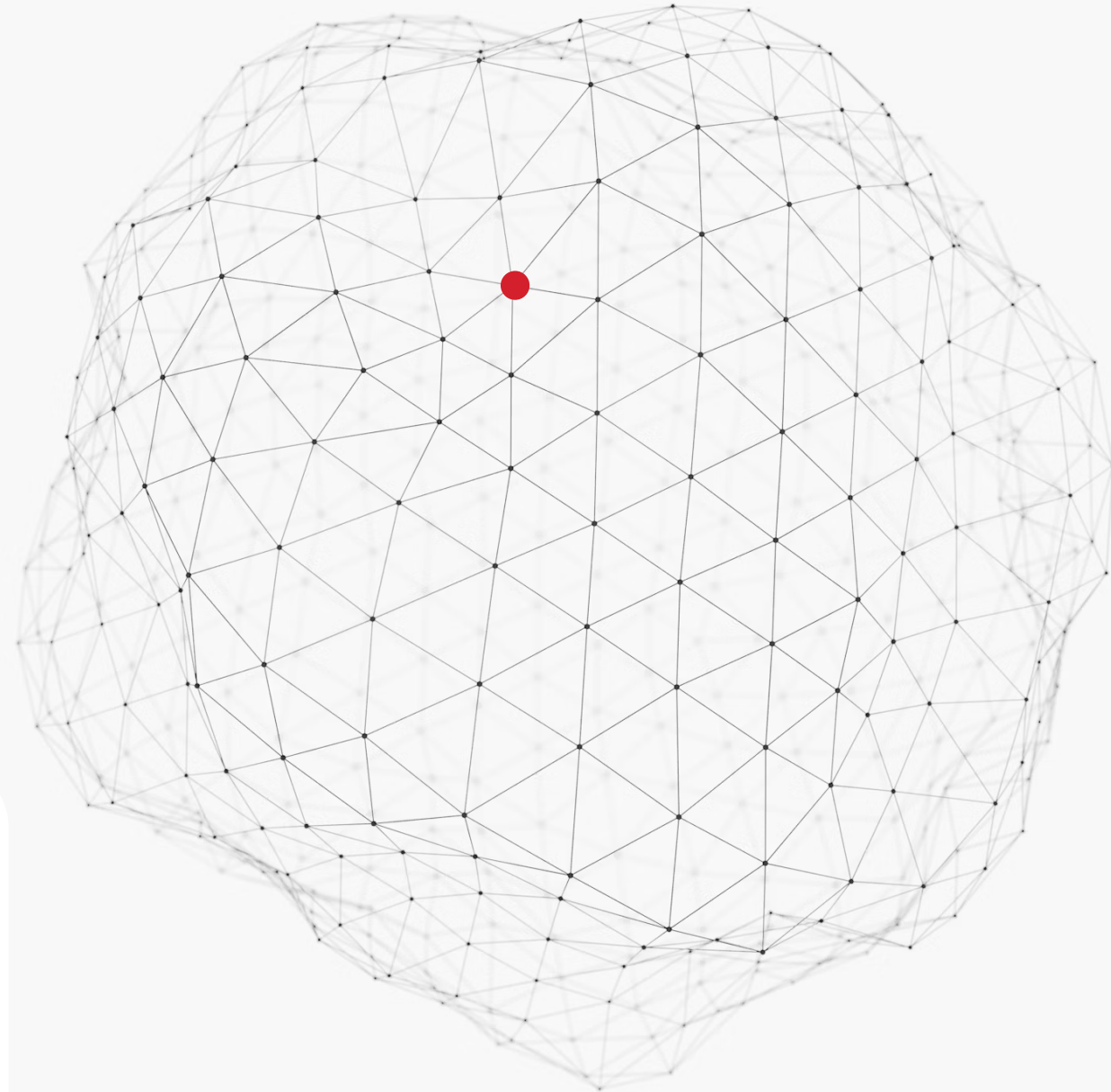

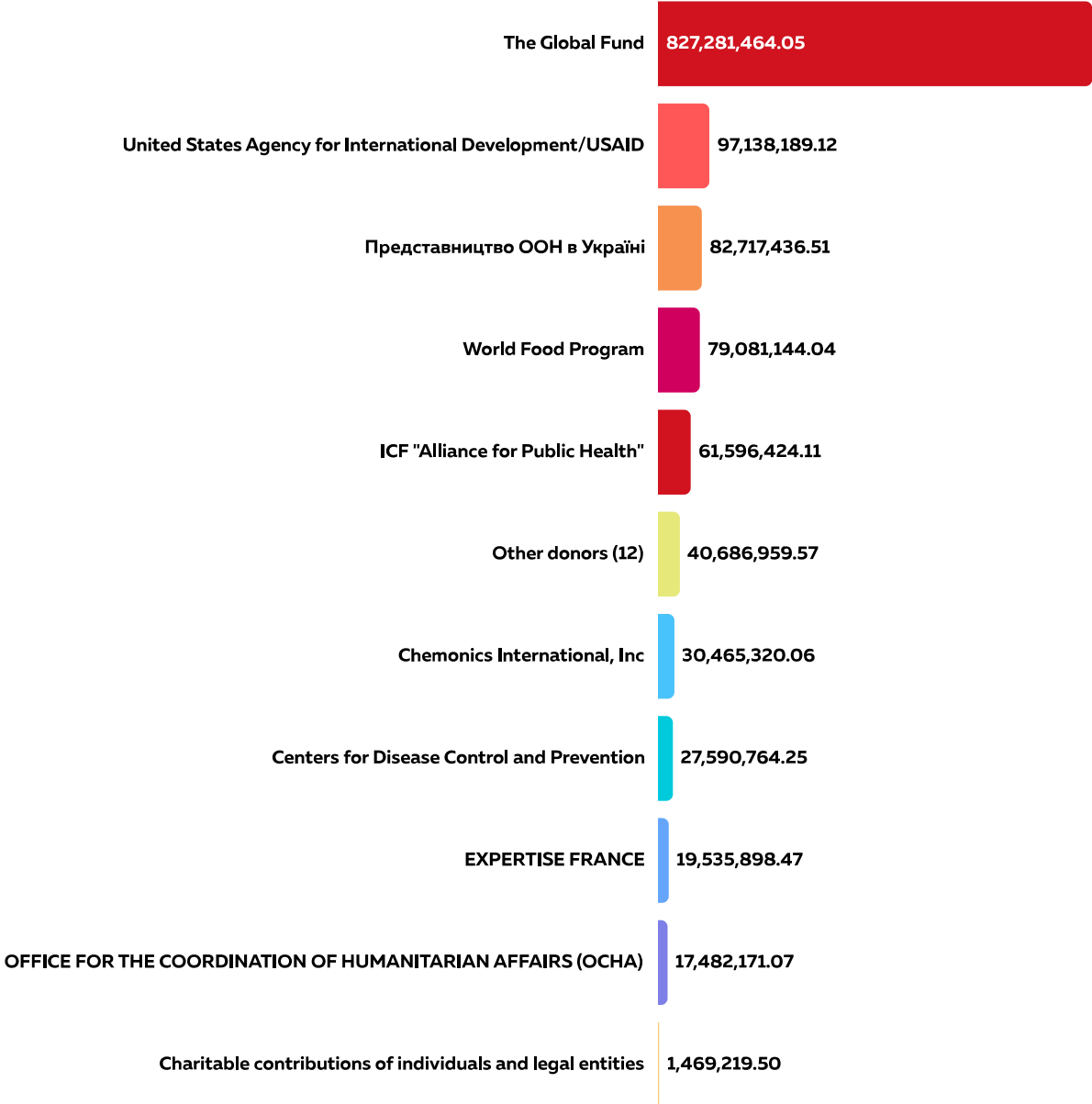

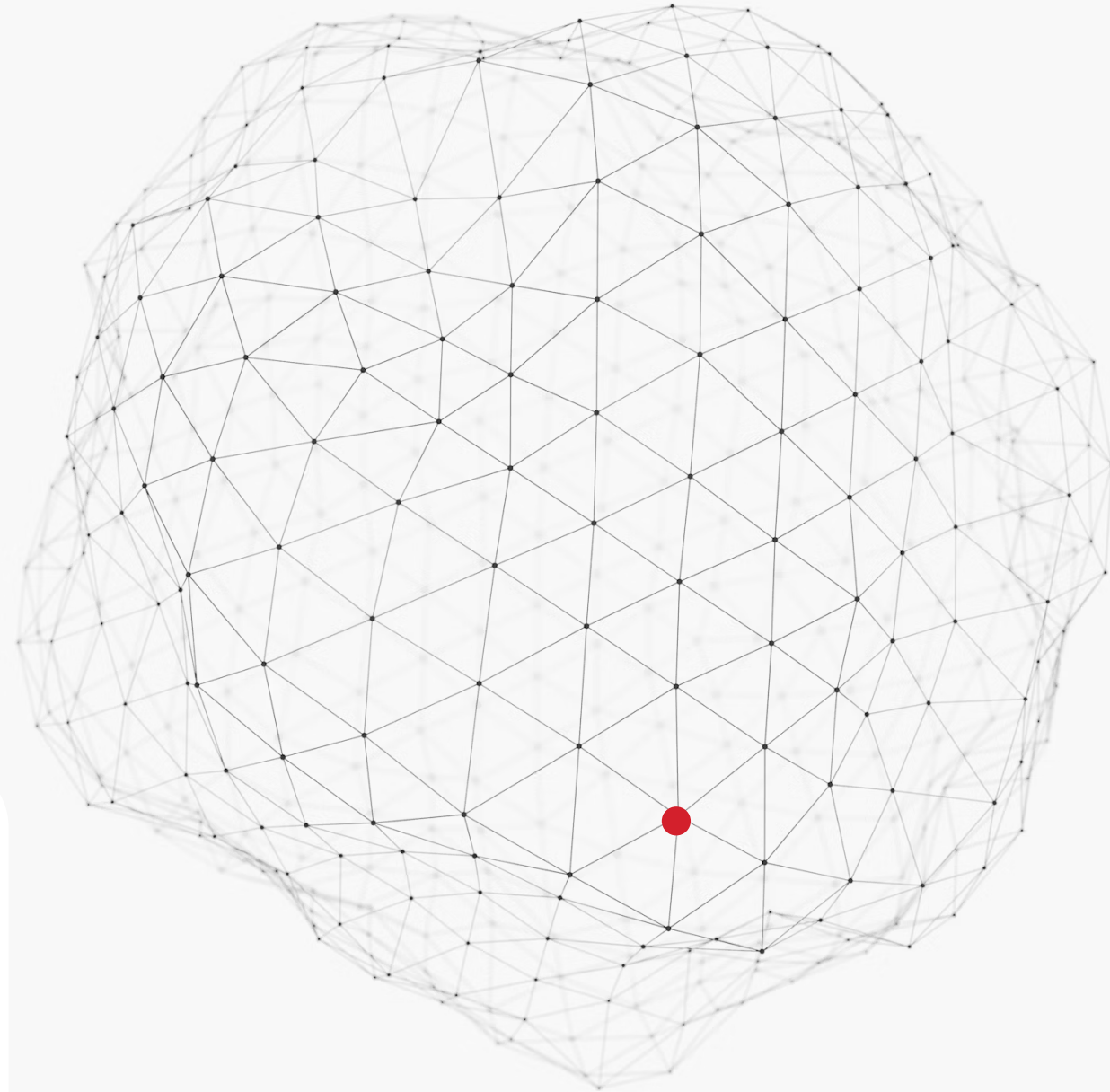

2023 – The European representative office of CO «100% Life» was established in Germany.  
CHARITY ORGANIZATION 100 PERCENT LIFE gGmbH is an officially registered organization in Germany.

### ACTIVITY FOCUS:

- Advocacy and communication of Ukraine’s needs in the field of HIV services, health care, social and humanitarian spheres.
- Building partnerships to incorporate new solutions in the processes of recovery and reconstruction of Ukraine.
- Expanding opportunities to help Ukrainian patients abroad.
- Strengthening of European integration processes through bilateral exchange of experience and expertise.
- The activity is carried out from its base in Berlin with the further involvement of partners in Europe.

  - Participation in the Regional Expert Group on Migrant Health (EECA).

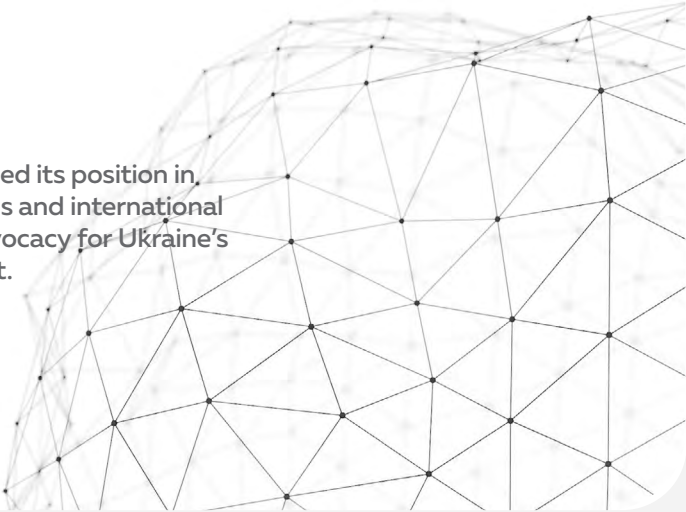

4-6 December 2024, Tbilisi

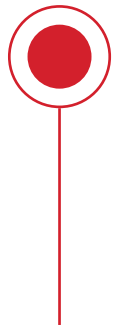
CO 100% Life experts Veronika Kochubey, Daryna Bondarenko presented key legislative changes affecting access to treatment and diagnostics.

The meeting was attended by more than 20 activists from EECA countries.

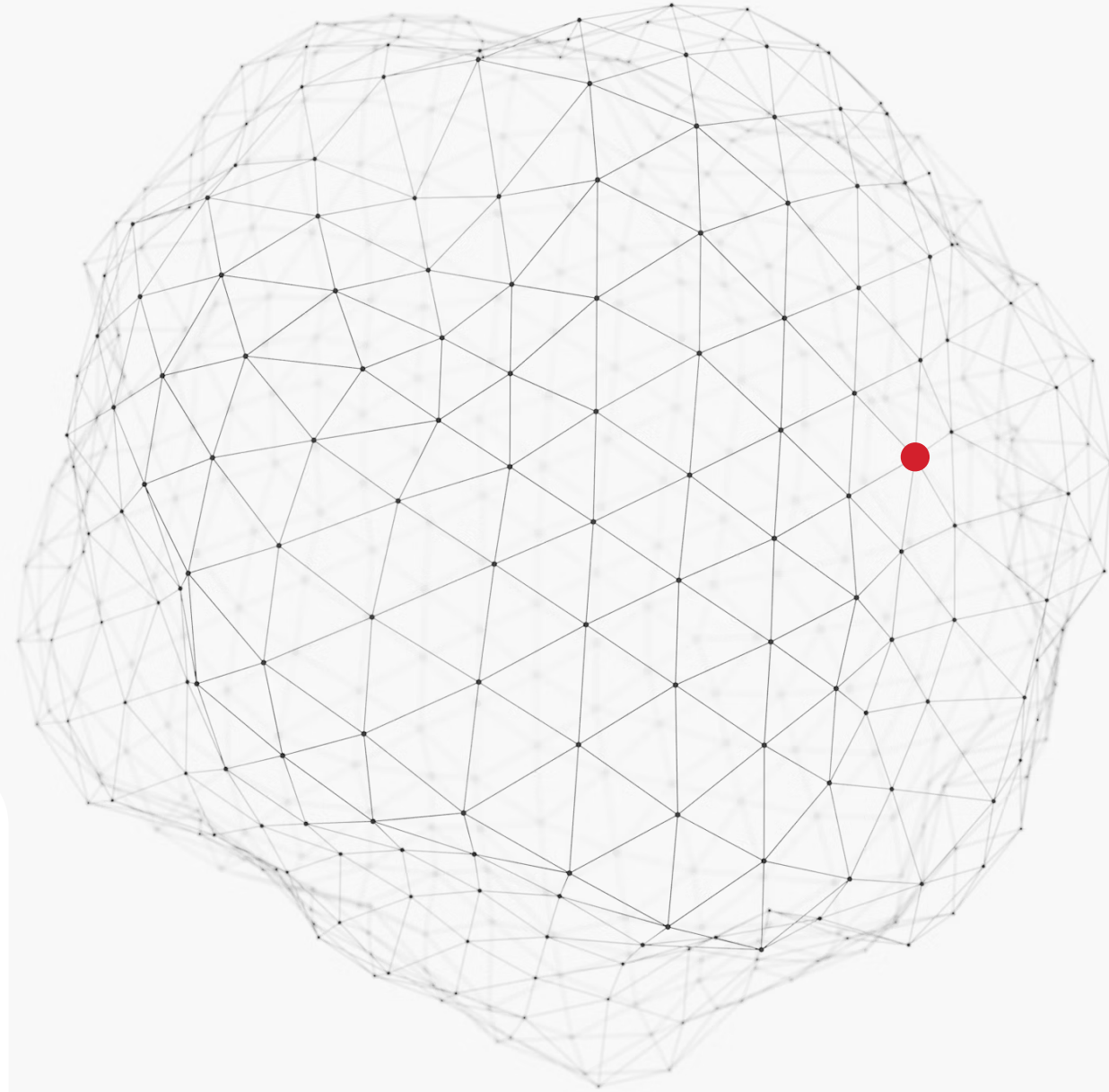


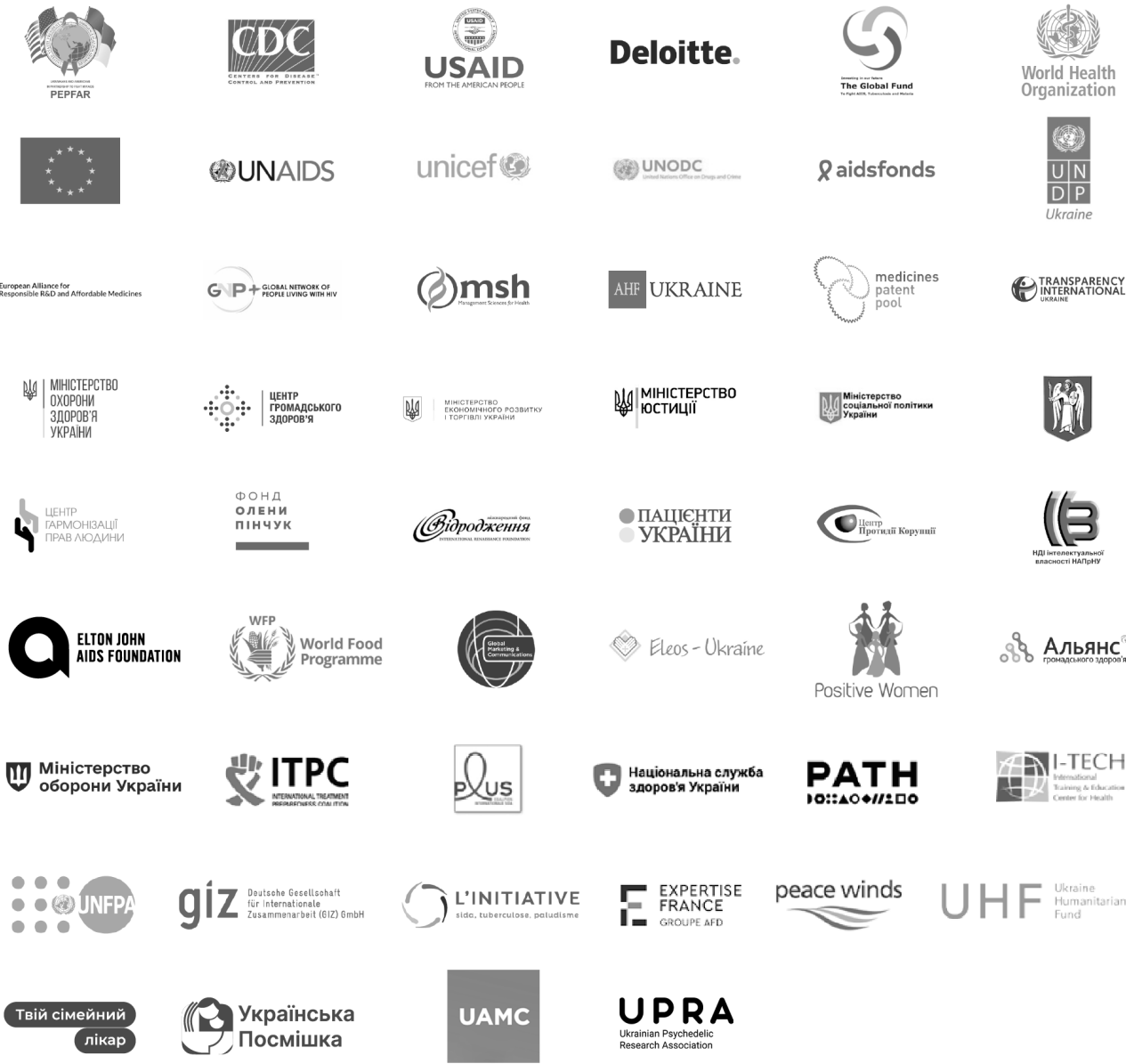
